## POCKET PARK The Grove by Gabi Torres

Back in September of 2021, I approached Josh Eggers, the Director of Parks & Recreation for the City of Clinton, with an idea. I wanted to create an "art forest" in Pocket Park, located at 125 Fourth Avenue South in between the Ameriprise Financial and Midwest Pets for Life buildings. The idea would be to create an immersive public art display where visitors would be able to walk through a forest of art. The display would be up for the months of June and July, be easily accessible, and free to the public.

Fast forward to April 2022, and I am happy to announce that we are in full-planning and creating mode for The Grove! The art forest display, officially named The Grove, consists of 12 free-standing, beautifully crafted wood frames created by Tim and Charlie from Retired with Wood that will hold 12 colorful, abstract pieces. The frames will be placed throughout Pocket Park to encourage visitors to

## A MESSAGE FROM THE MAYOR AND CITY ADMINISTRATOR

**A**s summer approaches and the weather begins to warm, the grass turns green and the farm fields are planted. It is a perfect time to review the goals and objectives for the City. Using the wonderful online sites, pick a blog.hubspot.com to look at the concept of goals and objectives. It states that a goal is an achievable outcome that is typically broad and long-term. A City or Business might use goals to inform yearly strategies that each department will execute. An objective, on the other hand, defines the specific, measurable actions each team employee must take to achieve the overall goal. To sum it up, the main difference between a goal and an objective is that goals provide direction whereas objectives measure how you should follow that direction.

The Department Directors and Council Members this summer will be focused on updating the City's goals and objectives for the next two years. The City is leveraging a third party to provide surveys, working groups and assist on focused goals and objectives that fit into the Strategic Plan. So, if any citizens have projects or items that need to be addressed, please contact your Ward Council Member or any of the At-Large Council Members so they can carry that in-

formation to the sessions. This will assist in maintaining the great momentum on critical projects and items that need to be completed. In addition, the City is set to partner with the University of Iowa and their Iowa Initiative of Sustainable Communities (IISC). This will align specific projects (examples: workforce attraction, Brownfields, wayfinding, housing needs assessment, plan for attracting young families, sports complex, dog parks, Liberty Square, trails, historical items, highlighting six living Clintonians on how they are making Clinton better, murals, tree inventory, riverfront, festivals, community identity, air quality, and many others).

Key part of the 2032 Strategy that the Council Members continue to focus on come from the Engineering Director and his team. Jason Craft and the Engineering Department continues to operate at a high level with numerous projects, to include, work on many asphalt streets that have not been rehabbed over the last 20 years, along with collector street resurfacing, and concrete patching on the very worst of the concrete streets in town. The City invested \$3.3 million for street projects last year and will invest \$3.6 million this coming year. Streets that are in the worst condition and needing replacement are prioritized.

Projects that were completed in the last 12 months include: Riverview Stadium and Swimming Pool parking lots with permeable pavers, North 3rd Street Three Lane Conversion, South 7th Street Sewer Separation, ADA Curb Ramps, North 18th Street Asphalt Overlay, Bluff Boulevard Asphalt Patching, South 2nd Street Viaduct Repairs, Fiber & Conduits on the Levee, 911 Memorial Park-ing Area, 16th Street Bridge Replacement, Harts Mill Road Reconstruction, Erickson Community Center Main Parking Lot Resurfacing, and Salt Storage Building.

Our upcoming projects in the next 12 months, with the goal to make what we have better and the objective of constant attention on our roads and what we already have, include: soon to be completed, Emma Young Pond - completely dug out and increasing the water depth to 10 feet, silt collect area added, a brand-new fishing pier and Eagle Scout project canoe and kayak launching area. Improvements to S. 2nd Street viaduct, S. 10th Street Sewer Project and S. 8th Street and South Clinton Sewer Separation, West View Heights resurfacing project is just about 50% completed with

work on the other 1/2 of the subdivision ongoing. Once this work is done, they will resurface 13th Avenue North from Mill Creek Parkway to the east (where the new concrete ended last year). More projects include Harts Mill Road, between 16th Avenue South & Cameron Drive, then Beaver Channel Parkway, South 32nd Street (2nd Ave S to Harts Mill Road), Harts Mill Road (S 32nd St to Valley Oaks Drive), 33rd & 34th Avenue North (Roling Meadows Area), 28th Avenue North (Pershing to 2nd St), South 12th Street (15th Ave S to 11th Ave S), and the long-awaited Riverview Drive (6th Avenue South to 9th Avenue North). The Riverview Drive and South 32nd Street will be full depth reclamation and cold in place recycling projects, which will control the reflective cracking from immediately occurring again after completion. In addition, numerous concrete Road rehab projects to include 14th Avenue North Reconstruction from North 2nd Street to North 4th Street, 15th Avenue South Concrete Patching between South 10th Street and South 14th Street, South 3rd Street and South 4th Street Reconstruction Project, LaMetta Wynn Drive, and Eagle Heights Driveway Reconstruction, then asphalt resurfacing of Pershing Boulevard from 18th Avenue North to Main Avenue, and 22nd Avenue North from North 3rd Street to North 8th Street.

It is wonderful to see all these projects (or objectives towards the goal of having a top pavement condition index), but that is just the tip of the spear. Another critical objective is to create the education and

training opportunities to prepare Clinton's residents for the workforce. Both Clinton High School and the Clinton Community College are doing just that. Clinton High School is undergoing a complete renovation with construction currently on the east side of the high school with the new academic wing. Meanwhile, right next to the Clinton Community College they are constructing the Career and Technical Education (CTE) labs and facilities (along with facilities in DeWitt and in Jackson County). These great facilities that will help ensure our future generations have the right skills for the job market and may obtain their individual goals and reach the objectives of filling critical jobs in Clinton.

Speaking of goal of improving our downtown(s), the City is waiting to hear from the State of Iowa on a request for over \$1.3M in funding for Facades. The overall projects will be over \$2M total with matches from business owners and the City. It will see 11 buildings and 21 sides renovated to include 8 business in the Downtown and 3 in the Lyons Business District. In addition, 4 microloans are being distributed to businesses to assist their operations. There could be several more neat and interesting projects in the Downtown that will continue to reshape our Downtown. Be sure to check out the article in this Lighthouse addition on The Grove which is an "art forest" in Pocket Park, located at 125 Fourth Ave South. Another project we have been discussing for some time is the Wilson Building. The full renovation is still on track to be completed late summer, early fall with numerous start-up businesses on the first floor and 33 luxurious apartments.

Along with all of the great projects that

are going on and the wonderful events we have planned this summer, we thought it would be a great time to announce the return of the Mayor's Youth Commission. This commission is set up for our young people that are currently in high school to have their voice heard at the city level. Along with the Mayor and the council mentor Councilmember Obren, the group will work towards goals and objectives that they think are needed for the young people in Clinton. The ideas and work that this group does will be brought to council for support just like any of our other boards and commissions. What better time than now to reengage this group, as the positive momentum sweeps through our community as a whole.

This time of year, means countless activities with Parks and Rec; check out the two full pages of those activities in this edition. With the goal of having our youth involved in all sorts of sports and other activities, it was amazing to see the numbers that are turning out. Director of Parks and Recreation, Josh Eggers, stated this year registration for soccer kids surpass 950 who signed up (which is one of the highest totals on record over the last 5 years). Also looking forward to the Swimming Pool opening for the summer. With the summertime weather and wanting to get out and about, we must mention the many great events returning this summer regarding the goal of "many things to do with a Riverview": there will be Thursday's Music on the Avenue, Finally Fridays, Showboat Equity Theater, LumberKings baseball and 4th of July Festival just to name a few. We are excited to show off our great City to visitors and know they will find Clinton to be warm, welcoming and beautiful.

## WHAT HAPPENS IF THE LEVEE FAILS

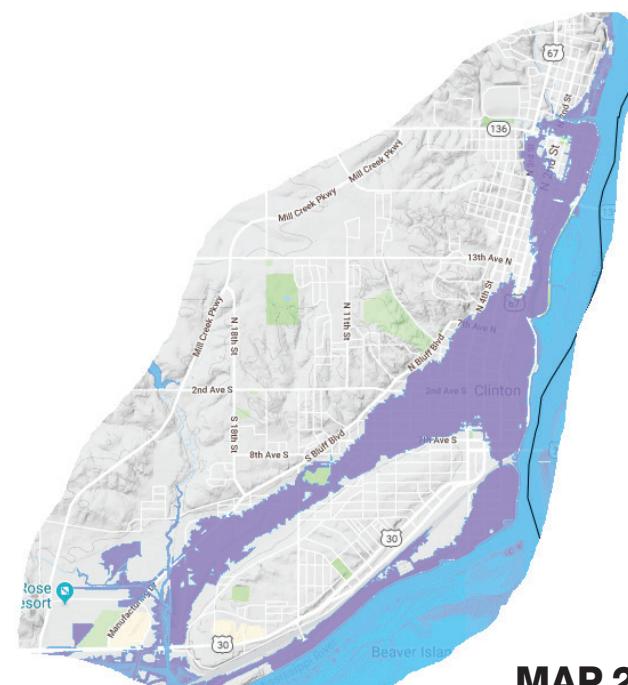
Thanks to our amazing levee system, few people in Clinton realize the potential for a catastrophic flood is real throughout many areas of town. There is a vast area of Clinton that would be prone to yearly flooding were it not for the magnificent levee system constructed by our forefathers after the persistent flooding incurred in the 1960's and 1970's.

Our levee is an urban flood protection project which was authorized by the United States government in 1962. The levee was completed between 1979 and 1983 in various stages along the right descending bank of the Mississippi River approximately between River Miles 514 and 521.4, or between Mill Creek at the south end and Turtle Creek at the north end. We are responsible for operating and maintaining the levee and the local flood protection system. This means regularly inspecting its integrity, patrolling the length of it to ensure no weak spots present themselves and closing the flood gates as river levels and the Army Corp dictate.

The Clinton levee was designed by the US Army Corps of Engineers to protect the city of Clinton from the 200-year frequency flood of the Mississippi River, which corresponds to a probability of exceedance of 0.5% in any given year (similarly a 100 year flood has a 1% chance of occurring each year, and a 50-year flood has a 2% chance of occurring each year). The entire levee was designed with 3-4 feet of freeboard, with the purpose of safe guarding against levee breach/break scenarios or other unforeseen circumstances.

**River Stages**

The local river stage used in the City of Clinton



comes from the USGS river gauge which is located in the Mississippi River near Camanche, and real time river stage levels are found on the National Weather Service website at [www.water.weather.gov](http://www.water.weather.gov)

The river stage zero reading for this gauge is set at 562.68' above mean sea level using the 1929 datum (USCGS 5th General Adjustment). Therefore, for example, when the local river stage is reported to be 17.00 feet, the elevation of the river at Camanche is 579.68' above mean sea level using the 1929 datum. Since the river does have a slope of approximately 6" per mile depending on flows, the actual river elevation in Clinton will vary depending on location.

To put river flooding into perspective in reference to our community, different river stages in Clinton will correspond to various local flood events, as listed below:

Stage 17.8' – Local Flood Stage is report by National Weather Service, marina flood gates are in

Stage 19.0' – Flood water begins to affect the Canadelight restaurant and other marina facilities

Stage 21.0' – Flood water begins to affect properties at 2600 block of Garfield Street

Stage 23.0' – Flood water begins to affect properties east of Garfield Street and north of 27th Avenue North along the Clinton riverfront

Stage 24.0' – Flood water begins to affect properties abutting Mill Creek in the commercial district including Kohl's, hotels, and Nestle Purina

Stage 29.0' – Mississippi River is close to the top of

the levee in some locations. At this point, we are worried about levee breach or overtopping at low points in the levee.

Historical Mississippi River crests are as follows:

- (1) 24.65' on 04/28/1965
- (2) 23.62' on 04/24/2001
- (3) 22.98' on 07/08/1993
- (4) 21.93' on 04/21/2011
- (5) 21.90' on 04/8/2019

With the exception of the flood in 1965, these large flood events were mostly contained by the levee system. After the construction of the levee all of these instances were almost entirely controlled by the levee system resulting in zero lasting damage. However, given a scenario where the levee system wasn't constructed today's reality would look much different. At a river stage of 21.9' as has been the recent crest the river would have left its banks flooding nearly everything east of 2nd Street and south of 7th Ave North. Riverview Park would be off limits, parts of downtown would have to install boat parking and the further south you go the deeper the water would get.

**Flood Inundation Maps**

In order to be prepared for floods, it is imperative that the citizens of our community are informed of possible flood impacts at various river stages. The maps below depict the approximate level of inundation.

These maps are derived from topographic info and interpolations of Corps of Engineers river flow data. They are conservative in nature, and should only be used as a guide for planning purposes.

**Map #1** – Approximate Flood Inundations at 24' in GREEN, 26' in ORANGE, 28' IN RED

**Map #2** – Approximate Inundations at levee failure or over-topping. This area is protected by the levee. If the levee were not in place, this area would be at risk of flooding each year. The City of Clinton encourages homeowners in this area to procure the proper flood insurance in case of levee failure.

### Appropriate Action

Please refer to any of the attached maps. If you live or own property in any of these parts of town, it may be prudent to check with your insurance provider regarding flood insurance. It always helps to be prepared. Any questions you may have regarding these maps can be answered by the Engineering Department at City Hall, which can be reached at 563-244-3423.

## CLINTON'S FIER NAMED TO IOWA'S VOLUNTEER HALL OF FAME

DES MOINES — Nine honorees, including one from Clinton, have been inducted into the 2022 Iowa Volunteer Hall of Fame.

Lt. Governor Adam Gregg inducted Greg Fier, of Clinton, seven other individuals, and a team of people focused on increasing vaccination rates, during a ceremony at the Iowa State Capitol building April 21. Fier joins a list of honorees that includes Tabinda Cheema, Davenport; Herbert Hazewinkel Jr., Peosta; Dr. Steven Meyer, Sioux City; Pam Schoffner, Polk City; Edna Schrandt, Decorah; Tom Townsend, Dubuque; VaxDSM Project, Des Moines; and Kathy Waychoff, Fairfax.

Being selected for the Iowa Volunteer Hall of Fame is the most prestigious state-level honor volunteers can receive as recognition of extraordinary donations of volunteer service to their communities, according to Volunteer Iowa, a commission composed of 15 to 25 governor-appointed individuals that determines who will be inducted.

According to Volunteer Iowa, Fier was selected for his volunteerism and advocating for people living with multiple sclerosis.

His profile on the Volunteer Iowa site notes Fier has overcome the adversity of total quadriplegia due to multiple sclerosis to become an incredibly productive service leader as well as an advocate and inspiration for others with MS and other disabilities.

"As his physical abilities steadily dwindled from MS, his determination to serve his community grew. He focuses his creative talents, communication skills and technical learning ability to contribute to the community in many ways," the profile states. Fier began his advocacy work when he joined the Clinton MS Support group. Soon state and local politicians and leaders got to know Fier, who taught them about the many issues that people with MS and various disabilities face.

Volunteer Iowa noted that Fier became one of the main organizers of the MS'issippi Walk-n-Roll, which has raised tens of thousands of dollars for the National MS Society since 2013.



He also is recognized for his personal mission to provide hands-free technology and technical assistance for a local musician who had been diagnosed with MS. Volunteer Iowa noted that he spearheaded a fundraising project to cover the costs for this one individual and then engaged friends, families, and the local MS support group to establish a nonprofit organization with the mission to provide individuals living with MS support and resources to remain independent in their own homes. The Bob Finch Memorial Fund has contributed over \$40,000 to cover the cost of projects that span from installing stairway lifts and hardwood floors to fully remodeling bathrooms and purchasing vans.

Fier remains a dedicated advocate for people with disabilities, participating with local, state, and national advocacy groups and much of his advocacy has centered on caregiver support, focusing on residential caregivers being fairly compensated and treated with respect and flexibility. Volunteer Iowa states that Fier is dedicating his award to his caregivers and all home and community-based caregivers who give so much of themselves.

"As he states, 'I hope that my ability to volunteer shines as a testament to how keeping disabled and elderly folks in their homes and communities instead of institutions is better for all of us,'" Volunteer Iowa stated in his profile.

The Hall of Fame induction ceremony also included the presentation of two Excellence in Mentoring Awards, which gives Iowa MENTOR certified programs the opportunity to recognize outstanding long-time youth mentors. The recipients of the 2022 Excellence in Mentoring Award are Matt Guess of West Des Moines and Mike Leerar of Garner.

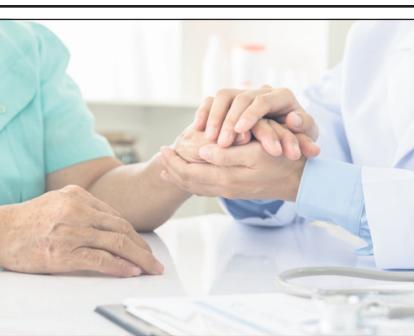

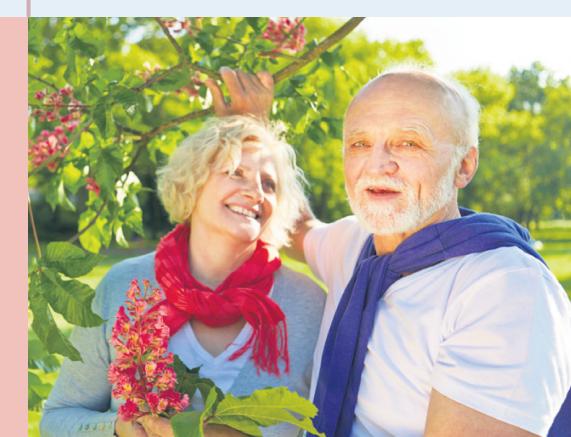

## CLINTON POLICE DEPARTMENT

## ATV OPERATION IN THE CITY OF CLINTON

Spring has arrived, and we have already seen more ATVs on the road. With this in mind, please be aware of some of the restrictions associated with driving these vehicles.

The City of Clinton enacted a new Chapter to the Clinton Code of Ordinances (Dec. 2020), allowing the operation of All-Terrain and Off-Road Utility vehicles on permitted City streets.

An "All-terrain vehicle" or "ATV" is defined as a motorized vehicle with no less than three and not more than six non-highway tires with less than a 1,000-cc engine, weighing less than 1,200 lbs. with a seat or saddle designed to be straddled by the operator and handlebars for steering control. This definition of "all-terrain vehicle" shall not include off-road motorcycles.

An "Off-road utility vehicle" or "utility terrain vehicle" or "UTV" is defined as a motorized vehicle with no less than four and not more than eight non-highway tires with a bucket or bench design seat not intended to be straddled by the operator and a steering wheel or control levers for control.

A "Golf cart" means a four-wheeled recreational vehicle generally used for transportation of person(s) in the sport of golf that is either electric powered or gas powered with an engine displacement of less than 300 cc and a weight

of less than 800 pounds.

There are restrictions on who and where these vehicles can be operated on City streets. The operator of an ATV, UTV, or golf cart **shall be at least eighteen (18) years of age, possesses a valid driver's license, and obtain a City of Clinton Operation Permit.**

Drivers who operate on Clinton's streets must show proof of ATV or UTV registration with the Iowa Department of Natural Resources and **proof of liability insurance.** Golf carts also must possess proof of liability insurance.

ATV, UTV, and golf carts may be operated only as permitted on City streets. ATV, UTV, and golf carts shall not be operated upon any City street, which is a primary road extension through the City. **Primary road extensions shall include Mill Creek Parkway, Highway 30, Highway 136, and Highway 67.**

However, ATVs and UTVs may traverse such a primary road extension, using the most direct route, to reach streets where lawful operations are permitted without impeding traffic. In addition, ATV and UTV shall not be operated on any street at a speed exceeding 35 miles per hour. Golf carts shall not be operated on any street with a posted limit above twenty (20) miles per hour. Golf carts shall not traverse any primary road extension or any other

road posted at over 20 miles per hour, regardless of the need to reach permitted areas of use.

There are also requirements for safety equipment when operating ATVs, UTVs, and golf carts. All vehicles must have adequate brakes, rear and side-view mirrors, and a muffler system limiting engine noise. ATV and UTV must have headlights and tail lights when operating from sunset to sunrise. Golf carts may only be operated between sunrise and sunset and must have a safety flag a minimum of five feet from the ground and a slow-moving vehicle sign.

UTVs must have safety belts. If an ATV or UTV is not equipped with a windscreens, operators and passengers shall wear eye protection in the form of goggles, safety glasses, eyeglasses, or sunglasses.

**The City Operation Permit is available at the Clinton County Recorder's Office. In addition to a required State permit, a \$100.00 fee shall be paid by all owners of any ATV, UTV, or golf cart operated on City streets.** This fee is paid bi-annually by July 1. Non-residents wishing to temporarily operate ATVs, UTVs, or golf carts in the City may acquire a seven-day permit for \$25. All ATVs, UTVs, or Golf carts shall have a current, color-coded City Operation Permit sticker or non-resident temporary permit affixed and visible on the ATV, UTV, or Golf Cart at all times during operation.

## MARIJUANA IMPAIRS DRIVING

There are many misconceptions about marijuana use, including rumors that marijuana can't impair you or that marijuana use can actually make you a safer driver.

Several scientific studies indicate that this is false. Research shows that marijuana impairs motor skills, lane tracking, and cognitive functions (Robbe et al., 1993; Moskowitz, 1995; Hartman & Huestis, 2013). A 2015 study on driving after smoking cannabis stated that THC in marijuana also hurts a driver's ability to multitask, a critical skill needed behind the wheel.

NHTSA (National Highway Traffic Safety Administration) continues to conduct research to better understand the relationship between marijuana impairment and increased crash risk. For example, NHTSA's Drug and Alcohol Crash Risk Study found that marijuana users are more likely to be involved in crashes. However, the increased risk may be partly because marijuana users are more likely to be young men, generally at a higher risk of collisions.

Research indicates drug prevalence is on the rise among drivers. NHTSA's 2020 study of seriously or fatally injured road users at studied trauma centers (Thomas et al., 2020) suggested that the overall prevalence of alcohol,

cannabinoids, and opioids increased during the public health emergency compared to before.

While evidence shows that drug-impaired driving is dangerous, we still have more to learn about the extent of the problem and how best to address it. In January 2018, NHTSA launched a new initiative to address drug-impaired driving. NHTSA's National Drug-Impaired Driving Initiative brings together experts, including law enforcement officials, prosecutors, substance abuse experts, and others, to discuss strategies that can reduce drug-impaired driving.

**THE ISSUE: It's Illegal**

Driving impaired by any substance—alcohol or other drugs, legal or illegal—is against the law in all 50 states and the District of Columbia. Law enforcement officers are trained to observe drivers' behavior and identify impaired drivers. Even in states where marijuana laws have changed, it is still illegal to drive under the influence of the drug.

NHTSA's National Roadside Survey conducted in 2013-2014 (PDF, 173 KB) found that 20 percent of surveyed drivers tested positive for potentially impairing drugs.

Surveys conducted by NHTSA show

the number of drivers testing positive for marijuana increased between 2007 and 2014. For example, in 2007, NHTSA's National Roadside Survey (PDF, 1 MB) found that 8.6 percent of weekend nighttime drivers tested positive for marijuana. In the 2013-2014 survey, 12.6 percent of weekend nighttime drivers tested positive for marijuana. That's a 48-percent increase in less than 10 years.

While the presence of a drug in a driver's system doesn't necessarily mean that they're impaired, these findings show the importance of raising awareness about the risks of drug-impaired driving.

**THE ISSUE: Responsible Behavior**

We can all save lives by making smarter choices.

- If you plan to use an impairing drug, plan ahead for a sober driver.
- Don't let friends get behind the wheel if they're under the influence of drugs.
- If you're hosting a party where alcohol or other substances will be used, it's your job to make sure all guests leave with a sober driver.
- Always wear your seat belt—it's your best defense against impaired drivers.

**Clinton Community School District Initiating P3 (Tips) App.**

Clinton School Resource Officer Corporal Haskell wanted to make the community aware of a new Tips App Program the Clinton Community School District (CCSD) has initiated to help keep the school community safe.

**What is P3 Campus?**

P3 Campus is an anonymous tip reporting solution designed specifically for the educational community. P3 Campus is an additional tool in keeping schools and students safe. School community members can report a wide range of concerns, from mental health issues to threats of violence, through the P3 Campus mobile app or through any web browser at P3 Campus. com. The P3 technology is used in thousands of schools and has saved lives and prevented tragedies. It gives administrators and designated law enforcement officials an intuitive interface to manage and share tips in real-time.

**Who can use it?**

The Clinton Community School District (CCSD) will have the app available for Clinton High School and Clinton Middle School stakeholders (students and parents), but anyone who has a safety concern regarding a student or the school can use the app.

## CLINTON POLICE DEPARTMENT CONTINUED

## A CHILD IS MISSING...WHAT SHOULD WE DO?

The Clinton Police Department responds to several calls for service during the year. A missing person or child call is arguably a stressful call not only to the police, but to the reporting party or the parents. Fortunately, the majority of missing child cases are resolved within hours. Missing children are frequently found as a result of a thorough investigation and a partnership between the community and the police department. Recent cases have shown.

**1. Try to stay calm and call law enforcement immediately.**

When a child goes missing, the Clinton Police Department recommends that you immediately call local law enforcement. Although it will be hard to do, try not to spend time looking for the child until you have alerted law enforcement.

**2. Provide your child's information.**

In the initial stressful moments when you can't find your child, it's common to forget the basic information law enforcement and 911 operators are going to request. However, if you can present facts and information in an organized manner, police will be able to move quickly on any leads. Be prepared to provide as much information about your child as you can, including the following:

- Child's full name
- Child's weight, height, age, and date of birth
- The clothes the child was last seen wearing
- Last known location, or the last place your child was observed.
- Identifying features, glasses, birthmarks, unique hair color, etc.
- Names and contact information of the child's friends, close relatives, or acquaintances
- Frequently visited hangout spots; parks, school functions, favorite convenience stores, etc.
- Any health issues the child may have
- Any other possibly relevant details about the time or place the child went missing

Police and other agencies are going to request a picture, too, so try to find several recent photographs that clearly display distinguishing characteristics.

**3. Look in your immediate area.**

Once law enforcement has been notified, begin searching where you last saw your child. Young children are prone to hide somewhere and fall asleep, so look on all beds, under furniture, in piles of laundry, around vehicles, and inside your washer and dryer.

If you're in a store when a child goes missing, notify the store manager immediately. Many stores follow a missing child protocol, where all employees will stop working to look for the child and monitor the store's entrance to ensure the child does not leave.

In instances where the child is old enough to have a phone or social media account, they may have left some digital clues. Rather than digging through electronic records yourself, ask the police to explore messaging histories and social sites.

Older children also tend to have run to friends' houses, so call around to any friends, family, or neighbors who are close to your child.

**4. Make yourself available.**

The first 48 hours after a child goes missing are critical. As a parent, you are going to want to help with the physical search, but it is recommended parents instead focus energy on gathering and providing information to investigators.

Especially as law enforcement may want to check your home and your child's room for evidence - it's common for authorities to take clothing, sheets, computers, and even trash as evidence—you'll want to make sure you're available to give investigators access to anything they need.

Keep your phone lines open, and put the name and number of the investigator assigned to your case in an easily accessible location. It's also a good idea to write down names, numbers, and other information relating to the case in a designated notebook.

**5. Amber Alert**

Depending on the circumstances surrounding the disappearance—if officers suspect abduction or feel the child could be in imminent danger—authorities may issue an AMBER Alert to spread the word throughout the community. The following criteria are utilized to determine if an AMBER Alert should be issued in the state of Iowa:

1. Law enforcement confirms a child has been abducted, and entry has been made into the IOWA/NCIC systems identifying the child is missing.
2. The child is under the age of 18.
3. Law enforcement believes the circumstances surrounding the abduction indicated that the child is in danger of serious bodily harm or death.
4. There is enough descriptive information about the child, abductor, and/or the suspect's vehicle to believe an immediate broadcast alert will help.

Keep in mind that police will only put out an AMBER Alert if they believe a child **has been abducted and are in danger of serious bodily harm or death**. The criteria is strictly adhered to in order to discourage overuse of the program that would make it less effective.

## CAR SEATS AND BOOSTERS

Car seats and boosters provide protection for infants and children in a crash, yet car crashes are a leading cause of death for children ages 1 to 13. That's why it's so important to choose and use the right car seat correctly every time your child is in the car. Follow these important steps to choose the right seat, install it correctly and keep your child safe.

**Car Seat Recommendations for Children**

There are many car seat choices on the market. Use the information below to help you choose the type of car seat that best meets your child's needs.

- Select a car seat based on your child's age and size, choose a seat that fits your vehicle, and use it every time.
- Always refer to your specific car seat manufacturer's instructions (check height and weight limits) and read the vehicle owner's manual on how to install the car seat using the seat belt or lower anchors and tether, if available.
- To maximize safety, keep your child in the car seat as long as possible, as long as the child fits within the manufacturer's height and weight requirements.

- Keep your child in the back seat at least through age 12.

**Rear-Facing Car Seat**

Birth – 12 Months

Your child under age 1 should always ride in a rear-facing car seat. There are different types of rear-facing car seats:

- Infant-only seats can only be used rear-facing.
- Convertible and All-in-One car seats typically have higher height and weight limits for the rear-facing position, allowing you to keep your child rear-facing for a longer period of time.

**1 – 3 Years**

Keep your child rear-facing as long as possible. It's the best way to keep them safe. Your child should remain in a rear-facing car seat until they reach the top height or weight limit allowed by your car seat's manufacturer. Once your child outgrows the rear-facing car seat, your child is ready to travel in a forward-facing

## SMOKE DETECTOR PROJECT... ONGOING SUCCESS

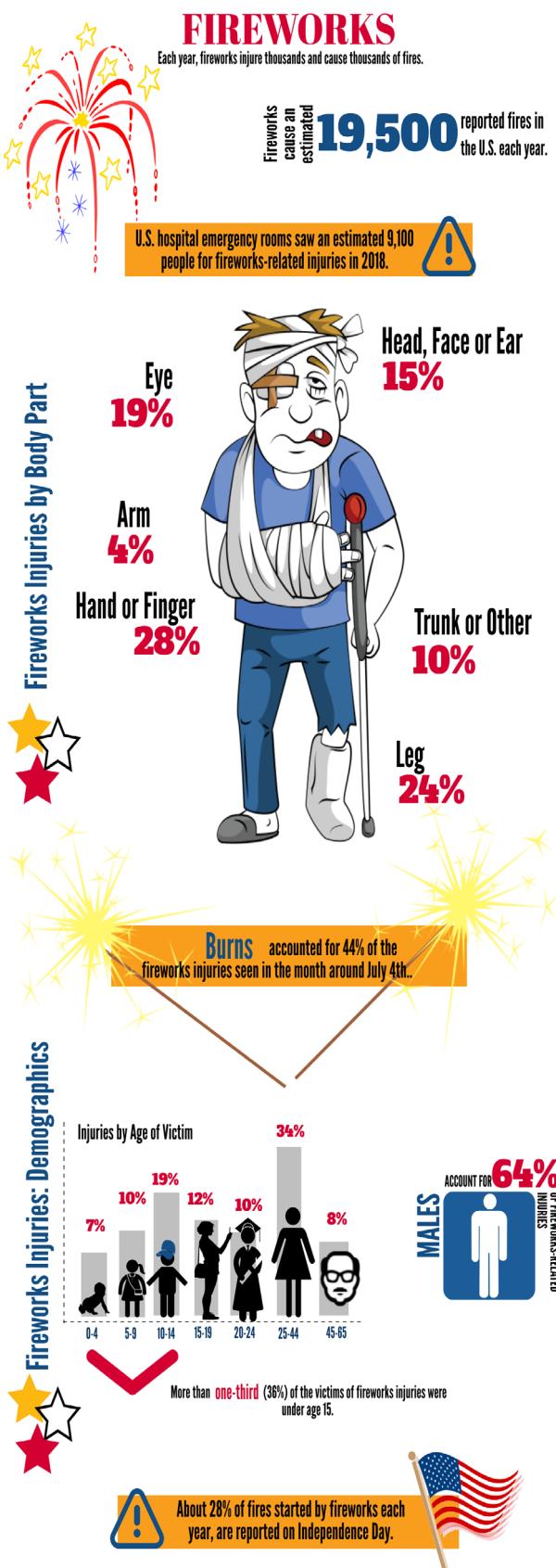

The City received an unmodified opinion from the State of Iowa Auditor's office on our fiscal year 2021 audit. An unmodified opinion is an opinion where the auditor expresses an opinion that financial statements are presented, in all material respects, in accordance with an applicable financial reporting framework.

Auditor of State Rob Sand today released an audit report on the City of Clinton, Iowa.

#### FINANCIAL HIGHLIGHTS:

The City's revenues totaled \$53,878,590 for the year ended June 30, 2021, a 17.4% increase over the prior year. Expenses for City operations for the year ended June 30, 2021 totaled \$51,842,085, a 1.6% increase over the prior year. The significant increase in receipts is primarily due to a new franchise fee and Federal CARES ACT funding.

#### AUDIT FINDINGS:

Sand reported nine findings related to the receipt and expenditure of taxpayer funds. They are found on pages 114 through 123 of this report. The findings address issues such as a lack of segregation of duties, material amounts of receivables and payables not properly recorded in the City's financial statements, the lack of utility billing reconciliations, lack of procedures to ensure the accuracy of time reporting and disbursements exceeding budgeted amounts. Sand provided the City with recommendations to address each of the findings.

Eight of the nine findings discussed above are repeated from the prior year. The City Council has a fiduciary responsibility to provide oversight of the City's operations and financial transactions. Oversight is typically defined as the "watchful and responsible care" a governing body exercises in its fiduciary capacity.

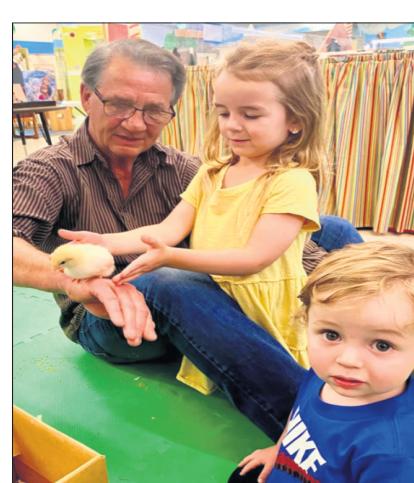

Cities in Iowa with a population > 2,000 people and with annual budgeted expenditures of > \$1 Million in two consecutive years are required to have an annual examination. Fiscal year 2021 is the 7th year that the city has had the State of Iowa audit team perform the audit.

## CODE ENFORCEMENT DEPARTMENT

### GRASS & WEEDS

Spring has arrived and we are all gearing up for warmer weather. With that comes mowing season. Be courteous to your neighbors and keep your grass and weeds cut. This also helps to keep bugs, rodents and snakes down in your neighborhood, and remember please do not mow or blow grass clippings into the street and keep the sidewalks clear.

#### CHAPTER 94.01

City requires grass, weeds, vines to be cut / mowed when it exceeds eight inches in height.

**§ 94.02 DEFINITIONS. § 94.03 MAINTENANCE OF BOULEVARD AND RESIDENTIAL PROPERTY.** This includes all the way to the curb in front of your property as well as out back along the alley way. Please remember to cut these areas as well.

City is only required to post in the newspaper the Grass & Weeds ordinance once a year. There are no notices sent to owners or tags placed upon the property requesting you to mow or cut your grass and weeds.

## PROPERTY NUISANCE

#### 90.07 NUISANCE ABATEMENT.

Whenever the Code Enforcement Officer receives a complaint and finds a nuisance exists on the property, notice is sent to the property owner by certified mail giving a reasonable time to abate the nuisance.

Please contact the officer who sent you the notification if you need more time to complete the clean up or have questions regarding the notice you received.

If you have not abated the nuisance by the time listed on the notice you were sent, and seven days has passed, you will receive a sticker on your day with an additional two days. After that time, your property will be sent to a contractor to abate the nuisance and you will be sent a bill for the clean.

The Code Enforcement Officers are always willing to assist and help residents in any way they can.

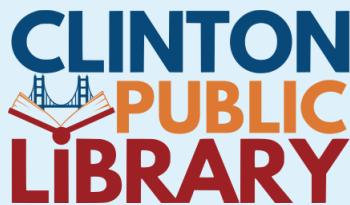

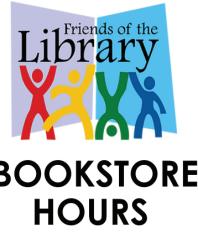

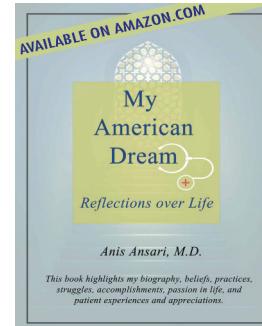

A: My favorite book or genre is non-fiction, especially history and automotive.

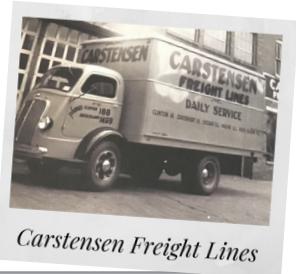
**Q: What do you like to do in your free time?**

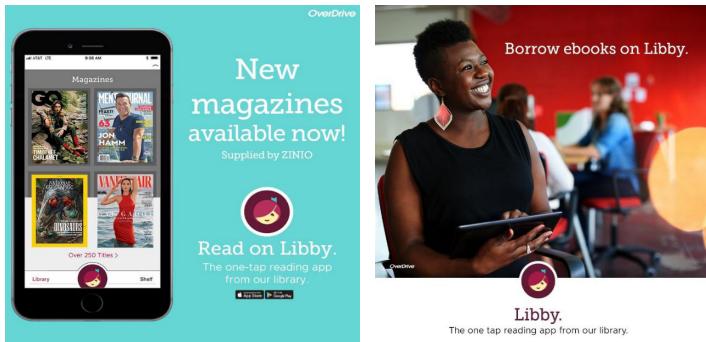

# STREETS & SOLID WASTE DEPARTMENT

The City of Clinton Public Works Departments strive to maintain the safety and health of our community in all our endeavors. Public Works consists of the following 4 departments.

The Streets Department's **6** employees have several responsibilities within the city's right-of-ways. Some of these responsibilities include: pothole repairs; putting up and replacing street signage; street sweeping; snow & ice removal on city streets; alley grading; right-of-way mowing and weed spraying; and removing fallen trees, branches, and debris within the roadway.

The Solid Waste Department's **6** employees are responsible for the collection of the city-owned garbage, yard waste and recycling carts. The

Solid Waste Department is also responsible for taking the orders for delivery and cancellation of the city-owned carts. The Solid Waste Department also assists with snow removal when a "Snow Emergency" is declared.

The Sewer Maintenance Department's **4** employees maintain the storm and sanitary sewer systems throughout the city. The Sewer Maintenance Department also assist with snow removal when 1 or more inches of snow is forecasted.

The Facilities and Grounds Department's **6** employees maintain city owned property and buildings throughout the city. The Facilities and Grounds Department also assist with snow removal when 1 or more inches of snow is forecasted.

**As a reminder when driving around town, we ask that you please use caution and slow down when approaching street crews in the roadway. Thank you!**

**By following these two simple rules, you can help save lives, avoid receiving a traffic ticket and prevent the potential loss of your driver's license. Iowa law requires motorists to:**

1. Change lanes or slow down, absent any other direction from a peace officer, when approaching the following vehicles, as provided in (Iowa Code

section 321.323A):

- A stationary emergency vehicle that has its flashing lights activated.
- A stationary tow, recovery, maintenance, construction, solid waste or recycling collection vehicle that has its flashing lights activated.
- Any stationary motor vehicle, including a passenger vehicle, that is continually displaying its emergency signal lamps (i.e., standard hazard lights).

2. Yield the right of way to an emergency vehicle displaying flashing lights or giving an audible signal by moving over to the right, stopping and waiting until the vehicle has passed before proceeding. (Iowa Code section 321.324).

## Streets Department Information

### Debris in Street or Alley

Please be aware that it is against City Ordinance to blow cut grass or leaves into the roadway and gutter. Yard debris clogs up storm drains/catch basins and can contribute to sewer backups. If you have a storm drain/catch basin anywhere around your property, please keep it clear to ensure all runoff drains properly.

#### § 97.003 Placing Debris on Street or Alley

It is unlawful for any person to throw or deposit on any street or alley any glass, glass bottle, nails, tacks, wire, cans, trash, garbage, rubbish, litter, offal, leaves, grass or any other debris likely to be washed into the storm sewer and clog the storm sewer, or any substance likely to injure any person, animal or vehicle.

(Iowa Code § 321.369) (1999 Code, § 135.03) Penalty, see § 10.99

### Trimming Trees

#### § 98.06 Duty to Trim Trees

The owner or agent of the abutting property shall keep the trees in or overhanging the street trimmed so that all branches will be at least 13 feet above the surface of the street and 9 feet above the sidewalks. If the abutting property owner fails to trim the trees, the city may serve notice on the abutting property owner requiring that such action be taken within five days. If such action is not taken within that time, the city may perform the required action and assess the costs against the abutting property for collection in the same manner as a property tax. Except as allowed in this section, it is unlawful for any person to trim or cut any tree in a street or public place without first obtaining authorization from the city. The Building and Neighborhood Services Official or his or her designee shall have the power to enforce this section.

(Iowa Code §§ 364.12(2)(c), 364.12(2)(d), 364.12(2)(e), 364.12(3)(b)) (Ord. 2437, passed 12-14-2010) Penalty, see § 98.99

Trees in right-of-ways are owned by the property owner, not the city. The city may remove trees in the right-of-way when there is a hazard caused by the tree, the tree has become a nuisance, the tree is dead/dying or for public works projects. When a tree in the right-of-way has been identified to be removed a notification letter will be sent in advance to the homeowner. Any damage to a home and/or property caused by a tree in the right-of-way would be covered by the home owner's insurance policy.

### Property Owners/Tenants Responsibility for Maintaining Right-of-Way

All owners of property and/or tenants of rental property are responsible for the maintenance of the right-of-way adjacent to the parcel's property lines. All grass, weeds, vines, and brush must be kept to less than 8" of growth.

#### § 94.03 Maintenance of Boulevard and Residential Property

All owners of property abutting any road right-of-way shall maintain their property and the abutting road right-of-way by cutting or destroying all grasses, weeds, vines and brush when the growth exceeds eight inches in height.

### Residential Street Light Outages

Many people are not aware that the majority of the street light outages in residential neighborhoods are not the responsibility of the City of Clinton. The City of Clinton is only responsible for the lighting and poles in the business corridors throughout town as well as the traffic signals. Street lights located in the residential areas of town are the responsibility of Alliant Energy. For any problems concerning residential street lights Alliant Energy prefers to be contacted by the homeowners directly. Listed below is the contact information for outages:

Vehicles or containers used for the collection and transportation of any solid waste shall be **loaded** and moved in a manner that the contents will not fall, leak or spill therefrom, and shall be **covered** to prevent blowing or loss of material. Where spillage does occur, the material shall be picked up immediately by the collector or transporter and returned to the vehicle or container and the area properly cleaned. (1999 Code, § 106.03) (Iowa Code §§ 321.460 and 805.8A(13)(c)

### Solid Waste Collection Program

#### CART INFORMATION

- All City of Clinton collection carts are the property of the City.
- The City has 3 types of collection carts: Gray – garbage, Green – yard waste, and Blue – recycling.
- Collection carts are assigned to an address, not an individual (family). When ownership of a residence changes, each cart must stay at the address it is assigned to. Residents may cancel services at any time and all appropriate carts will be removed.
- Residents have the option to purchase extra carts if so desired, purchased carts move with the owner.
- Each resident is responsible for the proper care and security of the collection carts. The resident will be charged for replacing a cart should it become damaged or stolen as the result of improper care and/or not keeping the cart secured on the property.

#### COLLECTION INFORMATION

- All carts must be out by 7:00 am the day of collection.
- Garbage should be bagged in the gray cart.
- Yard waste should be placed loose in the green cart (**no bags**).
- Recycling should be placed loose in the blue cart (**no bags**).
- Carts will not be emptied if there is improper or incorrect material in the cart (such as garbage in a yard waste or recycling cart).
- Hot ashes should never be placed in the carts.
- Construction debris is not allowed in any of the carts.
- Toxic or hazardous waste is not allowed in any of the carts. This includes: electronics, pesticides, paint cans with paint, motor oils, sharps containers, flammable material, etc. (Contact the Clinton County Landfill at 563-243-4749 for any questions about acceptable material.)
- The maximum weight limit of the 95-gallon carts is 150 lbs.
- To avoid exceeding the weight limitation of the cart, or causing possible damage to the cart or collection vehicle, do not place rocks, concrete, bricks or dirt inside carts. Any items placed within the cart must fall out easily when the cart is being serviced. Please do not overfill or tightly pack items into the cart.
- Lids must be closed.
- Carts must be located in an area that is easily accessible for the automated trucks. Collection drivers will not leave their vehicles in order to move a cart.
- Give adequate space between carts for collection by the automated trucks – 3 feet apart is optimal.
- Carts must be placed for collection away from homes, garages, fences, parked vehicles, utility poles, mailboxes, etc. 5 feet is the preferred distance to ensure that any property or possessions are not damaged.
- Carts should not be placed higher than 1 foot above the surface that the collection truck is on.
- Carts should not be left at their collection spots past the collection day. Carts should be removed from the street or alley right-of-way and placed in a designated storage area on the resident's property. (This will prevent a possible road hazard, damage to the cart, or theft of the cart.)

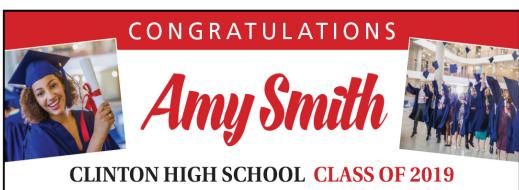

"Duke" Slater  
MEMORIAL STATUE

The Duke Slater Memorial Statue Committee is installing a lifesize statue of Duke at Clinton High School. Remaining funds will go towards scholarships in Duke's name. Duke called Clinton home. He was the first Black student-athlete in the University of Iowa's history to earn All-America honors. A three-time first-team All-Big Ten selection, Slater competed in football and track and field for the Hawkeyes. He was the first Black linemen in the National Football League (NFL) in 1922. After his playing days were over, he later became the first Black judge selected to the Chicago Superior Court - the highest court in the city at that time (1960).

Duke was inducted into the Pro Football Hall of Fame in 2020. The playing field at the University of Iowa was named Duke Slater Field in 2021.

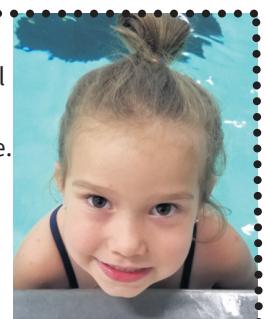
