## A MESSAGE FROM THE MAYOR AND CITY ADMINISTRATOR

Welcome to another edition of the Lighthouse from Mayor Scott and City Administrator Matt, in partnership with the Clinton Herald and the City. Its primary purpose is to inform y'all of everything that is happening from all the available Parks and Rec activities to highlighting new Police Officers A. Griffin and E. North, new Police Dept. employee E. Cain and the Fire Fighter of the Year Eng. R. Winkler by the American Legion. Additionally, we've got information about new projects like the Emma Young Pond rehab, Spotlight on R. Foley, the Fire Departments new Candidate Physical Ability Test (CPAT), Airport Holiday Light tour, where to vote for the November 2 elections and information on the American Rescue Plan (ARP) to assist in paying sewer bills. All that and much more.

Folks always wonder what the "City" is up to. We like to say the City is you, it is us, and it is we. Not them or they but rather, We. What we, the "City", focus on to inspire Hope in Action is leveraging the Clinton's Strategic short-term goals: Finance, Communications, Quality of Life and Making the City Departments more Efficient. Creating a plan, allowing others to visualize the plan, and then acting on that plan allows hope to flow through the process and bring projects to reality.

During the 2021 League of Cities conference in September, it was announced that the City of Clinton won the 2021 People's Choice award for the Jurgensen Soccer Complex. Winning this award is a direct reflection of Clinton folks' votes as well as their sense of community pride. The Jurgensen Soccer complex idea was hatched many years ago. In the past, the area housed the dirt that had been removed to help build the levy from 1965-1973. Then, after the YMCA sold the ground to the City, the City created soccer fields on terraces. The 2013 vision came to fruition during the FY20 and FY21 budget seasons when the Council approved funding, a wonderful \$200,000 match from the CCDA, exemplary engineer design, irrigation, ADA accessibility, new concessions and restrooms, new parking lot and water management, along with Public Works Department assisting in preparing the area and then installing new dirt and grass. All the while, Parks and Rec Director Josh Eggers and City Engineer Jason Craft oversaw the project every step of the way. If you need a smile or just to feel good about life in general, drive over Harrison Drive on a Saturday morning to see literally hundreds of kids playing soccer. It's truly an amazing transformation.

The Strategy for both our Com-

munications and Finance short-term goals include creating a seamless and transparent method to ensure anyone and everyone can have access to any/all documents online. The idea was hatched prior to COVID-19 and the Council approved funding, however, all was sped up due to COVID-19. At the center of it all was Clinton's very own City Clerk Lisa Frederick. The training, set up and execution all occurred in order to reveal iCompass technology in May 2020. City Clerk Lisa Frederick was named a 2021 Modern Governance 100 recipient in the ESG and Diversity Trailblazer category by Diligent Corporation, a software service company that enables board members of government organizations and nonprofit groups to collaborate and share information for board meetings. Additionally, part of the Communications strategic goal is improved transparency. As a result, now anyone can access the Document Center and search for items via the City webpage by going to the Agendas and Minutes tab. In addition, clicking on a date on the calendar will provide all the meetings that day and link to minutes. There is no reason any and all citizens and businesses can't monitor and track

all the happenings within City Government.

Next, the strategy and goals for improving Quality of Life involve both jobs and housing. Clinton is seeing a rebirth across existing businesses, new businesses and housing. Even though Clinton and Clinton County continues to see a population decline, business and housing expansion is growing at an unheard-of pace. Year-to-date, close to 1,980 permits have been pulled for capital investment of \$104M (Jan-Sep 2021). All that said, the City of Clinton, which is truly a regional hub, has over 9,000 employees who drive in to work every day with the mission to keep making Clinton a place people want to live and work!

The City has taken on a multi-pronged attack for attracting new business, supporting expansion of existing business, bringing in developers for new houses and apartments and reviving housing in the Hub Zone area. The City has 13 active and new Development Agreements supporting existing businesses, new businesses and housing with estimated \$765M investment of capital for business development and \$42M in housing over the last 12-18 months. The City, businesses, and citizens have stemmed off flooding, a Derecho and an ever-changing environment that has created a more challenging time to maintain infrastructure. An existing business's expansion included two large expansions totaling over 250M of capital investment with 80 new jobs. Another business has added 73 jobs and moved a critical portion of the operations to Clinton. In addition, the City is seeing over \$107M expansion of an existing business teaming up with a new business, and a \$500M expansion at the Industrial Rail Air Park, with over 50 and 60 jobs respectively. Over 350 new full-time jobs have been created through current and new business job growth. All these new employees need to find affordable living with either a house or apartment.

Thus, the City has been working with numerous housing and apartment developers at the tune of \$42M

in new infrastructure. River Stone Crossing infrastructure is just about completed with several foundations being approved. Mill Creek Crossing is in the midst of several new foundations, Jordan Heights continues to build new homes and Zara Heights is on track to have BWC complete the public infrastructure by publication time. On the apartment side, Valley Bluff is in the midst of building 231 apartments. As soon as they are built, they are being occupied. We all have been watching closely as the historical Wilson Building, built in the early 1900s, is in the midst of a complete renovation. 60% of the apartments have been reserved and several businesses are already coordinating to occupy the first floor. Also, numerous 1-4 bedroom apartment complexes are being renovated and updated to give even more opportunities for living in Clinton. It is also great to see the current homeowner renovations which the Neighborhood Improvement Committee continues to award with Improvement awards – keep it up! Another important aspect of Quality of Life in Clinton is the maintenance of our roads. City Engineer Jason Craft has put together the Pavement Management Plan (PMP) that includes 151 miles of roads. Jason has created a solid long-term plan to continue moving the condition index to higher levels, with the goal of reaching an optimum level for maintaining safer roads.

Finally, we are all excited about all the positive growth in Clinton, including the new Clinton Community College Technology Center expansion and the complete Clinton High School renovation / new build of the High School. Clinton continues to lead the area in development as a mid-size city. As we like to say, we're "fighting above our weight class". Clinton citizens, who are historically known as strong-willed, proud and questioning of change, are in the midst of a true metamorphosis of our wonderful community. As with anything - one has to first believe, then literally be able to see it, and lastly leverage a bit of hope and good planning. "We" can accomplish anything while maintaining a strong sense of humility and humor along the way!


## CPD: WINTER WEATHER TIPS

to help with traction if you get stuck. Keep jumper cables and some type of warning device in your car as well as a blanket, and make sure your cell phone is charged.

The best piece of advice we can give you is to slow down. It's harder to control or stop your vehicle on a slick or snow-covered surface. Also, don't crowd a snowplow or travel beside it. Snowplows travel slowly, make wide turns, often stop, overlap lanes, and exit the road frequently. Remember, the road behind a snowplow is safer to drive on, so stay behind it or be cautious when passing one.

If you find yourself stranded, stay in your car. Put a bright marker on your antenna or windows and keep your dome light on and emergency flashers. If the snow is deep, don't forget to remove the snow around your exhaust pipe, and if you can, keep your car on for short periods.








Figure 2: When these very small blood vessels become diseased they begin to shrivel up and the nerves begin to degenerate.



## CLINTON POLICE DEPARTMENT

## USING TECHNOLOGY TO BETTER ASSIST THE COMMUNITY

Crime-fighting in the 21st century has become a balancing act of traditional police and the use of state-of-the-art law enforcement technology. Police work still includes officers responding to calls, boots on the ground, neighborhood canvases, and face-to-face interviews. Law enforcement technology includes online reporting, evidence portals, drones, body-worn cameras, GPS devices, computer-aided dispatching, handheld computers, and social media. Clinton's police officers must adapt to the ever-changing world of technology. Today police departments must continue to be innovative and find ways to serve our communities better.

The first sentence of the Clinton Police Department's mission statement reads, "The mission of the Clinton Police Department is to enhance the quality of life in Clinton by working together with the public and within the framework of the constitution to enforce the law, preserve the peace, reduce fear and provide for a safe environment."

Chief Gyron has implemented

several new technologies, including social media, to better serve and communicate with our citizens. The department uses social media as a way to engage, inform and empower those we serve. The Clinton Police Department's Facebook page can be found searching Facebook for @clintonpolicedepartment.

The Clinton Police Department has posted videos requesting the community's assistance in identifying suspects. The crimes include bank robbery, business burglary, and forgery cases. The response to these videos and the cooperation from our citizens has been beneficial in identifying suspects.

In addition to social media, the department deployed a segment of our Body-Worn Camera program to allow citizens to upload digital evidence directly into a case file for investigation. Witnesses with surveillance video, cell phone videos, or digital pictures can access the evidence portal and share the evidence with the department. Suppose you believe you have (digital) evidence of a crime. In that case, you can contact

the Police Department at 563-243-1458 to access the portal.

Online reporting has increased the efficiency of officers by freeing up time to patrol the city. The department received a grant for an information kiosk in the department's lobby for citizens to file an online report. The office staff is available to assist citizens with the process. The Police Department does not want to discourage anyone from filing a traditional police report or deter anyone from having an officer respond to their home or business. Online reports were established to simplify the reporting process and to provide our citizens an additional reporting option.

## MOTOR VEHICLE THEFT PREVENTION

As colder weather approaches, police departments across the country see large increases in motor vehicle thefts. The morning frost on a car window creates an easy opportunity for car thieves when a car is left running and unlocked/unattended. While it is important to have your car windows clean of frost for safe driving, please follow these steps.

## 1. LOCK YOUR DOORS

Keeping your doors locked is the first step in deterring a thief. So, it's good to get into the habit of checking your car doors.

## 2. REMOVE YOUR KEYS FROM THE VEHICLE

Never leave your keys in the ignition, says the National Insurance Crime Bureau (NICB). If your key is in the car, a thief can simply break a window and drive off. Firestone also cautions against leaving your car running, even if you're just going into a store for a quick errand. A running vehicle may be an easy mark for a thief, especially if it is unattended or unlocked.

## 3. DO NOT LEAVE A SPARE KEY NEAR YOUR VEHICLE

The National Highway Traffic Safety Administration (NHTSA) recommends taking your keys with you when you leave your car. Some people keep

a spare key under the car or in the glove box, just in case they get locked out — but thieves know where to check for an extra key. While getting locked out of your car is a pain, think about the potential hassle of your car getting stolen.

## 4. CLOSE THE WINDOWS

Keep your windows closed completely, says the NICB. A thief can simply reach into your car through an open window — taking what they can reach or unlocking the door to gain full access to your vehicle and everything in it.

## 5. PARK IN WELL-LIT AREAS

Avoid parking in areas that are poorly lit or places that are not immediately seen by passers-by. We recommend parking under a light and in a well-trafficked area, as thieves may be deterred if they know they can easily be seen.

## 6. INSTALL AN AUDIBLE ALARM SYSTEM AND ANTI-THEFT DEVICE

The NHTSA recommends installing an audible alarm system if your car did not come with one and using a visible anti-theft device. An audible alarm is designed to emit a loud noise, often the car's horn, if someone attempts to enter the vehicle while the alarm is on. The unwanted attention attracted by the noise may chase off a

potential thief. Visible devices, such as a steering wheel lock, window etching, or an alarm system's flashing light, may also be enough to deter a car thief, according to the NHTSA. If they are not sure they can get away with the car quietly or fear they may get caught, they may just avoid your vehicle altogether.

## 7. INSTALL A TRACKING SYSTEM

You may want to consider installing a tracking system, which can also be called a vehicle recovery system. (As with the other alarms, you may need to have a professional install the device.) When your car is stolen, this tracking system will use wireless and/or GPS technology to emit a signal to the police or a monitoring service of your vehicle's location says the NICB. This may help the police recover your vehicle faster.

## 8. DON'T LEAVE VALUABLES IN YOUR CAR

One way to attract a thief is to leave a purse, cell phone, or another high-value item in a highly visible area of your car. It's best to leave anything of value at home, but if you must have something important with you, keep it out of sight. Firestone also recommends putting valuables in the trunk before you get where you need to be, as some

thieves scope parking lots — looking for people who are moving items to their trunk. Once you've left the vehicle, they'll break into the trunk to grab whatever you stashed away.

## 9. BE ALERT

Be aware of your surroundings when you park your car. If you are wary of the safety of your car or see someone loitering around the parking lot, it's best to park somewhere else. Firestone also recommends double-checking that your vehicle's windows and doors are closed before leaving your car unattended.

## WHAT TO DO IF YOUR CAR IS STOLEN

If your car is stolen, contact the police immediately. The NHTSA says you may need to provide the following information to the police:

- The year, make, model, and color of the car
- License plate number
- Vehicle Identification Number (also called the "VIN")

You'll also want to let your insurance company know within 24 hours if your vehicle has been stolen, says the NHTSA.

Thankfully, taking a few simple precautions may help you reduce the chances of your car being stolen.

## FIREFIGHTER OF THE YEAR: Lieutenant Ryan Winkler



The Clinton Legion June VanMeter Post 190 would like to announce Lieutenant Ryan Winkler has been chosen as the Firefighter of Year for the City of Clinton. He started his career with the Clinton Fire Department on November 23, 2009. He quickly climbed to the rank of Lieutenant through

hard work, training and dedication to his profession. Lt Winkler brings a positive attitude and a strong work ethic every day to the Clinton Fire Department. He seeks outside training to enhance his firefighting knowledge and leadership skills.

Lieutenant Winkler has an Associate's Degree in Fire Science from Kirkwood Community College. He is a National Registered Paramedic, Iowa certified Firefighter I and II, Fire Instructor I and a Fire Officer I and II. Ryan has taught Emergency Medical Technician courses for Clinton Community College. High angle rope rescue and confined space training is one of his main specialties, and he does an outstanding job teaching these skills to others.

On December 14, 2018, Lieutenant Winkler put his excellent critical thinking skills to use when he and his crew were dispatched to a

medical call at the local YMCA for an intoxicated male. While responding the caller notified Law Center the individual had left, and he would not be found there. They arrived on scene and met with another resident who showed the crew to the caller's apartment. The other resident said he checked it already and the patient was not there. Lieutenant Winkler then entered the apartment, turned on the lights, and noticed the patient was attempting suicide by hanging. He then placed his arms around the victim, lifted him up to take the stress off of his neck and called for the crew to hurry and assist. They were there within seconds and were able to cut the belt, and the patient was lowered to the ground and resuscitation efforts were started. Within minutes more help arrived, and the patient regained consciousness and was transported to the local hospital.

tal. If it was not for the determination of Lieutenant Winkler and his crew, the victim would have not survived.

Lieutenant Winkler again showed his bravery on May 23, 2019 while being dispatched to a house fire with a possible occupant trapped inside. Arriving on scene the crews found heavy flames coming from the front of the residence. Lieutenant Winkler and his crew were directed by the Clinton Police Department to a window where the resident was possibly spotted. They could not locate anyone in the window and moved to the next window. Nothing could be seen in that window either, so they returned to the initial window. He then saw the resident laying on the floor unresponsive. Firefighter Alex Sellnau helped Lieutenant Winkler into the window, who then assisted Firefighter Sellnau into the window. They were able to lift the resident up and

out of the window to additional crew members outside. The patient was revived and transported to the local hospital. He was then transferred to the University of Iowa hospital where he survived his injuries.

Ryan participates in many events in his home community of Charlotte, Iowa. Ryan and his wife Calie sponsor a fund raising car drive for the community's fireworks celebration. They operate several small businesses including the Charlotte Car Wash and 136 Custom Harvesting Company. He volunteers with the Charlotte Volunteer Fire Department and serves as their training officer. Ryan responds with the Charlotte area medical first responders group providing initial first aid for the community. The Clinton Legion June VanMeter Post 190 and the Clinton Fire Department are very proud of Lt. Winkler's accomplishments.

## Employee Spotlight: Rich Foley



Congratulations to Rich Foley for successfully completing the written examination administered by the International Code Council (ICC) for the Property Maintenance and Housing Inspector Certification. The ICC is dedicated to developing model codes and

standards used in the design, building, and compliance process to construct safe, sustainable, and resilient structures in the built environment. The City adopted the International Property Code in July of 2020, in an effort to protect our buildings and the people inside of them.

Rich is a native of the Clinton area – graduating from Clinton High School in 1986. A devoted family man, Rich and his wife Chris have three children who remain in close proximity to the area.

Rich began his career with the City of Clinton in January of 1993 when he was hired as a police officer and entered the Iowa Law Enforcement Academy. He had a long career in law enforcement with the city, serving and

establishing programs such as the School Resource Officer (SRO) program in 1995, serving on the Internet Crimes Against Children Task Force, and rounding out his career in law enforcement as a Corporal in the Administrative Services Supervisor position.

In May of 2015 Rich was thinking about retirement, but not quite ready to retire, so he applied for the Rental Inspector/Code Enforcement position that was open in the Building & Neighborhood Services Department. He has served the residents of Clinton in this capacity for the past 6 years and looks forward to continuing his education to keep up with the Property Maintenance and Housing Inspector Certification. While the certification

is not a requirement of the position, it certainly brings credibility and validity to the department.

When asked what is the most rewarding thing about working in his current capacity, Rich stated that he enjoys working with tenants and property owners to provide healthy and safe housing. Similarly, the most challenging aspects of the job are addressing safety issues with property owners without having to relocate a tenant. Displacement of the tenant is never the goal of the department.

When not at work, Rich enjoys woodworking. He has made dozens of gifts for family and friends that include benches, picnic tables, beds, and even grandfather clocks. In addition to

gifts, Rich has also generously given of his time and talents by making beds for people who have been the victims of fire or other elements of a loss exposure.

What most people don't know about Rich is that he has excellent taste in music, being an avid collector with over 10,000 digital downloads ranging from classical music to rap. And while Rich sometimes is not always popular with Clinton's landlords – Clinton is a much safer place because of all of his hard work!

## CANDIDATE PHYSICAL ABILITY TEST (CPAT)

The Clinton Fire Department is now using Candidate Physical Ability Test (CPAT) for its entry level physical ability testing. The CPAT is a nationwide physical fitness assessment tool developed by the Fire Service Joint Labor Management Wellness-Fitness Initiative including the International Association of Fire Chiefs and the International Association of Firefighters. The CPAT was developed to allow a fire department to fairly obtain a diverse pool of candidates who are physically capable of performing the tasks required to be a firefighter.

The CPAT consists of eight separate events. This test is a sequence of events that requires the candidate to progress along a predetermined path from event to event in a continuous manner. This is a pass/fail test based on a maximum total time of 10 minutes and 20 seconds. The CPAT includes eight sequential events as follows: Stair Climb, Hose Drag, Equipment Carry, Ladder Raise and Extension, Forcible Entry, Search, Rescue and Ceiling Breach and Pull.

All candidates must receive "hands-on" familiarity

with the test apparatus and receive guidance on specific conditioning regiments and techniques to help them prepare for the test. Each candidate shall also be provided an opportunity to perform practice runs of the CPAT prior to the final test. The goal of the Clinton Fire Department in adopting the CPAT is to recruit a diverse and physically fit candidate for their firefighting positions. 

## WHAT HAPPENS IF THE LEVEE FAILS

Thanks to our amazing levee system, few people in Clinton still realize the potential for a catastrophic flood is real throughout many areas of town. There is a vast area of Clinton that would be prone to yearly flooding were it not for the magnificent levee system constructed by our forefathers after the persistent flooding incurred in the 1960's and 1970's.

Our levee is an urban flood protection project which was authorized by the United States government in 1962. The levee was completed between 1979 and 1983 in various stages along the right descending bank of the Mississippi River approximately between River Miles 514 and 521.4, or between Mill Creek at the south end and Turtle Creek at the north end. We are responsible for operating and maintaining the levee and the local flood protection system. This means regularly inspecting its integrity, patrolling the length of it to ensure no weak spots present themselves and closing the flood gates as river levels and the Army Corp dictate.

The Clinton levee was designed by the US Army Corps of Engineers to protect the city of Clinton from the 200-year frequency flood of the Mississippi River, which corresponds to a probability of exceedance of 0.5% in

any given year (similarly a 100-year flood has a 1% chance of occurring each year, and a 50-year flood has a 2% chance of occurring each year). The entire levee was designed with 3-4 feet of freeboard, with the purpose of safe guarding against levee breach/break scenarios or other unforeseen circumstances. Even still, a levee failure or breach is still possible, and may occur someday.

## River Stages

The local river stage used in the City of Clinton comes from the USGS river gauge which is located in the Mississippi River near Camanche, and real time river stage levels are found on the National Weather Service website at [www.weather.weather.gov](http://www.weather.weather.gov)

The river stage zero reading for this gauge is set at 562.68' above mean sea level using the 1929 datum (USCGS 5th General Adjustment). Therefore, for example, when the local river stage is reported to be 17.00 feet, the elevation of the river at Camanche is 579.68' above mean sea level using the 1929 datum. Since the river does have a slope of approximately 6" per mile depending on flows, the actual river elevation in Clinton will vary depending on location.


To put river flooding into perspective in reference to our community, different river

stages in Clinton will correspond to various local flood events, as listed below:

- Stage 17.8' – Local Flood Stage is report by National Weather Service, marina flood gates are in
- Stage 19.0' – Flood water begins to affect the Candlelight restaurant and other marina facilities
- Stage 21.0' – Flood water begins to affect properties at 2600 block of Garfield Street
- Stage 23.0' – Flood water begins to affect properties east of Garfield Street and north of 27th Avenue North along the Clinton riverfront.
- Stage 24.0' – Flood water begins to affect properties abutting Mill Creek in the commercial district including Kohl's, hotels, and Nestle Purina
- Stage 29.0' – Mississippi River is close to the top of the levee in some locations. At this point, we are worried about levee breach or overtopping at low points in the levee.

## Flood Evacuation Routes

In accordance with our flood hazard mitigation plan, the following "Flood Evacuation Routes" have been established within



our community, in case of levee failure or breach.

The map below indicates routes that should be taken to ensure the quickest possible evacuation. The US Army Corps of Engineers is working with local Emergency Management Staff to place signage along these routes.

## PAVEMENT MANAGEMENT PROGRAM UPDATE (2022)

The City of Clinton is responsible for the maintenance of 145 miles of streets. Of these streets, 14 are aggregate roadways maintained by the County under the authority of a 28E agreement. The rest of these streets are a broad range of 126 miles of concrete, asphalt, chip seal, and 5 miles of aggregate roadways some of which have never been improved. This leaves approximately 126 miles of streets for the City to maintain as part of the pavement management program.

Over the past several years, the City of Clinton Engineering Department has been using DTIMS asset management software to track citywide pavement condition index (City PCI). This information has been used to prioritize the street rehabilitation schedule and budget for street construction from 2012 to 2021. The plan includes budgetary cost estimates based on expected quantities, known ADA accessibility issues, and contingency factors. Below is a chart of actual changes in the Citywide Pavement Condition Index from 2007 to 2020. Our expectation is that the 2021 data will prove that the City PCI is approaching 65, which was the stated goal of the Strategic Plan.

We can also use DTIMs to predict



future road network deterioration based on pavement condition history and construction records. Despite all of the recent spending on street projects, the need for consistent funding from 2022 on is evident. The next chart displays what would be the result of a "Do Nothing" approach to street paving beginning this year. Obviously, our PCI would deteriorate, and in 5 years we would be back to pre-2013 levels.

Instead of a "Do Nothing" approach, the City should focus on a preventative maintenance plan, with the goal of maintaining streets rather than letting them deteriorate and repairing them. There will be some necessary reconstructions, but the bulk of the projects will be resurfacing and preventative maintenance strategies.

The recommendation is for \$3.0 million per year in order to maintain a City PCI of 65 into the future. Below is a future estimated PCI chart based on this recommendation. This chart was produced using DTIMS pavement management software. Our



actual recommendation is slightly different than this, but this \$3.0 million per year is the basis of our recommendation.

Our stated goal as part of the Strategic Plan was to maintain a PCI level of 65. As shown on the chart above, this is now possible.

## THE TEN-YEAR PLAN

The ten-year plan is necessary in order to strategically plan for the future of the city. Thus, we have taken a deeper dive into the pavement management plan in order to provide a crucial piece to the puzzle. Below is the funding recommendation chart for the Pavement Management Program for the next ten years.



## Building &amp; Neighborhood Services - Our Mission

"To protect the health, safety, and welfare of the community through excellence in customer service, code administration, education, and enforcement."

Building codes are minimum requirements that help safeguard the health, safety, and welfare of all building occupants. Building codes govern the design, construction, remodeling, and maintenance of structures. Ensuring fire safety is the primary focus of building codes, including but not limited to: keeping the structure from catching on fire, stopping a fire from spreading in a structure or to another structure, and allowing safe evacuation of building occupants from a burning structure. Building codes also include guidance on all the common parts of a building, including the structure itself, as well as plumbing, electrical, and mechanical systems. All structures within our community, including homes, multi-family buildings, commercial, industrial, and institutional buildings, must conform to the rules stated in the adopted building codes. In order to ensure that buildings conform to the rules of the adopted building codes, our office will issue a building permit, and then we'll stop by for an inspection. It's through these inspections where we fulfill our mission, by ensuring that the work being done is up to code (code administration). If the work being done does not meet code, then the proper corrections are made in order to ensure that it does (enforcement and education). Lastly, when the work being done meets code, we are able to ensure the building is safe, and the customer has gotten what they paid for (protecting the health, safety, and welfare of the community), all of which is excellent customer service!

## IS THERE MOLD IN YOUR HOME!

Why is mold growing in my home? Molds are part of the natural environment. Outdoors, molds play a part in nature by breaking down dead organic matter such as fallen leaves and dead trees, but indoors, mold growth should be avoided. Molds reproduce by means of tiny spores; the spores are invisible to the naked eye and float through outdoor and indoor air. Mold may begin growing indoors when mold spores land on surfaces that are wet. There are many types of mold, and none of them will grow without water or moisture.

Can mold cause health problems? Mold can cause an allergic reaction in some individuals. About 50% of the population of the United States is allergic to mold. If you are NOT allergic to mold, it is unlikely that you will have health effects from mold exposure. If you are allergic to mold, your reaction depends on how sensitive you are to mold. Symptoms of an allergic reaction are

1. Itchy or watery eyes, runny nose.
2. Sinus drainage.
3. Respiratory discomfort, and
4. Cough.

How do I get rid of mold? It is impossible to get rid of all mold and mold spores indoors; some mold spores will be found floating through the air and in-house dust. The mold spores will not grow if moisture is not present. Indoor mold growth can and should be prevented or controlled by controlling moisture indoors. If there is mold growth in your home, you must clean up the mold and fix the water problem. If you clean up the mold, but don't fix the water problem, then, most likely, the mold problem will come back. Below are steps you can take to help eliminate mold;

1. Fix the source of the water problem or leak to prevent mold growth.

2. Reduce indoor humidity (to 30-60%) to decrease mold growth by:

Venting bathrooms, dryers and other moisture-generating sources to the outside

Using air conditioners and de-humidifiers

Increasing ventilation

Using exhaust fans whenever cooking, dish-washing and cleaning

3. Clean and dry any damp or wet building materials and furnishings within 24-48 hours to prevent mold growth.

4. Clean mold off hard surfaces with water and detergent, and dry completely.

5. Prevent condensation: Reduce the potential for condensation on cold surfaces (i.e., windows, piping, exterior walls, roof, or floors) by adding insulation.

6. Fix plumbing leaks and other water problems as soon as possible. Dry all items completely.

7. Absorbent or porous materials, such as ceiling tiles, carpet, toys, stuffed animals, bedding, and books, may have to be thrown away if they become moldy. Mold can grow

on or fill in the empty spaces and crevices of porous materials, so the mold may be difficult or impossible to remove completely.

8. If you are unsure about how to clean an item, or if the item is expensive, or of sentimental value, you may wish to consult a specialist.

9. Bathroom Tips: Places that are often or always damp can be hard to maintain completely free of mold. If there's some mold in the shower or elsewhere in the bathroom that seems to reappear, increasing ventilation (running a fan or opening a window) and cleaning more frequently will usually prevent mold from recurring, or at least keep the mold to a minimum.

Should I test my house or apartment for mold? No, the Iowa Department of Public Health does NOT recommend testing for mold for several reasons:

1. Mold is present at same level in outdoor air throughout the year so testing may be unreliable.

2. It is very difficult, even for professionals, to get meaningful test results.

3. Mold testing can be very costly.

4. There are no regulatory levels or guidelines for comparing testing results.

Who should do the cleanup? Who should do the cleanup depends on a number of factors; one consideration is the size of the mold problem. If the moldy area is less than about 10 square feet (less than roughly a 3 ft. by 3 ft. patch), in most cases, you can handle the job yourself, following the guidelines below. However:

1. If there has been a lot of water damage, and/or mold growth covers more than 10 square feet, consult a professional restoration or mold removal company.

2. If you already have a mold problem ACT QUICKLY. Mold damages what it

grows on. The longer it grows, the more damage it can cause. Leaky window – mold is beginning to rot the wooden frame and windowsill.

3. If you choose to hire a contractor (or other professional service provider) to do the cleanup, make sure the contractor has experience cleaning up mold. Check references!

If you are dealing with mold issues and your property is a rental, communicate concerns to your landlord and assist in creating a plan to eliminate mold growth. If repairs are required, please allow the property owner time to schedule and make required repairs. If your mold problem is created by a lack of maintenance, water leaks, deteriorated walls or window sills, lack of weatherization, and repairs are not taking place, please contact Building & Neighborhood Services at (563) 244-3360 for assistance. Mold growth not created by a lack of maintenance, like mold on shower or bathing surfaces, is not a rental violation and must be removed by the tenant and/or property owner.

## FRONT YARD REQUIREMENTS

Front yard is defined as a yard extending across the full width of the area from the front line of the building to the front property line of the lot. On corner lots, the front yard shall be provided on each street. This means corner lots have TWO front yards. Lots in the middle of a block, with a street in the front and rear are considered to have front yards on both streets.

Things you can or can't do in a front yard:

Accessory buildings (detached garages or sheds) – These require rear or side yard placement

Fences – In a front yard, 4' chain link or wrought iron are allowed within property lines. Privacy fences are for rear of side yards. Corner lots have two front yards, so these can be trickier for privacy fences.

Pools – Pools are to be located in rear or side yards only. No exceptions.

Residential Parking – Off-street parking within

a front yard is prohibited unless located on a hard-surfaced driveway. Temporary front yard parking for the purpose of delivery of appliances or furniture, use of moving vans or trucks, or other special circumstances is allowed.

Driveways – Hard-surface driveways only in front yards. No new gravel driveways or gravel parking pads in front yards.

Decks – Can have an open (uncovered) deck, up to 36" tall in front yard. Can encroach into front yard setback by 15', but must be at least 10' off of front property line. Deck must remain uncovered.

Solid Waste Containments – Solid waste, yard waste, and recyclable waste are to be set out one day a week, and then stored in rear or side yard. They are not to remain in front yards.

Hope this helps clear any confusion up about what is and what is not allowed in front yards.

## DO I HAVE BEDBUGS?

A common complaint we receive is my apartment or house has bedbugs. Once thought to be largely eliminated in the United States, bedbugs have again become a problem. Bedbugs easily travel from one location to another and spread rapidly in connected living spaces such as apartment buildings. Often by the time an individual has discovered visible evidence of bedbugs, the infestation has become widespread. It is a common myth that bedbug infestations arise from unsanitary living conditions. While excess clutter can provide bedbugs with more opportunities to hide, bedbugs can be found almost anywhere.

## Signs you may have bedbugs

1. Bedbugs, including their eggs, are visible to the naked eye. However, because bedbugs are only about the width of a credit card, they can slide into very small places.

2. Bedbugs shed their skin, so you may see "bug shells" in your home.

3. You may have small blood stains on your sheets or pillows.

4. Bedbug bites generally look similar to other insect bites, though they may be lined up in "row" of bites. Common areas for bites are the arms, hands, face and neck.

5. Small reddish or brownish spots on linens are often the first sign of an infestation. These spots are the bedbug's droppings and may bleed on the fabric like a marker would.

## Preventing and Getting Rid of Bedbugs

## From the Environmental Protection Agency

Bedbugs feed on your blood and cause itchy bites. Adult bedbugs are brown, 1/4 to 3/8 inches long, and have a flat, oval-shaped body. Young bedbugs (called nymphs) are smaller and lighter in color.

Bedbugs hide in a variety of places around the bed. They might also hide in other places, such as in the seams of chairs and couches, between cushions, and in the folds of curtains. They come out to feed on blood about every five to ten days, but they can survive over a year without feeding.

## To prevent bedbugs in your home:

1. Check secondhand furniture for any signs of bedbugs before bringing it home.

2. Use a protective cover that encases mattresses and box springs. Check it regularly for holes.

3. Reduce clutter in your home so they have fewer places to hide.

4. Unpack directly into your washing machine after a trip and check your luggage carefully. When staying in hotels, put your suitcases on luggage racks instead of the floor. Check the mattress and headboard for signs of bedbugs.

## To get rid of bedbugs:

1. Wash and dry bedding and clothing at high temperatures.

2. Use mattress, box spring, and pillow encasements to trap bedbugs and help detect infestations.

3. Use pesticides if needed.

The good news? Unlike some other pests, bedbugs don't transmit and spread diseases.

## Top Ten Bedbugs Tips from the Environmental Protection Agency

1. Make sure you really have bedbugs, not fleas or ticks or other insects. If you suspect you have bedbugs, contact a professional infestation company to complete an inspection to confirm the infestation you have are indeed bedbugs.

2. Don't panic! Eliminating bedbugs is difficult, but it's not impossible. Don't throw out all of your things because most of them can be treated and saved. Throwing stuff out is expensive, may spread the bedbugs and could cause more stress.

3. Think through your treatment options -- Don't immediately reach for the spray can. Be comprehensive in your approach. Try other things first. Integrated pest management (IPM) techniques may reduce the number

of bedbugs and limit your contact with pesticides. If pesticides are needed, always follow label directions or hire a professional.

## 4. Reduce the number of hiding places

-- Clean up the clutter. A cluttered home provides more places for bedbugs to hide and makes locating and treating them harder. If bedbugs are in your mattress, using special bedbug covers (encasements) on your mattress and box springs makes it harder for bedbugs to get to you while you sleep. Leave the encasements on for a year. Be sure to buy a product that has been tested for bedbugs and is strong enough to last for the full year without tearing.

## 5. Regularly wash and heat-dry your bed sheets, blankets, bedspreads and any clothing that touches the floor.

This reduces the number of bedbugs. Bedbugs and their eggs can hide in laundry containers/hampers, so clean them when you do the laundry.

## 6. Don't rely on do-it-yourself freezing as a reliable method for bedbug control.

While freezing can kill bedbugs, temperatures must remain very low for a long time. Home freezers are usually not cold enough to kill bedbugs. Putting things outside in freezing temperatures can kill bedbugs, but it can take several days when the temperature is 0°F and almost a week when the temperature is 20°F.

## 7. Use heat to kill bedbugs, but be very careful.

Raising the indoor temperature with the thermostat or space heaters won't do the job. Special equipment and very high temperatures are necessary for successful heat treatment. Black plastic bags in the sun might work to kill bedbugs in luggage or small items, if the contents become hot enough (about 110°F for at least 3 hours).

## 8. Don't pass your bedbugs on to others.

Bedbugs are good hitchhikers. If you throw out a mattress or furniture that has bedbugs in it, you should slash or in some way destroy it so that no one else takes it and gets bedbugs.

## 9. Reduce the number of bedbugs to reduce bites.

10. Thorough vacuuming can get rid of some of your bedbugs. Carefully vacuum rugs, floors, upholstered furniture, bed frames, under beds, around bed legs, and all cracks and crevices around the room. Change the bag after each use so the bedbugs can't escape. Place the used bag in a tightly sealed plastic bag and in an outside garbage bin.

11. Turn to the professionals, if needed. Hiring an experienced, responsible pest control professional can increase your chance of success in getting rid of bedbugs. If you hire an expert, be sure it's a company with a good reputation and request that it use an IPM approach. Contact your state pesticide agency for guidance about hiring professional pest control companies. Also, EPA's Citizen's Guide to Pest Control and Pesticide Safety provides information about IPM approaches, how to choose a pest control company, safe handling of pesticides, and emergency information.

I think I may have bedbugs. What should I do?

1. If you live in a rental, notify your landlord. Depending on the circumstances, the property owner may be responsible for the elimination of all infestations.

City of Clinton Iowa, Code of Ordinances Chapter 155.19 (L) states "Every owner of a dwelling containing two or more dwelling units shall be responsible for the extermination of insects, rodents or other pests on the premises. Whenever infestation exists in two or more of the dwelling units in any dwelling, or in the shared or public parts of any dwelling containing two or more dwelling units, extermination thereof shall be the responsibility of the owner."

2. Contact a professional exterminator. Throwing away furniture and using spray or powders purchased at the local store will not eliminate bedbugs.

3. Cooperate with extermination efforts.

4. Reach out to Building & Neighborhood Services with any questions or concerns.

## SMOKE ALARMS

Every year in the United States, over 3,000 people lose their lives in residential fires. Most fire victims die from inhalation of smoke and toxic gases. Most fatal fires occur at night while the victims are asleep.

Along with carbon monoxide detectors and a well-rehearsed fire escape plan, properly installed and maintained smoke alarms in your home can cut your odds of dying in a fire by half or more.

Here are some guidelines on where to locate smoke alarms:

- Install smoke alarms in every sleeping room and in the hallway outside each sleeping room.
- Place at least one smoke alarm on every level of your home.
- Locate the smoke alarm on the room's flat ceiling or on the wall within 12" of the ceiling.
- Avoid placing alarms near the top of peaked ceilings or near air vents; these locations can reduce their effectiveness.

Recent years have seen improve-

ments in smoke alarm technology. Following are several considerations when purchasing a new model:

- Use interconnected smoke alarms (wired or wireless) to provide the earliest possible warning that a fire is occurring.
- "Dual sensor" smoke alarms detect both smoldering and flaming fires, ensuring the most comprehensive coverage.
- Models that are hardwired to your home's electrical power and have battery back-up will provide the best guarantee of being fully-powered when you need them most.
- Many newer models are supplied with long-life batteries which require less frequent replacement or ten-year models with no battery replacement needed.

Once installed, follow these steps to ensure reliability from your device:

- Replace your smoke alarm's

battery at least every year, unless its instruction manual states otherwise. The beginning or end of daylight savings time is an ideal time. Certain new models come pre-packaged with lithium batteries rated for ten years of life.



- Press your alarm's test button once a month to make sure it sounds properly. Please know that this only tests the alarm's ability to make noise — the test button does not test its ability to detect smoke.
- Replace your smoke alarm regularly, at the time specified in the instruction manual.
- If a smoke alarm is producing frequent nuisance alarms, do not disable it! Instead, clean it according to the instruction manual, or consider using a different type of alarm (photoelectric) that will be less sensitive.
- At the same time, you replace your smoke alarm batteries, replace the batteries in your Carbon Monoxide (CO) alarm.

Building & Neighborhood Services urges families to develop and rehearse an escape plan so that when the smoke alarm sounds, family members can immediately move to a safe location outside the home.

We recommend the following emergency escape practices:

- Develop a home fire escape plan.
- Practice the plan at least twice a year with the entire household.
- Practice the fire escape plan with your children, babysitter, and older family members.
- During practice, identify and remove obstacles that may prevent a quick and safe evacuation, such as clutter, blocked doors or stuck windows.
- Because children may not awaken to the sound of a smoke alarm, parents should hold a nighttime fire drill to assess their children's ability to

respond and evacuate.

Don't wait for a fire in your home to test your smoke alarm and develop a fire escape plan --- DO IT NOW!

## RABIES EXPOSURE MANAGEMENT FOR BAT-RELATED INCIDENTS

Wild animals (especially bats) may carry rabies, and you can be infected if you are exposed to a rabid animal's saliva. If you see a bat in your house and cannot say, "I know I was not bitten," you may have been exposed to rabies, especially if you woke up with it in your room or if it was in a child's room.

Bats' teeth are small and produce such sharp, needle-like bites that may not be immediately noticeable.

Rabies is deadly if not addressed immediately after exposure. Wash any wound and seek medical care immediately. The incubation period can vary from 5 days to 2 years,

and once symptoms start, there is no curative treatment. Death follows within one or two weeks of symptom onset.

It is important to safely capture the bat if there is uncertainty of a potential bite. The animal must be euthanized by a veterinarian so as

not to damage the brain tissue that will be tested for rabies. The IDPH provides consultation to help health care providers, veterinarians, and the public to determine whether a potential exposure occurred. Rabies exposure consultation can be obtained from the Center for Acute Disease Epidemiology.

## RESTAURANT REMINDER

Early last spring the City passed an ordinance requiring restaurants to install grease interceptors no later than June 30, 2020. Letters were sent out to all known Food Service Establishments to notify them of the change. The City also offered an incentive at the time to pay 50% of the installation cost up to \$1500. Ten Food Service Establishments took advantage of the program. Some restaurants have already been inspected this year and notified in person of the upcoming change. The intent of this ordinance is to keep as much oil & grease out of the sewers to avoid sewer blockages and to reduce the maintenance costs which will help keep the sewer rates down.

A lot of restaurants believe if they do not use a deep fryer that they do not have a grease issue. The truth of the matter is most of the Fats , Oil, and Grease come from doing dishes. There are "Best Management Practices" that can be implemented to reduce the amount of FOG going into your interceptor reducing the amount of times it will need to be emptied.

In this article we have included a copy of the installation and maintenance requirements of the updated "FOG" ordinance.

## \$ 52.038 INSTALLATION AND MAINTENANCE REQUIREMENTS.

## (A) Installations.

(1) All establishments subject to this chapter shall have a grease interceptor installed and in fully operational condition no later than June 30, 2020. Any establishment that demonstrates timely compliance with this section shall be entitled to a one-time rebate of 50% of the total cost of installation of the grease interceptor, with the maximum rebate payment not to exceed \$1,500. This rebate would only be available to businesses that have installed a compliant grease interceptor between July 1, 2018 and June 30, 2019. No rebates issued pursuant to this section shall be approved or issued for grease interceptors installed after June 30, 2019. However, if an establishment begins installation of a compliant interceptor before June 30, 2019, a rebate shall be approved if the installation of such interceptor is completed within 30 days of commencement of installation, even if such installation is not complete until after June 30, 2019.

(2) New facilities. Food processing or food service facilities which are newly proposed or constructed, or existing facilities which will be expanded or renovated to include a food service facility, where such facility did not previously exist, shall be required to design, install, operate and maintain a grease interceptor in accordance with locally adopted plumbing codes or other applicable ordinances. Grease interceptors shall be installed and inspected prior to issuance of a certificate of occupancy.

(3) Existing facilities. Existing grease interceptors must be operated and maintained in accordance with the manufacturer's recommendations and in accordance with these Model Stan-

dards, unless specified in writing and approved by the POTW.

(4) All grease interceptor waste shall be properly disposed of at a facility in accordance with federal, state, or local regulation.

## (B) Cleaning and maintenance.

(1) Grease interceptors shall be maintained in an efficient operating condition at all times.

(2) Each grease interceptor when cleaned shall be fully evacuated.

(b) Name, signature, address, and phone number of the person who generated the waste and the date collected;

(c) Type and amount(s) of waste collected or transported;

(d) Name and signature(s) of responsible person(s) collecting, transporting, and depositing the waste;

(e) Date and place where the waste was deposited;

(f) Identification (permit or site registration number, location, and operator) of the facility where the waste was deposited;

(g) Name and signature of facility on-site representative acknowledging receipt of the waste and the amount of waste received;

(h) The volume of the grease waste received; and

## 2022

In 2022 (FY 2023), we plan to focus on the bulk of asphalt streets that have not been rehabbed over the last 20 years, along with collector street resurfacing and concrete patching on the very worst of the concrete streets in town, most of these with a PCI of less than 30. We currently project this expenditure at \$3.6 million. The reason for this inflated number is the backlog of projects from the last two years that still must be finished within a reasonable schedule to avoid undesirable PCI. Below is the construction program for 2022.

## 2023

Beginning in 2023 (FY 2024), we will use the DTIMS program almost exclusively for pavement rehab recommendations. During 2023-2025, we are proposing to scale the program back a bit, as we focus on some of the side streets as part of the Manufacturing Drive Project, and re-pave a few streets using grant funds for sewer projects. Thus, the average recommended funding amount for these three years is only \$2.3 million.

We have manually edited some of the DTIMS recommendations to account for this change. Below is construction program for 2023.

## 2024-2025

2024 will be a light year for construction, with the bulk of the funds being spent on a full reconstruction of Springdale Drive. This road was resurfaced in 2011, but the cold Iowa winters have wreaked havoc on the sub-base below the street. This road was manually inserted into the DTIMS construction plan, as there is no way to maintain the street in its current condition. 2025 is the smallest yearly expense in the Pavement Management Program at \$2.0 million.

Most of the projects from 2027-2031 will be of the preservation variety. We are planning for \$1.5 million in preservation projects (micro-surfacing, thin overlays, etc.), and \$1.5 million in standard reconstruction or resurfacing projects. Further, many of the reconstruction projects will be constructed as part of a sewer separation project.

Once we have the actual PCI data for 2021, we will work to provide the council and citizens with project level recommendations for the construction years 2027-2031. We anticipate this by October of 2022.

AMERICAN RESCUE PLAN MONEY IS AVAILABLE  
TO HELP PAY YOUR SEWER UTILITY BILL

The Iowa Department of Human Rights/Division of Community Action Agencies (DCAA) has announced the publication of the Low-Income Household Water Assistance Program (LIHWAP) State Plan.

The Low-Income Household Water Assistance Program has been established to provide assistance to qualifying low-income customers in Iowa by paying arrearages to drinking water/wastewater utilities in order to reconnect and/or ensure uninterrupted water service.

The Iowa Department of Human

Rights, Division of Community Action Agencies (DCAA) administers Iowa's LIHWAP program and is authorized by Iowa law to contract and distribute Iowa's LIHWAP program funds to Iowa's community action agencies.

Please contact Community Action of Eastern Iowa for more details, and to see if you qualify for funding. This program is available to renters and homeowners.

In addition to the LIHWAP program, the Iowa Finance Authority is administering \$195 million in rent and utility assistance through the Federal Emergen-

cy Rental Assistance Program. This program may provide eligible residents with assistance for a period of up to twelve months. Covered expenses include sewer utility and trash removal. ## BUS PASSENGER SAFETY

The Clinton Municipal Transit Administration provides thousands of safe rides a year to the citizens of Clinton. Our passengers range from an infant with their parent, to a k-12 student, college student, adult, senior or an eligible para transit rider. MTA drivers provide

the safest ride they can, but can not control the traffic when a passenger gets off the bus.

As passengers get off the city bus, they should wait at the corner until the bus leaves the area. This provides the passenger with a clear view to look

The City of Clinton Public Works Departments strive to maintain the safety and health of our community in all our endeavors. Public Works consists of the following 4 departments:

The Streets Department's **6** employees have several responsibilities within the city's right-of-ways. Some of these responsibilities include: pothole repairs; putting up and replacing street signage; street sweeping; snow & ice removal on city streets; alley grading; right-of-way mowing and weed spraying; and removing fallen trees, branches, and debris within the roadway.

The Solid Waste Department's **6** employees are responsible for the collection of the city-owned garbage, yard waste and recycling carts. Yard Waste begins the first full week of April and ends the last week of November. The Solid Waste Department is also responsible for taking the orders for delivery and cancellation of the city-owned carts. The Solid Waste Department also assists with snow removal when a "Snow Emergency" is declared.

The Sewer Maintenance Department's **4** employees maintain the storm and sanitary sewer systems throughout the city. The Sewer Maintenance Department also assists with snow removal when 1 or more inches of snow is forecasted.

The Facilities and Grounds Department's **6** employees maintain city owned property and buildings throughout the city. The Facilities and Grounds Department maintains about 500 acres of park land, multiple miles of recreational trails, many playgrounds, a recreational vehicle park and sports facilities including a minor league professional baseball stadium. The Facilities and Grounds Department also assist with snow removal when 1 or more inches of snow is forecasted.

**As a reminder when driving around town, we ask that you please use caution and slow down when approaching street crews in the roadway. Thank you!**

**By following these two simple rules, you can help save lives, avoid receiving a traffic ticket and prevent the potential loss of your driver's license. Iowa law requires motorists to:**

1. Change lanes or slow down, absent any other direction from a peace officer, when approaching the following vehicles, as provided in (Iowa Code section 321.323A):

- A stationary emergency vehicle that has its flashing lights activated.
- A stationary tow, recovery, maintenance, construction, solid waste or recycling collection vehicle that has its flashing lights activated.
- Any stationary motor vehicle, including a passenger vehicle, that is continually displaying its emergency signal lamps (i.e., standard hazard lights).

2. Yield the right of way to an emergency vehicle displaying flashing lights or giving an audible signal by moving over to the right, stopping and waiting until the vehicle has passed before proceeding. (Iowa Code section 321.324).

sible, when pedestrian and vehicular traffic is at a minimum. Business District snow removal may be performed by contractors. Parking lots will be cleared by the Grounds & Facilities Division.

Because bridges freeze before roadways, they receive early attention.

Intersections are treated as soon as possible with salt and brine in compliance with Priorities 1, 2, & 3. Hills are also plowed, salted & brine applied as soon as possible.

Isolated icy spots reported by the Police Department, MTA, residents or others will be treated as soon as possible. The public is encouraged to help the City by reporting hazardous conditions.

**EQUIPMENT INVENTORY** - The Public Works Department has the following major pieces of equipment for snow removal operations:

- 8 dump trucks – converted to snow plows and salt spreaders as needed.
- 2 end loaders
- 1 snow blower – end loader mounted
- 2 motor patrols (the small grader has very limited snow removal capabilities)
- 1 wing plow for grader
- 1 V-plow
- 2 plows for end loader

One additional dump truck is available from WPC for snow hauling, as needed.

**WINTER PARKING RESTRICTIONS -**

**PARKING RESTRICTIONS DURING SNOW EMERGENCIES:** In the event a snow emergency is declared, parking will not be permitted on any public street or parking area designated as a snow route and posted as such with appropriate signs unless the snow has been removed from the street and parking area and the snow has ceased to fall. Parking on residential streets not marked as a snow route shall follow the calendar parking schedule. Fine for violation is \$25.00 and vehicles parking in violation are subject to impoundment.

These regulations are established by Ordinance No. 79.10 and Chapter 84 Schedule VI.

When predictions or occurrences indicate the need, the City Administrator or authorized representative, shall declare a snow emergency and publicize the same over all radio stations in the City of Clinton, in the Clinton Herald, on the City's Web Site, City's Facebook page and Channel 18 on Mediacom.

Vehicles abandoned during the snow emergency may be ticketed or towed to facilitate snow & ice removal.

**SNOW REMOVAL DISTRICTS** - The City has been divided into six snow plowing districts, including the rural area. A Street Division truck, equipped with a snow plow and salt spreader is assigned to each district. A seventh truck is used to help plow the larger districts and answer emergency calls. Motor patrols are also used to plow snow and end loaders to clean cul-de-sacs, parking lots and other areas.

Agreements have been made with the Iowa DOT, Clinton County and City of Camanche for sharing responsibility for snow & ice control on joint streets.

**SIDEWALK SNOW REMOVAL** - Abutting property owners are responsible for the removal of natural accumulations of snow and ice from the sidewalks. The City has the authority to initiate sidewalk snow removal. If the snow and/or ice remains on the sidewalk for more than 48 hours after the snow stops falling, or after ice forms, the City may remove the snow or ice from the sidewalk. The costs of actual removal, plus a filing fee, will be assessed against the property for collection in the same manner as a property tax.

The property owner is also responsible for removal of snow and ice from private driveways.

The Grounds & Facilities Division will remove snow and ice from sidewalks near City-owned buildings, parks and other city-owned property.

Pedestrians are encouraged to wear winter footwear such as rubber boots and exercise caution when walking on sidewalks with snow and ice accumulations.

**Solid Waste Department Information**

**Upcoming Solid Waste/Recycling Delays:**

**Thanksgiving- Thursday, November 25th**

Thursday – There will be no Garbage/Yard Waste/Recycling collections due to the holiday. Thursday's route will be picked up on Friday, November 26th, and Friday's route will be picked up on Saturday, November 27th.

Solid Waste employees will not get out of their vehicle to pick up trash or empty bins with lids that are not closed. It is important to leave space between the Waste/Recycling/Yard bins in order to allow room for the grab arms to operate safely. Waste/Recycling/Yard waste bins must be a minimum of 3 feet from property such as fences and or vehicles to avoid property damage, drivers will not empty bins that are too close to personal property.

**Large Item Collection**

The City of Clinton **no longer** provides Large Item Collection. For persons needing to dispose of large items, they may be taken directly to the Clinton County Area Solid Waste Agency located at: 4292 220th St. – Clinton, IA 52732. **Sharps Disposal**

The City of Clinton **does not** collect and/or dispose of used sharps, as they pose a potential threat to the Solid Waste workers. However, residents may transport and dispose of sharps collected in an empty laundry soap container, labelled and dropped off free of charge at the Clinton County Area Solid Waste Agency located at: 4292 220th St. – Clinton, IA 52732. **Tarping Loads to the Landfill**

Please be aware that tarps and/or covers are required by City Ordinance on any and all waste being transported to the Clinton County Area Solid Waste Agency (aka the Landfill):

**City Ordinance: § 50.27 Loading**

Vehicles or containers used for the collection and transportation of any solid waste shall be **loaded** and moved in a manner that the contents will not fall, leak or spill therefrom, and shall be **covered** to prevent blowing or loss of material. Where spillage does occur, the material shall be picked up immediately by the collector or transporter and returned to the vehicle or container and the area properly cleaned. (1999 Code, § 106.03) (Iowa Code §§ 321.460 and 805.8A(13)c)

**Solid Waste Collection Program**

**CART INFORMATION**

- All City of Clinton collection carts are the property of the City.
- The City has 3 types of collection carts: Grey – garbage, Green – yard waste, and Blue – recycling.
- Collection carts are assigned to an address, not an individual (family). When ownership of a residence changes, each cart must stay at the address it is assigned to. Residents may cancel services at any time and all appropriate carts will be removed.
- Each resident is responsible for the proper care and security of the collection carts. The resident will be charged for replacing a cart should it become damaged or stolen as the result of improper care and/or not keeping the cart secured on the property.

**COLLECTION INFORMATION**

- All carts must be out by 7:00 am the day of collection.
- Garbage should be bagged in the gray cart.
- Yard waste should be placed loose in the green cart (no bags).
- Recycling should be placed loose in the blue cart (no bags).
- Carts will not be emptied if there is improper or incorrect material in the cart (such as garbage in a yard waste or recycling cart).
- Hot ashes should never be placed in the carts.
- Construction debris is not allowed in any of the carts.
- Toxic or hazardous waste is not allowed in any of the carts. This includes: electronics, pesticides, paint cans with paint, motor oils, sharps containers, flammable material, etc. (Contact the Clinton County Landfill at 563-243-4749 for any questions about acceptable material.)
- The maximum weight limit of the 95-gallon carts is 200 lbs.
- To avoid exceeding the weight limitation of the cart, or causing possible damage to the cart or collection vehicle, do not place rocks, concrete, bricks or dirt inside carts. Any items placed within the cart must fall out easily when the cart is being serviced. Please do not overfill or tightly pack items into the cart.
- Lids must be closed.
- Give adequate space between carts for collection by the automated trucks – 3 feet apart is optimal.
- Carts must be placed for collection away from homes, garages, fences, parked vehicles, utility poles, mailboxes, etc.
- Carts should not be placed higher than 1 foot above the surface that the collection truck is on.
- Carts should not be left at their collection spots past the collection day. Carts should be removed from the street or alley right-of-way and placed in a designated storage area on the resident's property. (This will prevent a possible road hazard, damage to the cart, or theft of the cart.)
- The collection of yard waste carts will stop on Saturday November 27th, 2021. Yard waste pickup will resume the first full week of April, 04/04/22.


