## THE START OF THE NEW YEAR BRINGS HIGHS AND LOWS FOR THE CITY OF CLINTON

The New Year 2019 has already brought the City of Clinton highs and lows. The year started out extremely sad as Clinton grieved the loss of Firefighter Lieutenant Eric Hosette, who died as a result of an accident at ADM, and Clinton Firefighter Adam Cain was seriously injured in the accident. The uplifting of the community through its rallying of support and prayers around both families was overwhelming. Community support was evident by red lights shining, donations overflowing, food continually being provided, and embraces for the family, friends and the City.

As the snow fell on Riverview Drive and the Bandshell, hundreds turned out from the community, along with Firefighters and vehicles, to witness a truly humbling farewell for our hero Lieutenant Eric Hosette. Wind, snow nor chilly temperatures could dampen the occasion, as heartfelt words and prayers warmed us. Addy and her dad's song played and the bagpipes bellowed on in remembrance. Time froze with the weather and it wasn't about issues or concerns of potholes, or solid waste pickup or even taxes, it was about a community, a hero and his family, all the while reinforcing who Clinton really is and what we all stand for. It is the sacrifice of a single human being that reminds us how tender and fragile life can be. In the end it is not about stuff or things, but rather what we each gave to each other and the memory of being a truly good person will be carried with us when we think of Eric each and every day.

Meanwhile, Firefighter Adam Cain was fighting for his life in Iowa City where he had been medevacked on that dismal day - January 5, 2019. Firefighter Cain was battling to overcome fluid on his lungs, a bleeding spleen and liver, broken bones and the realization that he had lost his fellow firefighter who was standing with him on top of the silo. Then three weeks after the accident, Firefighter Adam Cain returned home to a hero's welcome. Foregoing a ride in the ambulance, and passing on a helicopter flight home, Adam opted for the suburban. Again the citizens and Firefighters in the entire region turned out to show their support, reinforcing how much life is really a team sport and in order to conquer and succeed we need each other.

All the while, with Eric and Adam on our minds, the Council moved forward to continue the tremendous effort of improving Clinton each and

every day. Budgets are now balanced and ready for submission to the State of Iowa, along with a Capital Improvement Plan (CIP) that will continue to focus on improving our roads and bridges. The vision the Council has is to move the City forward and continue to have gains for growth economically throughout the City. The motto of "the bitterness of poor city infrastructure remains long after the sweetness of a low levy is forgotten" rings true and currently the City of Clinton is being inched out of the top highest 100 levies in Iowa. This statistic is amazing when the City of Clinton is currently the 19th largest City (but over 90 cities have higher levy rates). It is important to remember that one must think about the entire economy and not solely focus on levy rates. We all understand fixed incomes, but we also understand to begin growing the population and have folks fill the vacant jobs in Clinton, we want these new residents to live in Clinton. This means, as a City, we must continue to enhance the quality of life - from roads and

bridges, to creating quiet zones (reducing the number of horn blows sounded by trains), to improved areas/facilities at the Library, the Parks and Recreation indoor and outdoor amenities, continuing to improve our Riverfront areas with monuments and other attractions, adding more things to do (such as tent camping at Eagle Point Park), and continuing to focus on safety items. All of these items provide things for all ages to be able to work, live and play as we #ChooseClintonIowa.

## Animal Control Issues:

The procedure for removal of small dead animals (i.e., dog, cat, squirrel) in a roadway is to contact the Clinton Police Department non-emergency number at: 563-243-1458 and the Animal Protection Officer, Jaci Mulholland (APO) will assist with removal.

For removal of live, medium sized animals (such as a raccoon), contact: Eric Perry, the "Wildlife Wrangler"

at: 563-559-6989. Eric will capture the animal for the homeowner and release it into the country for a fee.

For large dead animals (such as deer) that are too large for the APO to remove on their own, the Public Works Department may be called upon to assist with removal.

## Burn Rules

From April 1st - May 15th, the City of Clinton will allow open burning for those residents with lots of one acre or larger on Tuesday, Thursday and Saturdays between the hours of: 10 am – 5 pm, weather and wind permitting. Fires must be no closer than 25 feet to a structure or other combustible material. Open

burning is limited to: piles of clean, dry, untreated wood and lumber and landscape waste. The piles should not be burned larger than 3 feet in diameter and 2 feet high.


All fires must be attended by an adult with an extinguishing agent readily available.



## CLINTON POLICE DEPARTMENT

## PARK REGULATION CHANGES

In December, 2018 the Clinton City Council amended Chapter 96 (Park Regulations) to establish more uniform park hours and allow for more strict enforcement of park hours in order to prevent loitering and other criminal activity in city parks after park hours. Changes in hours are **in bold**.

Chapter 96.05 prohibits alcoholic beverages during certain hours.

Eagle Point Park and all other City Parks and City-Owned Property. The possession, use and consumption of alcoholic beverages, including beer and wine, is prohibited in Eagle Point Park and in any other city parks including but not limited to Chancy Park, Clinton Park, Hawthorne Park, DeWitt Park, Four Square Park, Riverview Park, or any and all other city areas delineated as parks by signage or other indicia, Joyce's Island and Willow Island and the land between the islands in the city; and all other City property between the hours of **sunset and 11 a.m.** except as allowed by special permit from the Parks and Recreation Department.

Chapter 96.08 regulates park hours.

Eagle Point Park. No person shall be in Eagle Point Park between the hours of **sunset to 6:30 AM** except as allowed by special permit from the Parks and Recreation Department for use of the Lodge and its parking lot or some other special permit.

All Other City Parks. No person shall be in any other city parks including but not limited to Chancy Park, Clinton Park, Hawthorne Park, Four Square Park, DeWitt Park, Riverview Park, or any and all other city areas delineated as parks by signage or other indicia, between the hours of **11 PM and 5 AM**, except as allowed by special permit from the Parks and Recreation Department.

Riverfront Drive. Riverfront Drive is part and parcel of Riverview Park for purposes of this ordinance. No person shall loiter, gather with others, or physically idle or remain on Riverfront Drive between the hours of 11 PM and 5 AM.

Chapter 96.14(16) regulates the outside use and consumption of alcoholic beverages, including beer and wine, is prohibited in the R/V Park between the hours of **12:00 midnight and 11 a.m.**

## BICYCLE SECURITY

The Clinton Police Department monitors crime trends throughout the year and one constancy is the theft of bicycles. Similar to motor vehicle thefts in Clinton, bike thefts are mostly crimes of opportunity. Keys are routinely left inside vehicles that are stolen and likewise stolen bicycles are rarely locked up. Bikes are stolen from unlocked sheds, garages, front porches and front yards. Very few, if any, bicycles are reported stolen after a lock or security device has been cut off or removed. Usually bikes are ridden by the thief to another area of town, abandoned and recovered by the police department. Our department's Public Service Officer has a system in place to marry up stolen bicycles and recovered bicycles. There are occasions when the thief tries to disguise a stolen bicycle by repainting or altering its appearance. Thankfully these paint jobs are rudimentary and are a red flag for Officers to check if the bike is stolen.

Reporting your bike stolen is the best way to get it back. The department recovers far more stolen bikes than we take reports on. Citizens call to see if their bike has been found but don't know the details like make, model and serial number to ensure we have their particular bike. Registering your bicycle is a proven way to get it returned if it is stolen. The department's bike registry program collects all the information from your bike in order to identify it later even if it has been altered. It's important you know your bike's make, model, serial number, how many gears and accessories in order to identify it later.

Bicycles found or recovered by the police department are logged and stored away. Several times a year the department publishes bicycles as found property in the Clinton Herald. Annually in the Spring unclaimed bikes are turned over to Information Referral to be sold.

Clinton is a great place to ride with the additions of bike lanes and recreational trails. Unfortunately it's important to secure your bike so you can continue to enjoy our city on two wheels.

## CLINTON CURFEW ORDINANCE

In December 2018 the Clinton City Council amended Chapter 134.01 to provide better and more effective enforcement of the City's curfew ordinance by imposing more stringent requirements on parents or legal guardians responsible for minors who violate the Ordinance.

Here is a highlight of the changes:

Unless accompanied by a responsible adult, no minor 17 years of age or under shall be in any public place during the following times:

– Sunday through Thursday 10:30 p.m. through 6:00 a.m. each day

– Friday and Saturday 11:30 p.m. through 6:00 a.m. each day

It is unlawful for any responsible adult to allow a minor to be in any public place in the city within the time periods prohibited by this section unless the minor's presence falls within one of the exceptions.

On the first offense of a curfew violation, the responsible adult shall be notified of the offense. On any subsequent offense, the responsible adult commits a municipal infraction and may be cited for each separate offense.

## 3. Vehicle registration.

Only obtain the recommended documents if it is safe to do so and you are not injured.

**Step 6: Complete accident report:** If the accident requires a police report, over \$1500 damage, the responding police officer will complete a state accident report. Generally the police officer will give each driver a "Drivers exchange report" at the scene. A driver exchange report has basic information about the accident including; location, time, vehicles involved, insurance information, and police department case number. The driver would then be required to take the driver exchange report to their insurance company. A more detailed accident report will be completed by the investigating officer. The detailed report is available for drivers and insurance companies for a small fee.

Hopefully, you will not be involved in a traffic accident; however, if you are involved in a collision, following these steps will assist you during the incident.

## WHAT TO DO AFTER A CAR ACCIDENT

Car accidents are a common event occurring within the City of Clinton Iowa. Car accidents can be a stressful event and raise many questions when a driver is involved in a collision: Am I required to call the police? Should I move my vehicle? Do I need to file a claim? Many of these questions are asked to responding Clinton Police officers. If you are involved in a traffic accident, the police department recommends you take the following actions:

**STEP 1: Check yourself for injuries.** If you are injured or suspect you have an injury, call 911 or ask someone else to do so. If you are seriously injured, try not to move, and wait for emergency personnel.

**STEP 2: Check on the well-being of your passengers.** If you are not to hurt to move, check on the passengers of your car. If anyone else is injured, contact emergency services or ask bystanders to call for help.

**STEP 3: Get to safety.** If you are able to, move to the side of the road or a sidewalk. If your car is safe to drive and is causing a hazard, pull it to the side of the road. Otherwise, leave your car where it is and get yourself to safety.

**STEP 4: Contact the police.** The decision to

contact the police and file an accident report is outlined in Iowa code 321.266. A driver involved in an accident resulting in **injury to or death** of a person is required to immediately contact the police. A driver involved in a traffic accident resulting in combined property damage to an extent of one thousand five hundred (\$1,500) or more shall, within 72 hours after the accident, forward a written report of the accident to the department. Minor fender benders, no apparent damage, and minor scuffs and scrapes, may not require a driver to contact the police. If there is ever a doubt about whether or not to report an accident, the police department encourages drivers to call the police. Once an officer is on scene, they will inform drivers of the proper reporting procedures.

**Step 5: Exchange information.** If the police are responding to the accident, there are some important documents you should have ready.

1. Your driver's license.

2. Insurance company paperwork – the insurance information needs to be updated and have the policy number clearly marked on the card. Exceptions to a digital copy of drivers insurance are considered; however, an updated paper insurance card is the preferred documentation.

## HOME BASE IOWA CLINTON COUNTY

Home Base Iowa is a program designed to connect veterans and transitioning service members with Clinton County-based employers. It's estimated that 200,000 men and women transition out of active duty service each year. These individuals are trained using state of the art technology, come equipped with unmatched problem-solving skills, and promote leadership and team development within the workplace.

Following the receipt of our official Home Base Iowa designation by former Governor Terry Branstad in 2016, Clinton County developed a list of benefits to be leveraged in an effort to attract these professionals to Clinton County.

Veterans relocating to Clinton County on or after December 23rd, 2016, are eligible to receive the following benefits:

- One-time home purchase closing cost reimbursement of \$1,500 for a home located in Clinton County
- Reimbursement of expenses up to \$275 per visit to interview with a business in Clinton County
- A first-year waiver of the Clinton County Business License Fee for a veteran opening a business

A veteran applying for the home closing cost reimbursement must present proof of home purchase (i.e. Closing Disclosure or Purchase Agreement), and the home must have been purchased within one year of your date of arrival.

Veterans must apply for these benefits within one (1) year from their date of arrival and must be able to present a DD 214 or Certificate of Release/Discharge from Active Duty at the time of application. All veterans interested in applying for the incentives listed above shall take their appropriate paperwork to the Clinton County Auditor's Office at 1900 N 3rd St.

## CLINTON MUNICIPAL AIRPORT

Have you ever wondered what we do at the Clinton Municipal Airport? The airport is owned by the City of Clinton and operated by the Clinton Airport Commission. The commission is composed of 5 members from the City of Clinton. Often, these members have a background in business and/or aviation.

The airport is a General Aviation airport with no commercial airline service. There are two runways, Runway 03/21 and Runway 14/32. The runways are able to support everything from a small single-engine airplane to large corporate jets such as a Gulfstream 650. Runway 03/21 is the longer of the two runways and is almost 1 mile long. It is equipped with an Instrument Landing System which allows pilots to fly into the airport during poor weather. The airport has 26 T-hangars available for rent. Most of these hangars are rented to individuals who own a small airplane used for business or personal travel. There are two larger hangars available for storage of bigger airplanes. One of these bigger hangars is home to Phalanx Aviation, an aircraft maintenance shop. The Corporate hangar is attached to the terminal building. It is used for hangaring

of overflow and transient airplanes. Often, business airplanes will stay in the hangar overnight or for a few days while their passengers conduct business in the area. The airport is also able to support Aerial Applicators. During a typical summer, you will see several "crop dusters" using the airport for fueling and loading. Occasionally, you will see Army National Guard helicopters using the airport for training.

The airport is staffed with 2 full-time employees, and 2 part-time employees. Those employees are responsible for a variety of tasks. Staff handles mowing, snow removal, grounds keeping, fueling and hangaring of airplanes. They conduct maintenance and upkeep of all the buildings and equipment.

The airport is host to the annual Cessna 150/152 Fly-In. Each summer, around 60 Cessna 150s and 152s from all over the country gather in Clinton for flying contests and socializing. This year will mark the 20th year we have been host to the Fly-In.

## TRAILS ADVISORY COMMITTEE

You've just finished work but it's just too nice to stay inside for the rest of the day, why not go for a walk, run or bike ride? Nothing crazy, just something to do while you enjoy the last hour or so of daylight, no big deal right? But if you live on the west side of town up on the bluff, that means if you want to get to the riverfront trail you will need to load up your bike or running shoes to drive down to the dike for your after work stroll. Instead you decide to ride to your favorite restaurant, you zig zag through the neighborhoods as you try and find the most sensible route when one doesn't exist. You get to the restaurant and you can't find a bike rack anywhere nearby to lock your bike up. If you already run, walk or ride in town, these are problems that you are all too familiar with. Up until recently there has not been any entity who has taken up the mantle to be responsible for things like this until now.

August 2018 marked the beginning of a new committee, the Recreational Trails Advisory Committee. This committee will advise the city council on matters concerning recreation trails, bike lanes, proposed sidewalks and other similar enhancements. They will help to define the Trails Master Plan, work on sidewalk infill and provide general advice on these and similar topics. But more importantly, this committee will bring a voice to a public infrastructure that up until this point has been up in the air and not given the necessary attention. Trails often haven't been given a second thought and any plans or ideas for improving the network have often been overlooked to make way for infrastructure projects pertaining to streets and sewers.

Historically, trails have always been viewed as a luxury item as opposed to vital public infrastructure like road and sewer work. While this isn't the sole reason for our limited trail network, it is a factor that heavily contributes. Unfortunately capital projects focusing on luxury items are often deemed less necessary than vital infrastructure projects. Projects that address luxury items are inherently less vital but that doesn't mean they aren't important. Street and sewer projects address things like transportation and sanitation, and while on the surface it seems trail projects address recreation and personal health but on deeper inspection reveals they provide more than that. A wholly connected trails network provides many benefits. A town with a connected trails network that crisscrosses the entire town provides a whole new opportunity for transportation. A dedicated trails network will aid many people who already depend on their bikes for everyday transportation and opens up

the possibility for more people to bike to work, to events and to run errands. 'Luxuries' like recreation trails and designated bike facilities will create a safer environment for cyclists, pedestrians, and automobiles. Road and sewer projects are planned out years in advance, allowing a systematic approach to managing resources and trails should be approached, with the same amount of planning.

There has never been a network approach to trails in town. Prior trail work only pertained to the Mississippi River trail that runs north to south, and while this is an important and popular trail, its reach and uses are limited. Through a methodical approach this committee hopes to facilitate the design and creation of a cycling environment that will provide for safe quick transport throughout town. It will reach important community locations like parks, schools and business centers. Additionally, it'll branch into large residential communities to allow everybody easy access to the trails.

At this moment, the new Trails Advisory Committee is creating a Trails Master Plan that will highlight our projects for years to come. As a part of this, we are using accepted guidelines to achieve standard goals that focus on engineering, education, encouragement, enforcement and evaluation. The committee is reviewing the existing data that has been compiled, and determining what data still needs to be obtained to achieve the set goals. Future planning such as this will outline trail work year after year, allowing each department to take the necessary steps to prepare.

This trails master plan will not only address trails projects but also help to guide on engineering policy, regular maintenance, educating the public, improving the safety of the network, how they will be addressed by law enforcement all the while using metrics to constantly evaluate their impact. In addition to future planning the committee is looking into ways to impact the trail system now through maintenance items, small projects and signage. It is critical that while we are devising plans to expand the network that the existing trails continue to be monitored. To create the desired network will require both larger capital projects as well as smaller projects. A lot can be accomplished through addressing items such as increased facilities, lane re-alignment through the pavement management program and trail head improvements.

Trails are great for a morning walk or an after work ride. You can take your dog out on the weekend or go walking with your grandkids. Maybe you want to ride and get a workout in or just want to check out your



city from a new perspective. Trails serve an important role in communities even more so than just when it comes to healthy living and recreational opportunities. Trails and cycling come with a huge economic upside. Across the country in 2017, the Outdoor Recreation Economy estimate that bicycling participants spend \$83 billion (up from \$71 billion in 2012) on bicycle trip related sales of cycling equipment and clothing. These trips generated a further \$97 billion in retail sales, food, lodging and local sales not to mention the 848,000 jobs that were created and sustained through the industry. It's true that these impacts are not equally distributed across every state, and some states experience greater impacts than others. Research conducted in Iowa reports that the economic impact in Iowa amounts to \$365 million, and of that \$17 million is related to RAGBRAI and its participants. These estimates are from 2012 and it's reasonable to assume that the totals have only gone up since then. Because this data represents only cyclists and not all trail users, it is only a portion of the economic impact that trails provide.

An improved trail network will create a ripple of benefits throughout the community. It gives citizens another opportunity for recreation and exercise leading to a healthier community. New options for transportation become available providing dedicated space on roads or dedicated trails, standardizing lane usage and making the travel experience safer for all. Increased trail usage leads to increased local retail spending. Healthy options, fun recreation, boosting the local economy and safer transportation these are both the results of an enhanced trail network and items that lead to an increased quality of life to a community. Who would have thought just riding your bike or going for a walk could be such a big deal?



## DEBT 101 – ISSUING BONDS

Governmental entities have been using debt (most often in the form of 'municipal bonds') for over 200 years to fund public infrastructure such as government buildings, police stations; roadways, and many other projects that require significant capital investment. When a city government issues debt, it receives an infusion of cash to build a project; in return the government repays the bond purchasers over time, plus interest. By using debt, the government can complete a capital project with a repayment schedule that spreads the cost of that project over its useful life, and the bond purchaser receives a reasonably reliable source of investment income.

Debt issuance requires working with a number of partners, each of whom has a specific role. The debt issuance will result in a financing agreement that is legally binding.

## THE FINANCING TEAM

**Bond Counsel** – Bond Counsel works directly for the issuer – The City's bond counsel is Ahlers & Cooney in Des Moines. The Bond Counsel is a team of attorneys with specialized experience in municipal financings, that generally issues two legal opinions in the offering:

1. An opinion as to whether the financing is a valid legal, binding obligation of the issuer, and,
2. An opinion of the nature of the taxability of the interest the investor earns on the financing.

These two opinions are relied upon by investors when considering whether they will purchase the bonds. The Bond Counsel will often also serve as a disclosure counselor for the issuer. The attorney assists with the preparation of the official statement and the continuing disclosure agreement, and will help facilitate preparation of the final (closing) documentation.

**Municipal Advisor/Financial Advisor** – a Municipal Advisor or 'MA' is a professional consultant that works directly for the Issuer. Under the Dodd-Frank Wall Street Reform and Consumer Protection Act, a Municipal Advisor working for a municipality must be registered with the Securities and Exchange Commission (SEC) and must give fiduciary care in advising the Issuer by putting the Issuer's interest above their own financial interest in a transaction. The MA has an independent view of the financing market, and works closely with Bond Counsel and the Issuer to assist in structuring and marketing the financing in the most economical way. The MA will also assist in determining if the method of sale should be through a competitive or negotiated sale. They will further assist by managing the sale and assisting the Issuer through the closing process.

## STRUCTURING CONSIDERATIONS

Issuers looking to utilize debt financing should review and update annual capital improvement plans to identify projects that can be funded with annual operating funds (which is very few), and those that require debt financing. Projects should be thoroughly reviewed as to scope, feasibility, cost, useful life of the financed assets, and capacity to repay debt. The City of Clinton utilizes a Capital Improvement Committee (CIP) to review the projects that are brought forth by the City Administrator and the Department Heads.

## THE CITY OF CLINTON'S USE OF GENERAL OBLIGATION BONDS

Over the last 10 years the City of Clinton has issued \$56,545,000 in General Obligation bonds to finance projects across several departments of the city. The listing below enumerates projects to improve quality of life in our community.

Pavement Management Program – Roadway Construction	\$15,000,000
Public Safety Equipment Needs	\$ 4,100,000
Parks & Recreation Equipment/Buildings/Amenities	\$ 3,155,000
Airport Terminal & Improvements	\$ 1,430,000
MTA/Streets/Grounds Equipment	\$ 1,235,000

The fiscal year 2020 budget process is wrapping up with an approved project listing that includes \$4,825,000 for road improvement and road construction projects. Along with our continued road improvements, there are \$3,100,000 in public safety and quality of life initiatives.

## SIDEWALK SNOW / ICE REMOVAL RESPONSIBILITY

### Business district sidewalks.

(1) Sidewalks on the following streets are hereby defined as business district sidewalks:

(a) Main Avenue between Harding and Third Streets;

(b) North Second Street between Twenty-Third Avenue and Main Avenue;

(c) Fourth Avenue South between First and Third Streets;

(d) Fifth Avenue South between First and Fourth Streets;

(e) Sixth Avenue South between First and Fourth Streets;

(f) Seventh Avenue South between Second and Fourth Streets;

(g) Eighth Avenue South between Second and Fourth Streets;

(h) First Street between Fourth and Seventh Avenues South;

(i) Second Street between Third and Eighth Avenues South; and

(j) Third Street between Fourth and Eighth Avenues South.

In the event snow and/or ice remains on a business district sidewalk for more than 12 hours after the snow stops falling, or after ice forms, the city may remove the snow or ice from the sidewalk. The cost of the actual removal, plus a filing fee will be assessed against the property.

### Sidewalks other than business district sidewalk.

This division applies to all sidewalks not defined as business district.

In the event snow and/or ice remains on the sidewalk for more than 48 hours after the snow stops falling or after ice forms, the city may remove the snow or ice from the sidewalk. The costs of actual removal, plus a filing fee will be assessed against the property.

Did you know, the effects of de-icing materials can range from an oxygen level reduction in our creeks and streams, to increased sediment levels, burning vegetation along sidewalks, and damage to concrete and carpets? You can reduce the harmful side effects of de-icing materials by: Shoveling early and often, Reducing salt use, Limit access to your home to one entrance, and Avoid using fertilizers and products containing urea.

## SEVERE WEATHER PREPAREDNESS

- Listen to local area radio, NOAA radio or TV stations for the latest information and updates.
- Watch for tornado danger signs: dark, often greenish clouds — a phenomenon caused by hail; a wall cloud — an isolated lowering of the base of a thunderstorm; or a cloud of debris.
- Move or secure any of the items on your list of items to bring inside or anything else that can be picked up by the wind.
- Bring your companion animals indoors and maintain direct control of them.
- Go to a safe place in your home where household members and pets will gather: a basement, storm cellar or an interior room on the lowest floor with no windows.
- In a high-rise building, pick a hallway in the center of the building. You may not have enough time to go to the lowest floor.
- In a mobile home, choose a safe place in a nearby sturdy building. If your mobile home park has a designated shelter, make it your safe place. No mobile home, however it is

configured, is safe in a tornado. If you have access to a sturdy shelter or a vehicle, go there immediately, using your seat belt if driving.

- If you are driving, stay away from bridge/highway overpasses.
- If strong winds and flying debris occur while driving, pull over and park, keeping your seat belt on and engine running. Put your head down below the windows, covering your head with your hands and a blanket.
- After a tornado, let friends and family know you are safe.
- If evacuated from your home, return only when authorities say it is safe to do so.
- Listen to local news or a weather radio.
- Check for injuries. If you are trained, provide first aid to people in need until first responders arrive.
- And we would like to add: **Be ready.**
- Assemble an emergency kit now. Practice where you would shelter during a storm now. Talk with your family about how you would contact each other, or where to meet, in the event of a storm.



## STREET / PUBLIC WORKS DEPARTMENT

Upcoming Solid Waste/Recycling Delays:  
YARD CART COLLECTION RESUMES ON MONDAY APRIL 1STSOLID WASTE DEPARTMENT  
POLICY ON YARD COLLECTION

The Solid Waste Department has set standard start and end dates for yearly yard waste collections as the following:

**Start of Yard Collection:** 1st week of April

**End of Yard Collection:** Last week of November or with the first snowfall

\*As always, these dates are subject to the weather.

Our rationale for the dates are as follows:

When the temperatures are below freezing, the moisture in and around the material in the yard carts will freeze everything together, which prevents it from coming out when we empty it. This in turn, may also cause the cart to split/crack or become damaged in some other way.

At our current staffing levels, we are not able to adequately transition from our winter duties to our spring/summer duties until that time.

We have heard from many of you wondering why we stop our yard collections so early compared to several of the surrounding communities. The reason for this is because those communities do not use carts for their yard waste. They use bags that are hand loaded onto their trucks. They do not run the risk of damaging carts because of the waste material freezing inside a container.

Our goal is to lessen any confusion for our residents. We would like to thank all of the residents of Clinton for helping us run a successful Yard Waste program.

## CITY OF CLINTON WORK TICKETS

**Did you know that anyone can submit a work order ticket to the City of Clinton for services, community concern, or any other issue that they would like to report on?**

You will go into the support center home for the City of Clinton. This area allows for tickets to be created and sent to departments to address your concern. You can follow up on your concern with the number assigned with the request.

Street Sweeping and Pothole repair are currently on-going. We will be starting work in the Right-of-way's, which include: spraying, ditch mowing and maintenance.

To assist the public, a work order may be created and assigned to ANY department through the City of Clinton's website – go to: [www.cityofclintoniowa.us](http://www.cityofclintoniowa.us) and click on CONTACT US and choose OPEN A NEW TICKET – then just follow the prompts. A work order may be created at any time, 24 hours a day, 7 days per week. All work orders are addressed according to the order it was received and its public safety ranking.

**Please use caution and slow down when approaching street crews in the roadway!**

**Please be aware** – it is against City Ordinance to blow cut grass into the roadway and gutter. Yard debris clogs up storm drains and can contribute to sewer backups. Also – if you have a storm drain / catch basin in front of your house, please keep it clear, to ensure all runoff drains properly.

## § 97.003 PLACING DEBRIS ON

It is unlawful for any person to throw or deposit on any street or alley any glass, glass bottle, nails, tacks, wire, cans, trash, garbage, rubbish, litter, offal, leaves, grass or any other debris likely to be washed into the storm sewer and clog the storm sewer, or any substance likely to injure any person, animal or vehicle.

(Iowa Code §321.369) (1999 Code §135.03) Penalty, see § 10.99

**Please be aware** that tarps and/or covers are required by City Ordinance on any and all waste being transported to the Clinton County Solid Waste Agency (aka the Landfill).

## § 50.27 LOADING

Vehicles or containers used for the collection and transportation of any solid waste shall be **loaded** and moved in a manner that the contents will not fall, leak or spill therefrom, and shall be covered to prevent blowing or loss of material. Where spillage does occur, the material shall be picked up immediately by the collector or transporter and returned to the vehicle or container and the area properly cleaned.

(1999 Code, § 106.03) (Iowa Code §§ 321.460 and 805.8A(13)(c))

## City Ordinance Regarding Tree Responsibility

## § 98.06 DUTY TO TRIM TREES

The owner or agent of the abutting property shall keep the trees in or overhanging the street trimmed so that all branches will be at least 13 feet above the surface of the street and nine feet above the sidewalks. If the abutting property owner fails to trim the trees, the city may serve notice on the abutting property owner requiring that such action be taken within five days. If such action is not taken within that time, the city may perform the required action and assess the costs against the abutting property for collection in the same manner as a property tax. Except as allowed in this section, it is unlawful for any person to trim or cut any tree in a street or public place without first obtaining authorization from the city. The Building and Neighborhood Services Official or his or her designee shall have the power to enforce this section.

(Iowa Code §§ 364.12(2)(c), 364.12(2)(d), 364.12(2)(e), 364.12(3)(b)) (Ord. 2437, passed 12-14-2010) Penalty, see § 98.99

## City Ordinance Regarding Grass Height For Property Owners

\*\*The purpose of this chapter is to require owners of residential property to cut their grass, weeds, vines and brush when they exceed eight inches in height.

## § 94.05 NOTICE TO OWNERS, ONCE PER CALENDAR YEAR.

Notice to the property owner shall be provided as follows: The Code Official shall cause to be published prior to June 1 of each year in a newspaper of general circulation within the City a notice stating that maintaining property as required under this chapter shall be done, and that the property owner has until the growth reaches eight (8) inches in height to cause the work to be done. Further, the notice shall state that failure to comply after publication of the notice will result in the City causing the work to be done, and the costs incurred by the City shall be assessed against the property in the manner provided by law and this Code of Ordinances. No further notice shall be required, provided the Code Official may post notices or provide such additional notice as the Code Official deems appropriate under the circumstances.

TRACKING SOLID WASTE,  
YARD WASTE AND RECYCLE CARTS

With the implementation of Single-Stream Recycling, the City of Clinton now has the capability of tracking its collection carts, since all of the carts are chipped. The new computer program that the City is using allows us to monitor all cart activities and our collection routes. When a resident reports a cart as being stolen or lost, we are able to find the actual location of the cart. If a residence is found to have more carts than they are entitled to, the City will notify the resident of that address that they are in possession of the extra carts and that they must make arrangements to return the carts back to the City. The resident may also elect to pay the appropriate fees if they wish to keep the extra carts. If arrangements are not made, the resident runs the risk of being reported for being in possession of lost or stolen property to the Clinton Police Department.

## SINGLE STREAM RECYCLING

First and foremost, Thank you City of Clinton residents for embracing our Single Stream Recycling program!

In 1990, Clinton was one of the first cities in the State of Iowa to begin curbside recycling. At that time, each residence was given three small black buckets for sorting their recycling items. Recycling has grown to where last Fall, we replaced the small black buckets with a 95-gallon cart. It became easier to recycle – no more sorting or removing labels, and more items became acceptable for recycling!

In the first three months of this pro-

gram, recycling has increased an average of 32 tons per month. This is 32 tons less material per month filling up our landfill. During this time, we have also decreased the amount of solid waste going to the landfill by an average of 20 tons per month.

You - the residents of Clinton, have been doing an awesome job! Keep up the good work!

If you have any suggestions on how to make this program even better, don't hesitate to contact the Solid Waste Department. We'd love to hear your ideas.


