CITY SIDEWALKS

Toddlers learn to walk, kids walk to school and adults take the dog for a walk. Walking is arguably the most abundant activity we take part in in our lives. It is used to get from point A to point B, the couch to the fridge or from home to school. We go for a walk to exercise, look at the changing leaves or just to relax and ponder the day that has been or the day that lies just ahead. We walk and walk and it's a part of everybody's day.

Unfortunately, a nice walk can be interrupted in a number of different ways and not just from a poorly timed phone call that interrupts an otherwise tranquil walk. A severely misaligned segment of sidewalk can create a tripping hazard, tree roots can cause the walking path to heave, low spots hold puddles, non-uniform settling can make for a steep path and cracking combined with any of these problems can just exacerbate the problems further. All of these are problems that come with the physical existence of a sidewalk at that location. There are many areas where the sidewalk may cease all together for one property or an entire block. Spots that lack a sidewalk may be trampled down into a muddy path, there may be trees, bushes and trash bins that you are forced to dodge or you may be forced to move out into the street, which means contending with cars. This scenario is only considering walking through decent weather. Once the snow flies, if you are still out walking whether for pleasure or because it's required for transportation purposes, you have to worry about sidewalks not being shoveled. While cracks and heaved areas may create quite the headache when shoveling, just imagine discovering one that is buried beneath an inch or so of fresh snow while walking. All of this can turn a normal walk along the sidewalk into an exercise in navigating an obstacle course.

Over the last few months, the Engineering Department has been surveying the state of Clinton's existing sidewalk infrastructure. Parts of town sport new sidewalk that are in good condition, while other areas include sidewalk that has failed, and some areas have sidewalk that has been around for decades and hardly show signs of wear. While the expected useful life a sidewalk is 50-75 years, depending on various factors, even the best of sidewalks can be destroyed by tree roots and frost, making new and old sidewalks equally susceptible.

To assess the existing sidewalk infrastructure, the department used the following factors to determine the current integrity of our sidewalks: heaving, cracking and spalling. Sidewalk that has heaved via thermal expansion (frost) or tree roots are known to have significant tripping hazards - nonetheless this is not the only cause of tripping hazards. Settlement attributed to improper backfill, poor compaction or washouts can be a cause as well. A simple crack in a sidewalk isn't necessarily evidence of sidewalk failure but is a sincere precursor to future failure. Occasionally a crack can take quite a long time to form and then become a hazard and other times they can develop and result in sidewalk failure and a hazardous situation relatively quickly. Should a particular segment of sidewalk have multiple cracks, this significantly increases the chances for tripping hazards at those locations. Spalling occurs when the surface of the concrete begins to wear away exposing the aggregate and creating an uneven surface. These are not the only factors to consider in a sidewalks' integrity.

The sidewalks were also evaluated on their cross slope, consistency and continuity. A proper ADA accessible sidewalk will have a cross slope less than ¼” per foot falling towards the roadway. This creates a surface that can be easily walked upon and is ideal for wheel chairs as well, yet allows the water to shed off and make its way towards the gutter, conveying all water to the storm inlets. A proper stretch of sidewalk should run at a consistent pitch and slope. Should the pitch and slope of each panel be different than the panel immediately preceding it, this will impair the use of the sidewalk. The final aspect to be considered was the continuity of said sidewalk. Some areas of town have more consistent sidewalks than others. Consistency can be reduced by large trees or bushes or simply blocks or particular yards completely void of sidewalks. It is not unusual to move through town and come to a sidewalk that has terminated and begins again at the next yard or block. In these instances, pedestrians are then required to walk out in the road or walk through yards which can be frowned upon.

Through this inventory, it is evident that the city's current approach to sidewalk maintenance needs to be examined. Currently all work on sidewalks in town is reactionary and cannot even be referred to as maintenance because maintenance implies the knowledge of the existing condition along with regular inspections of the whole system. Currently even some city facilities like parks are not properly accessible because of lacking sidewalk nearby. The City will be considering a revised sidewalk maintenance policy in order to improve a sidewalk network that will not improve unless it gets the attention it deserves.

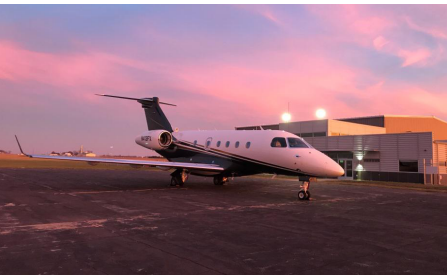
This is a step that the engineering department has been taking, and will continue to do, to handle permitting of sidewalk construction and you can actively help with this. Should you decide to replace the sidewalk in front of your residence, rental unit or business, come to the engineering department's office to pick up a permit. There is a small fee, \$10 for every 15 linear feet of sidewalk, but as a part of the permit, a member of the Engineering Department staff will inspect the sidewalk prior to the concrete being poured to ensure that it has been properly compacted, has the requisite expansion, and is the right thickness. It will also be inspected after to make sure the sidewalk has been properly backfilled, seeded and that the concrete is holding up. Another way that residents can help is to keep their small segment of sidewalk free from items that may accumulate such as snow, leaves and grass clippings.

Sidewalks may often be overlooked and underappreciated, but there are a lot of people who depend on them. Kids learn to ride their first bikes on them, mail carriers pound them day after day, and everybody can remember that hill they walked up both ways to and from school when they were young. A fully accessible and well maintained system of sidewalks - free of tripping hazards- offers a well-connected network that allows all pedestrians to access any part of town. Just like homes and roads, sidewalks demand regular attention and settling on a proactive maintenance plan will ensure the network will become and continue to be useful for all.

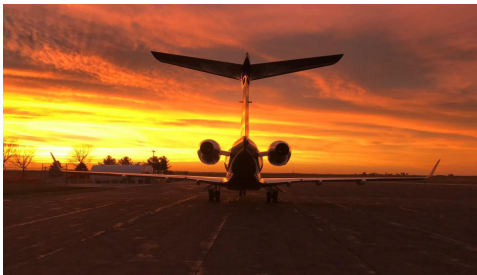
Economic Impact

We tracked over 235 known business flights. These flights brought passengers from all parts of the country to visit industrial sites, manufacturing plants, real estate locations, construction projects, and more throughout Clinton and surrounding counties.



Improvement Projects

We replaced 25 year old underground fuel storage tanks with new aboveground fuel storage tanks. This project was funded in large part with grant money from the Iowa DOT, and eliminated the risk of in-ground leaks from older storage tanks.

The airport was host to the 18th annual Cessna 150/152 Fly-In which brought approx. 55 airplanes and 85 visitors to the airport for a week in July. TREES

The next couple of months are perfect for heavier pruning of trees which should be done when the tree is dormant and before active growth begins. This is a great time to trim up those branches that are overhanging the sidewalks and roadways.

City ordinance states all tree branches over hanging the city streets must be trimmed to 13 feet above street level and 9 feet over sidewalks. Bushes close to a sidewalk or street need to be trimmed back away from the area to ensure safe passage as well as ensuring there is no obstruction of vision. This is also a good time for checking your trees for dead branches that might fall during storms as well as if the tree is dying or diseased.

Do You Realize Your Toilet IS NOT A Trashcan?

Tired of hearing of high sewer costs? Here is a way you - as a Clinton city resident, can help.

Have you ever stopped and really thought about what foreign objects you automatically just “flush” thinking it is not harmful to our sewer systems? Or even to our own personal home systems? It’s hard to imagine when you flush, what and where exactly everything is going and what problems may occur. It’s just gone and forgotten. Most people just don’t think about it.

A back up in your home (plugged sewer) that can cause raw sewage coming up, is a very devastating experience. It is also very costly and time consuming for you and everyone involved.

There are so many products that people simply flush down the toilet. Even if a product says it is “flush-able”... Unless it is toilet paper, it should not be flushed! The biggest product on the market that claims to be flushable are WIPES. There are various types of WIPES - all claiming to be “flushable”. They do not break down in the sewer system and are one of the worst culprits in clogging up the systems. They are sold to us consumers as being “flushable” and they are not. They need to be disposed of properly in a trash container.

Other products not to be flushed are the obvious – paper towels, cloth towels, or any type of rag, feminine hygiene products, and facial tissues.

Only one thing to always remember as stated earlier in this article, “Unless it is toilet paper, it should not be flushed!” No Wipes Down the Pipes!!

From the Finance Department

The Fiscal Year 2019 budget season is underway. The city’s budget must be approved and submitted to the County and to the State of Iowa by March 15th of every year.

Many economic factors face a municipality when setting the budget – the first one being economic changes to the valuation of all of the property within the city. For Fiscal Year 2019, taxable valuation is down because of the rollback on residential property. What does this mean? If you are a homeowner, and own property that has a Fair Market Value (FMV) of \$100,000 – you only pay property taxes on a portion of that value – the ‘rolled back’ value. For Fiscal Year 2018 the residential rollback was 56.9391%. For Fiscal Year 2019 the residential rollback is 55.6209%. Here’s what this means to you as a homeowner, and what it means to the city, as a taxing body:

	2018	2019
FMV of Your House	\$ 100,000	\$ 100,000
Residential Rollback	56.9391%	55.6209%
Taxable Value	\$ 56,939	\$ 55,621
City's General Fund Levy (per \$1,000 in taxable value)	\$8.37	\$8.37
Your property taxes that support the General Fund	\$ 476.58	\$ 465.55
Decrease in property taxes paid for FY19	\$	(11.03)

In total – the decrease in residential property valuation for Fiscal Year 2019 – attributable to the residential rollback - is \$10.1 Million. This is a loss of \$85,000 in property tax revenues that supports the operation of the city’s general fund. Those departments directly affected are Police; Fire; Parks & Recreation; Library; Building & Neighborhood Services; and all of the other General Government functions of the city.

The General Fund levy that is enumerated above is a portion of the city’s overall tax levy. For Fiscal Year 2018 the city’s total property tax levy is \$15.63968 per \$1,000 in taxable valuation. The other pieces of the city’s levy (besides the \$8.37 that supports the General Fund) are as follows:

General Fund Levy	\$ 8.37000
Property Liability	\$ 0.30696
Police & Fire Retirement/IPERS/Other	\$ 4.38315
Debt Service	\$ 2.57957
Total	\$ 15.63968

Then, the city’s property tax levy is only a portion of the total property taxes that you pay. If you live within the city, and the Clinton School District, the other taxing bodies that are included in the total property taxes that you pay are: State TB Fund (.00310); The County (7.82264); The Area College (1.03000); The Assessor’s Office (.48520); The Ag Extension (.12334); and The School District (16.81474) for a total of \$41.9187 (per \$1,000 in taxable valuation). This is better illustrated in this graph:

We are 4 weeks into the budget workshops, and hope to finish up in the next couple of weeks.

The departments have been working together to fit their operating budgets within the constraints that we are faced with – all the while being diligent about preserving the services that our residents deserve and need. It is difficult (for example) to grow a police force when the amount of money available to operate it keeps being reduced by forces outside of our control (the residential rollback).

Please take the time to educate yourself about how city government works – how property taxes are assessed and used – and how the other fees that you pay (not just property taxes) are accounted for. You’re never too cool to learn something new!

Animal Control Issues:

The procedure for removal of small dead animals (i.e., dog, cat, squirrel) in a roadway is to contact the Clinton Police Department non-emergency number at: 563-243-1458 and the Public Safety Officer (PSO) will assist with removal.

For removal of live, medium sized animals (such as a raccoon), contact: Eric Perry, the “Wildlife Wrangler” at: 563-559-6989. Eric will capture the

animal for the homeowner and release it into the country for a fee.

For large dead animals (such as deer) that are too large for the PSO to remove on their own, the Public Works Department may be called upon to assist with removal. All fires must be attended by an adult with an extinguishing agent readily available.

Burn Rules:

From April 1st - May 15th, the City of Clinton will allow open burning for those residents with lots of one acre or larger on Tuesday, Thursday and Saturdays between the hours of: 10 am – 5 pm, weather and wind permitting. Fires must be no closer than 25 feet to a structure or other combustible material. Open

burning is limited to: piles of clean, dry, untreated wood and lumber and landscape waste. The piles should not be burned larger than 3 feet in diameter and 2 feet high.

All fires must be attended by an adult with an extinguishing agent readily available.

Clinton Curfew Ordinance

As Spring quickly approaches and the weather warms, more and more people will want to spend time outdoors. Our children are no different. They will want to be outdoors and stay outside later and later. It may become more difficult for a responsible adult to know the whereabouts of the child. Nevertheless, the City of Clinton has a Curfew Ordinance. The Clinton Police Department wants everyone to know the specifics of the Curfew Ordinance.

Unless accompanied by a responsible adult, no minor under 14 years of age shall be in any public place in the City of Clinton during the following times:

Sunday through Thursday:
10:00 p.m. through 6:00 a.m. each day

Friday and Saturday:
11:00 p.m. through 6:00 a.m. each day

Unless accompanied by a responsible adult, no minor aged 14 to 17 shall be in any public place in the City of Clinton on any day between 12:00 midnight through 6:00 a.m.

There are a few exceptions to these hours:

1. The minor is accompanied by a responsible adult;
2. When the minor is on the sidewalk or property where the minor resides;
3. The minor is traveling between home and one of the following exceptions
 - a. Minor's place of employment;
 - b. Minor's place of religious activity;
 - c. Governmental or political activity;
 - d. Professional entertainment, with proof of attendance;
 - e. School activity;
 - f. Assembly such as a march, protest, demonstration, sit-in or meeting of an association for the advancement of economic, political, religious or cultural matters, or for any other activity protected by the First Amendment. (all of these activities must be within one hour after the end or before the beginning of the excepted event)

4. The minor is on an emergency life, property or medical errand for a responsible adult;
5. The minor's business, trade or occupation, in which the minor is permitted by law to be engaged, requires the presence of the minor in a public place.

It is unlawful for any responsible adult knowingly to permit or to allow a minor to be in any public place in the city within the time periods outlined above.

So what happens when your child is charged with a Curfew Violation?

After the minor is taken into custody or issued a citation, the officer shall make an effort to notify the adult responsible for the minor. The minor will be released to the adult upon the promise of the person to produce the child in court, when required.

A curfew violation is a simple misdemeanor punishable up to a \$100 fine or perform community service, as ordered by the court.

Body-Worn Camera Deployment for Clinton PD

The Clinton Police have embarked on the first phase of its planned roll-out of body-worn cameras to officers. The deployment, which gets underway in February, follows a successful trial period, as a well as a public consultation and input from area leaders.

In the wake of high-profile incidents in Ferguson, Chicago, North Charleston, Baltimore, and elsewhere, law enforcement agencies across the country have rapidly adopted body-worn cameras for their officers. One of the main selling points for these cameras is their potential to provide transparency into police interactions, and to help protect civil rights. Body worn video will support our officers in the many challenging situations they have to deal with, at the same time as building the public's confidence.

Body-worn cameras are small cameras which can be clipped onto a police officer's uniform or belt and turned on to record video and audio of law enforcement encounters with the public. The video is often saved with time and date stamps and GPS coordinates. The department can select input that triggers body-worn cameras to automatically turn on without manual activation, such as turning on a police car's lights or sirens, crash sensor activation, when

the car reaches a certain speed, or when nearby dashboard cameras or body cameras are switched on. All footage is uploaded to external databases maintained by the department.

Video captures events in a way that can't be represented on paper in the same detail. It has been shown that the mere presence of this type of video can often defuse potentially violent situations without the need for force to be used.

The Clinton Police Department will use the technology to gather evidence. They also offer greater transparency regarding the behavior of officers themselves, something which is particularly relevant following the recent national discussions about the use of stop and search.

Once the device has been docked at the end of the shift, all footage is automatically uploaded to secure servers, before being tagged for use in court. Video not retained as evidence or for a policing purpose is automatically deleted within 91 days. The Clinton Police Department anticipates the body worn camera system to be fully operational within the next month.

Alcohol Sales Compliance Checks to be Performed

As a law enforcement agency in Clinton County, the Clinton Police Department is in support of the Gateway ImpACT Coalition Community Coalition Grant through the Iowa Department of Public Health to implement substance abuse prevention strategies to reduce underage use of alcohol in our community.

As a part of this project, law enforcement will be completing alcohol compliance checks across Clinton County, including the city of Clinton, in the next few weeks. Compliance checks are an enforcement strategy which checks the sale of alcohol to individuals under the legal drinking age. Compliance checks are conducted at least once annually by using underage customers, under the supervision of a law enforcement official, who enter a retail establishment and attempt to purchase alcohol. Clerks who make the illegal sale will be cited.

If you are a business owner who sells alcohol, now is the time to train and remind all your point of sale clerks on the proper identification and sale of alcohol to your customers. If you are a clerk whose responsibility includes the sale of alcohol, check ID's! You are the one who will receive the citation when an illegal sale is made.

The Gateway ImpACT Coalition offers retailer and point of sale employee training. Training for Intervention Procedures (TIPS) is a FREE training program designed to prevent inebriation, drunk driving, and underage drinking. TIPS certified staff are less likely to sell to underage people, are more knowledgeable about state and local regulations, have fewer penalties for alcohol violations and improve customer service and satisfaction. All the TIPS classes are FREE and held at Clinton Community College Technology Center, 1951 Manufacturing Drive, Clinton. Registration is required. 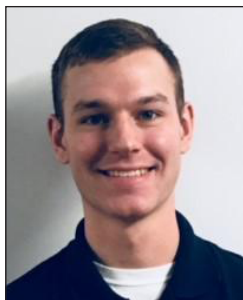

Alex started his employment on January 2, 2018 and is now receiving his training at the Iowa Law Enforcement Academy in Johnston, Iowa. Alex is scheduled to graduate from the Academy on April 18, 2018.



Joseph "Joe" Gandrup has accepted the position as a Police Reserve Officer with the Clinton Police Department. Joe is a graduate of the Citizen's Police Academy and a member of the Citizen's Police Academy Alumni. Joe has begun his reserve training which will continue over the next several months. This position replaces one of the two vacancies created when Reserve Officers Livesay and Winter were hired as full-time police officers.

CRIMES OF OPPORTUNITY

Clinton Police officers respond to many calls for service. The types of calls range from the serious, personal injury type crime, traffic accidents, assaults, etc., to the less serious property crime such as a theft or vandalism. There may be times during an officer's shift that calls from the public must be evaluated and a response made based on the type of call received and not necessarily in the order in which the call was received. However, we realize that every call is important.

Many theft crimes may be considered crimes of opportunity. We see in the paper and on local television newscasts that many reported crimes occurred because someone with a criminal thought found an opportunity to commit a crime. That is, the offender chose a target offering a high reward with little effort and risk. An example of a crime of opportunity could be an individual walking down the alley in the middle of the night checking to see if car doors are locked, with the intent to take the change sitting in the center console. In this instance, if your vehicle was locked, the subject would have just kept on walking to check the next car. Another example may be when an individual is walking down the sidewalk, sees a bicycle left out in the front yard and takes it and deserts it close to his destination. Both examples of theft could have been avoided by taking a little extra time to lock things up when you leave your vehicle or retire for the night.

You can help keep yourself, your neighborhood and your community safe from these crimes of opportunity by following these steps:

- Keep your car doors locked. Do not leave your car running.
- Don't leave valuables in your car.
- Bring in bikes, toys, tools, etc, at the end of the day.
- Do not leave your overhead garage door open.
- Lock your home, even if you are present.
- Use exterior lighting around your house during the evening hours.
- Mark all your valuables so if they are stolen, they can easily be identified as yours.
- Document all valuables in your home. Use a smart phone app or note cards to document the make, model and serial numbers of TVs, stereos, cell phones and other electronics and high dollar items in your home.
- Don't leave laptops, purses, electronics next to a door or in open areas of your home.

Clinton Police to Partner with Iowa Alcoholic Beverages Division for Tobacco, Alternative Nicotine, and Vapor Product Education and Enforcement



The Clinton Police Department has taken a pledge to keep tobacco, alternative nicotine and vapor products out of the hands of Clinton's youth.

Known as I-pledge, the program is a partnership with the Iowa Alcoholic Beverages Division (ABD) to educate local retailers and to enforce Iowa's tobacco, alternative nicotine and vapor product laws. Since the program's inception in 2000, the statewide tobacco compliance rate has grown to 91%. By participating in the program, the Clinton Police Department has committed to do its part to increase the compliance rate even more this year.

I-pledge places the emphasis on retailer training. Clerks who successfully complete an online training course and then pass an exam will become I-pledge certified. This allows a retail establishment to use an affirmative defense against a civil penalty if the certified clerk makes an illegal sale.

"I-pledge retailer training is a great way for clerks to prepare themselves to refuse illegal tobacco, alternative nicotine and vapor product sales," Clinton Police Chief Kevin Gyron said. "The training also assists retailers to ensure they maintain a compliant and responsible establishment."

Clinton Police Officers will also be conducting compliance checks on local establishments as part of the I-pledge program. Underage customers, under the supervision of law enforcement officials, will enter establishments and attempt to buy tobacco, alternative nicotine and vapor products. Clerks who make the illegal sale will be cited.

Criminal penalties for selling tobacco, alternative nicotine and vapor products to a minor include a \$100 fine for a first offense, a \$250 fine for a second offense and a \$500 fine for third and subsequent offenses. However, handing out citations is not the intent of the I-pledge program.

"By partnering with the Iowa Alcoholic Beverages Division, we hope to educate clerks and maintain a compliant retail environment in our community," Chief Gyron said. "Moreover, we pledge to help keep tobacco, alternative nicotine and vapor products out of the hands of Iowa's youth."

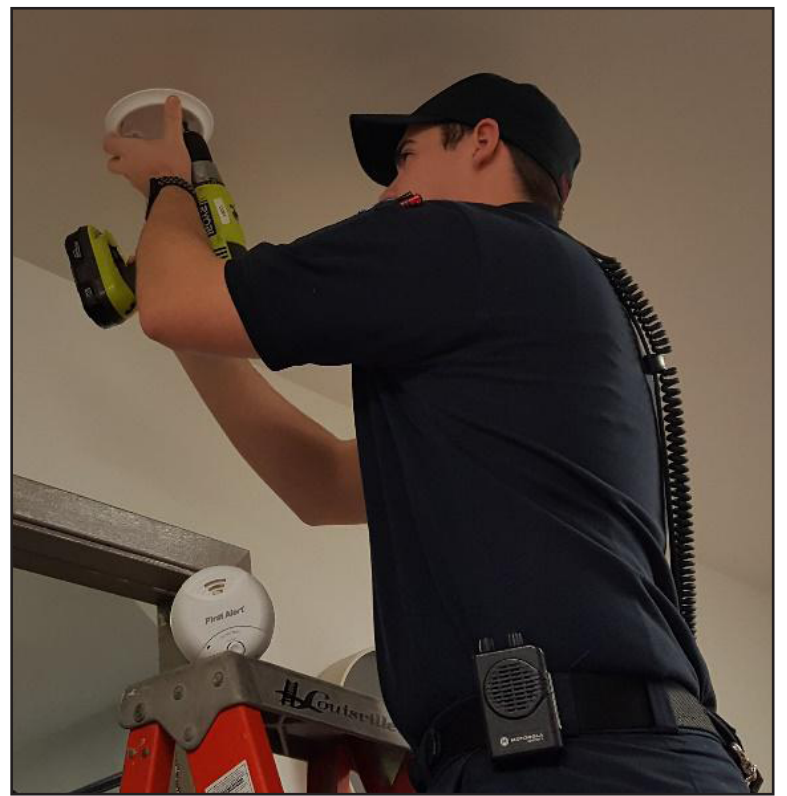

Lead Hazard Control & Healthy Homes Program

CITIES OF CLINTON AND MAQUOKETA

The cities of Clinton and Maquoketa have received a Housing and Urban Development Lead and Healthy Homes Grant. The purpose of this grant is to provide financial assistance to low and moderate income homeowners and rental property owners to reduce lead-based paint hazards in homes with young children. Eligibility for this program is based on household income and the presence of a child under the age of six that lives in the home or visits frequently.

- Lead-based paint is prevalent in homes built prior to 1978. If your house was built before 1978 and any of the following conditions exist, we can help:
- Painted surfaces that are chipping, peeling, cracking or otherwise deteriorated.
- Paint that is accessible to children under the age of six and is

chewable. Examples of chewable surfaces are: window sills, stair treads, handrails and spindles.

- Paint on impact surfaces where it can be easily chipped. Examples: doors, door jams and baseboards.
- Paint that is on a friction surface where movement creates dust. Examples: windows and floors.

Grant funds will be available for three years. It is anticipated that we will be making approximately 64 homes "lead-safe". There is also supplemental funding for Healthy Homes. These funds become available if lead is detected in the home.

Building & Neighborhood Services – Nuisances

We are here to help make Clinton a better community. If you receive a notice that your property has been tagged for a nuisance, we want you to understand what that notice means. It isn't a summons. It isn't a citation. It isn't a placard. It isn't a condemnation. It means your property, at present, does not conform to Clinton's Code of Ordinances and is a request for you to make the required improvement in order to comply.

Please understand that even though it is a request, it is required. If you don't abate the nuisance yourself, we will have the city's contractor do it for you, and you will have to pay his invoice, plus a processing fee. Along with that,

you are subject to civil and/or municipal citations.

Building and Neighborhood Services does not want ANY of this to happen. First and foremost, we want you to take care of your property. But, if you do get a notice, BNS inspectors are more than willing to work with you. The key is communication. Call our office if you just don't understand why you are receiving the notice or are struggling to meet the deadline. We will be glad to explain the process and work with you to keep up your property and keep our city beautiful.

Building Permit Inspections

Recently we have had a couple of complaints about missed inspections on building projects. We here in Building & Neighborhood Services are available and able to inspect any project with a requested 24 hour notice before the inspection is needed. In emergency situations and for roofing projects, we can many times provide same day service. However, Building & Neighborhood Services needs to be notified when an inspection is needed by either the contractor or the homeowner. Many times we are not notified until a project is finished, and so we cannot do a full inspection if items have been covered by

wallboard or a layer of asphalt roofing. When we cannot see what is behind a wall or under a roof, we cannot verify if every aspect is code compliant. This means we sometimes have to close out a project without an approved status on the project. Please make sure that you or your contractor call for all required inspections. A list of those inspections is available in our office and is given to homeowners or contractors when they pick up a building permit. Our goal is to provide excellent service to our community and we cannot meet that goal if we aren't made aware of the need for an inspection.

Please Number Your House!

City of Clinton Code of Ordinances Chapter 153 Building Numbering

The City of Clinton has an ordinance requiring that all buildings, including homes, be numbered. The numbers should be on the front entryway, should be 4 inches in height with a minimum stroke width of ½ inch. Color should contrast with the house color so to be seen from the street. In rural areas, the numbers should be attached to the rural mailbox at the street location. In town, where mailboxes are present at the street, numbers should be placed on the mailbox as well as the house near the entry, so to be seen from the street. Numbers on rural or street level mailboxes, should be

in 3 inch block numbers and contrast the mailbox color to ensure proper visibility. We ask you to comply with Chapter 153 so emergency personnel can locate your house in an emergency.

Failure to number the structure in accordance with Chapter 153 after being notified to do so, will cause the City to number your building and assess the cost against the property in the same manner as a property tax. It also subjects the property owner to civil citations, or municipal infractions per City of Clinton Ordinance, Chapter 10, section 10.99 General Penalty.

LANDLORDS

We started a new billing procedure for Rental Inspections January 1st 2018. You will receive your scheduled Rental Occupancy Renewal Notice approximately 30 days prior to date of inspection. The bottom portion of letter should be detached and returned with payment

prior to scheduled appointment. Certificate of Occupancy will not be issued until paid. If bill is not paid and sent to lien, the owner will be subject to accessed fees, penalties, possible citations and possible placard.

Single Stream Recycling:

First and foremost, Thank you City of Clinton residents for embracing our Single Stream Recycling program!

In 1990, Clinton was one of the first cities in the State of Iowa to begin curbside recycling. At that time, each residence was given three small black buckets for sorting their recycling items. Recycling has grown to where last Fall, we replaced the small black buckets with a 95-gallon cart. It became easier to recycle – no more sorting or removing labels, and more items became acceptable for recycling!

In the first three months of this pro-

gram, recycling has increased an average of 32 tons per month. This is 32 tons less material per month filling up our landfill. During this time, we have also decreased the amount of solid waste going to the landfill by an average of 20 tons per month.

You - the residents of Clinton, have been doing an awesome job! Keep up the good work!

If you have any suggestions on how to make this program even better, don't hesitate to contact the Solid Waste Department. We'd love to hear your ideas.

CITY ORDINANCES

Street Sweeping and Pothole repair are currently on-going. We will be starting work in the Right-of-Way's, which include: spraying, ditch mowing and maintenance. **Please use caution and slow down when approaching street crews in the roadway!**

Please be aware – it is against City Ordinance to blow cut grass into the roadway and gutter. Yard debris clogs up storm drains and can contribute to sewer backups. Also – if you have a storm drain / catch basin in front of your house, please keep it clear, to ensure all runoff drains properly.

§ 97.003 PLACING DEBRIS ON

It is unlawful for any person to throw or deposit on any street or alley any glass, glass bottle, nails, tacks, wire, cans, trash, garbage, rubbish, litter, offal, leaves, grass or any other debris likely to be washed into the storm sewer and clog the storm sewer, or any substance likely to injure any person, animal or vehicle.

(Iowa Code § 321.369) (1999 Code, § 135.03) Penalty, see § 10.99

City Ordinance Regarding Tree Responsibility

§ 98.06 DUTY TO TRIM TREES

The owner or agent of the abutting property shall keep the trees in or overhanging the street trimmed so that all branches will be at least 13 feet above the surface of the street and nine feet above the sidewalks. If the abutting property owner fails to trim the trees, the city may serve notice on the abutting property owner requiring that such action be taken within five days. If such action is not taken within that time, the city may perform the required action and assess the costs against the abutting property for collection in the same manner as a property tax. Except as allowed in this section, it is unlawful for any person to trim or cut any tree in a street or public place without first obtaining authorization from the city. The Building and Neighborhood Services Official or his or her designee shall have the power to enforce this section.

Please be aware that tarps and/or covers are required by City Ordinance on any and all waste being transported to the Clinton County Solid Waste Agency (aka the Landfill).

§ 50.27 LOADING

Vehicles or containers used for the collection and transportation of any solid waste shall be **loaded** and moved in a manner that the contents will not fall, leak or spill therefrom, and shall be covered to prevent blowing or loss of material. Where spillage does occur, the material shall be picked up immediately by the collector or transporter and returned to the vehicle or container and the area properly cleaned.

City Ordinance Regarding Grass Height For Property Owners

****The purpose of this chapter is to require owners of residential property to cut their grass, weeds, vines and brush when it exceeds eight inches in height.**

§ 94.05 NOTICE TO OWNERS; ONCE PER CALENDAR YEAR

(A) For the first violation of this chapter in each calendar year on a parcel of property, the Inspector shall notify the property owner by certified U.S. mail, return receipt requested, that a condition that violates the terms of this chapter exists and shall notify the property owner of the actions that must be performed to correct the condition and the notice shall state that the condition shall be corrected within five days from the date that the notice is received or returned to the city unclaimed.

(B) For subsequent violations on the same parcel of property owned by the same person in the same calendar year a written notice will not be sent. For subsequent violations, the Inspector shall verify the violation exists and that the parcel of property is still owned by the same person to whom the first notice was sent. If a subsequent violation exists, the Inspector shall order the work done by city employees or by a contractor.

(C) The Public Works Director shall publish in the local newspaper prior to June 1 of each year a notice advising the public that city ordinance requires the cutting of grasses, weeds, vines and brush exceeding eight inches in height and notice of violation will be mailed only once a year for each property. Subsequent violations will not receive a written notice.

Severe Weather Preparedness

- Listen to local area radio, NOAA radio or TV stations for the latest information and updates.
- Watch for tornado danger signs: dark, often greenish clouds — a phenomenon caused by hail; a wall cloud — an isolated lowering of the base of a thunderstorm; or a cloud of debris.
- Move or secure any of the items on your list of items to bring inside or anything else that can be picked up by the wind.
- Bring your companion animals indoors and maintain direct control of them.
- Go to a safe place in your home where household members and pets will gather: a basement, storm cellar or an interior room on the lowest floor with no windows.
- In a high-rise building, pick a hallway in the center of the building. You may not have enough time to go to the lowest floor.
- In a mobile home, choose a safe place in a nearby sturdy building. If your mobile home park has a designated shelter, make it your safe place. No mobile home, however it is configured,

is safe in a tornado. If you have access to a sturdy shelter or a vehicle, go there immediately, using your seat belt if driving.

- If you are driving, stay away from bridge/highway overpasses.
- If strong winds and flying debris occur while driving, pull over and park, keeping your seat belt on and engine running. Put your head down below the windows, covering your head with your hands and a blanket.
- After a tornado, let friends and family know you are safe.
- If evacuated from your home, return only when authorities say it is safe to do so.
- Listen to local news or a weather radio.
- Check for injuries. If you are trained, provide first aid to people in need until first responders arrive.
- And we would like to add: Be ready.
- Assemble an emergency kit now. Practice where you would shelter during a storm now. Talk with your family about how you would contact each other, or where to meet, in the event of a storm.

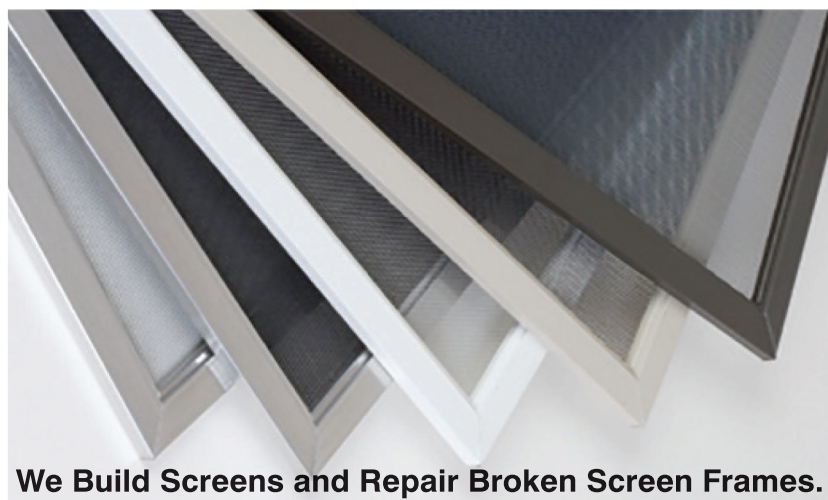

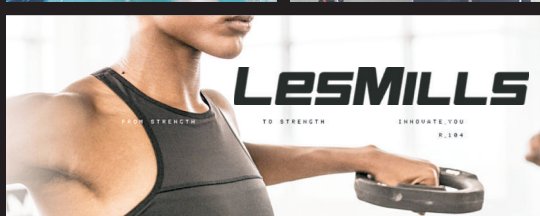
