Marijuana Remains Illegal in Iowa

Clinton residents will see no change to the marijuana (THC) laws in Iowa. The use and possession of marijuana remains illegal in our state. The recent change to Illinois law allows Illinoisans to possess 30 grams, or about an ounce, of (cannabis flower) marijuana. There are also limits for cannabis concentrate and cannabis-infused products, such as edibles. Marijuana in Illinois can only be consumed in a private residence, or a cannabis-related business. Marijuana cannot be consumed in public. Non-residents of Illinois may possess 15 grams of marijuana while within the State of Illinois.

The impaired driving law in Iowa has also not changed. There is no tolerance for THC in the blood, or urine while driving in Iowa. Any controlled substance present in a person is illegal while driving. Iowa law stipulates whether the driver shows impairment or not. The mere presence of marijuana in a driver's system is illegal. Research shows marijuana (THC) can stay in your system for three to 30 days depending on use and your body's metabolism. Recreational use of marijuana in Illinois could feasibly lead to a driving under the influence charge in Iowa several days to weeks later.

The Clinton Police Department continues their vigilance in the detection, arrest and prosecution of all drug crimes within our city. This department recognizes the legalization of recreational marijuana in Illinois may lead to an increase in possession of marijuana in Clinton. Our department is ready with tools in place to combat any increase in drug-related incidents. The Clinton Police Department narcotics task force officers have partnered with Illinois to uphold the law; our narcotic detection K9 is trained, our dedicated patrol officers and targeted enforcement teams are ready to make Clinton a safe community.

Crime Free Housing Program

In early 2019, the Clinton Police Department, along with Building and Neighborhood Services, began working to develop a Crime Free Housing Program. The goal of the project was to keep illegal activity from occurring in rental properties within the city. After considerable research and training from other Crime Free Housing Programs throughout the country, it was decided there would be three phases of training for landlords or property managers. The landlord or property manager will need to complete each of the phases in order to join this voluntary program. Phase 1 – is classroom training for

landlords, property managers, and maintenance personnel. This training consists of applicant screening, background checks, rental applications and fair housing standards. Phase 2 – is on-site evaluations of Crime Preventions Through Environmental Design (C.P.T.E.D.) concepts. In this phase there will be detailed security assessment of the rental property. Officers assess lighting, landscaping, structure fortification, and parking, just to name a few. Phase 3 – is tenant training on recognizing criminal activity and how to report such activity. Once all phases of training are

completed, the property is then recognized as a Crime Free Housing Property and given signs to recognize the accomplishment. The Clinton Police Department will continue to be a resource for property owners or landlords as they focus on maintaining the program goal. Snow/Ice

Snow and ice must be removed from the sidewalks of residential properties within 48 hours after a snow or ice event. If the sidewalks are not cleared within the required timeframe, the City may remove the snow or ice from the sidewalks and assess the cost to the property owner. Business districts need to remove snow and ice within 12 hours after a snow or ice event. Please do not clear snow or ice from sidewalks or driveways into the traveled portion of streets or alleys.

Signs and More Signs

Any type of sign, including "For Sale" signs, advertising for a rummage sale or bazar, and political signs, are not allowed in the rights-of-way. This is the area between the curb and the sidewalk. Please ensure that all signs are placed on your property, in front of your house. If you are on a corner lot, please ensure that you are not obstructing the view of traffic at the corners.

Garbage, Recycling and Yard Waste Totes

Just a friendly reminder to remove your City totes from the curb, alley or area of which it is placed for dumping. This ensures with the winter winds that they will not be blown into the roadway or sidewalk and become an obstruction. Carts may be put out 12 hours before the collection date and can remain 12 hours after the collection date.

Large Item Collection

The City of Clinton no longer provides Large Item Collection. For persons needing to dispose of large items, the items may be taken directly to the Clinton County Area Solid Waste Agency located at: 4292 220th St. – Clinton, IA 52732. 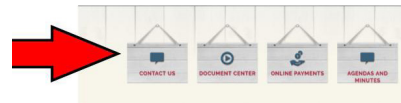
Sharps Disposal

Iowa’s “Move Over” Law

On July 1, 2018, the State of Iowa updated the “Move Over” law, which requires motorists to change lanes or slow down when approaching any motor vehicle continuously displaying emergency or hazard lights. The law was updated to protect motorists and professionals from being struck by passing motorists while conducting their duties or stranded on the side of the road. There have been several individuals who have died or have been severely injured due to being struck by a vehicle. According to The Officer Down Memorial Page statistics, in 2018, six officers were killed after being struck by a vehicle as opposed to 2019 where 14 officers were killed. In May 2018, an officer of the Clinton Police Department was struck by a motorist while inside his squad car assisting another officer on a traffic stop. Fortunately, the officer sustained minor injuries; however, the squad car was totaled.

The officers of the Clinton Police Department have been actively monitoring traffic to ensure the safety of our citizens

while on the side of the road. With the severe weather conditions, members of the Clinton Police Department would like to remind the citizens to move over and slow down when approaching any vehicle displaying emergency or hazard lights and to activate their hazard lights should they find themselves on the side of the road. An update of Iowa Code 321.323A can be found below:

321.323A Approaching Certain Stationary Vehicles

1. The operator of a motor vehicle approaching a stationary authorized emergency vehicle that is displaying flashing lights, as permitted under section 321.423, shall approach the authorized emergency vehicle with due caution and shall proceed in one of the following manners, absent any other direction by a peace officer.
- a. make a lane change into a lane not adjacent to the authorized emergency vehicle if possible, in the existing safety and traffic conditions.

- b. If a lane change, under paragraph “a”, would be impossible, prohibited by law, or unsafe, reduce the speed of the motor vehicle to a reasonable and proper speed for the existing road and traffic conditions, which speed shall be less than the posted speed limit, and be prepared to stop.

2. The operator of a motor vehicle approaching a stationary towing or recovery vehicle, a stationary utility maintenance vehicle, a stationary municipal maintenance vehicle, a stationary highway maintenance vehicle, a stationary construction vehicle, or a stationary solid waste or recycling collection service vehicle that is displaying flashing lights, as permitted under section 321.423, shall approach the vehicle with due caution and shall proceed in one of the following manners.

- a. make a lane change into a lane not adjacent to the authorized emergency vehicle if possible, in the existing safety and traffic conditions.
- b. If a lane change, under paragraph “a”, would be impossible, prohibited

by law, or unsafe, reduce the speed of the motor vehicle to a reasonable and proper speed for the existing road and traffic conditions, which speed shall be less than the posted speed limit, and be prepared to stop.

3. The operator of a motor vehicle approaching a stationary motor vehicle that is continually displaying its emergency signal lamps flashing simultaneously shall approach the vehicle with due caution and shall proceed in one of the following manners.

- a. Make a lane change into a lane not adjacent to the authorized emergency vehicle if possible, in the existing safety and traffic conditions.
- b. If a lane change, under paragraph “a”, would be impossible, prohibited by law, or unsafe, reduce the speed of the motor vehicle to a reasonable and proper speed for the existing road and traffic conditions, which speed shall be less than the posted speed limit, and be prepared to stop.

Applications for Citizen Police Academy XXV are now being accepted at the Clinton Police Department. The class begins February 7, 2020. The Clinton Police Department in partnership with Clinton Community College, Clinton National Bank and Honorable Retired Judge David Sivright are excited to celebrate our 25th class of the Citizen Police Academy. Over 400 citizens of Clinton and the surrounding area have attended and graduated from this 14-

week interactive course. Attendees to the Citizen Police Academy get to see what it is like to be a Special Response Team (SRT) member, process a crime scene, go on patrol, testify in court and see and do many other law enforcement related topics. Recent Changes in Iowa Law

Drunk Driving

Motorists in Iowa convicted of a third or subsequent drunk driving offense now can be sentenced as habitual offenders. The new law is in response to an Iowa Supreme Court ruling last year that rejected a lower court’s use of a habitual offender sentence in a case involving a third OWI offense. Under the previous law, a third operating-while-intoxicated offense would be subject to a five-year prison sentence, but the habitual offender statute allows someone convicted of a third offense OWI to be sentenced to up to 15 years.

Ban on Prison Drone Flights

People flying unauthorized drones over state prisons or county jails can be charged with a Class D felony, punishable by up to five years behind bars.

Safe-Haven Babies

Iowa’s safe-haven law will be expanded to leave an infant up to 30 days old at a hospital or health care facility without fear of prosecution for abandonment. The limit has been 14 days. New provisions also allow a person to call 911 to have police or other first responders pick up a baby. The infant will be taken to the nearest institutional

health facility.

Sexual Abuse - Statue of Limitations Increased

Iowa Code 802.2 to extend the length of time that victims of child sex abuse can file criminal charges by five years. Iowans now have 15 years after the date they turn 18 to do so, or until they turn 33.

Personal Degradation of Dependent Adult

Amends Section 235B.2(5) a) of Iowa Code by adding personal degradation as a form of dependent adult abuse by a caretaker regulated by the Department of Human Services (DHS). The Bill defines personal

degradation as a willful act or statement by a caretaker intended to shame, degrade, humiliate, or otherwise harm a dependent adult’s personal dignity, or a willful act or statement by a caretaker where the caretaker knew or reasonably should have known the act or statement would shame, degrade, humiliate, or otherwise harm the dependent adult’s personal dignity. This would include the taking, transmission, or display of an electronic image of a dependent adult by a caretaker. Dependent adult abuse by personal degradation as a serious misdemeanor

Technologies That Have Changed Law Enforcement

It really does not matter what industry you are associated with; technology has changed us all in the last few decades. Technology in law enforcement has changed the way Clinton Police Officers respond and investigate crimes. New technology brings us closer to the people we protect and allows officers to react quicker to crimes.

Social Media

No longer just reserved for individuals’ personal enjoyment, social media is now used by police and others in law enforcement to engage with our community, gain knowledge about cases and solicit crime-stopping tips. According to a 2010 International Association of Police Chiefs Center for Social

Media survey of law enforcement chief executives, 81% reported they use social media in their work. Of that number, nearly 67% said they use Facebook. Some of the most common activities on social media included:

- Investigating crimes
- Updating the public on crime
- Activities related to crime prevention
- Gaining crime tips from the public

Body Cameras and In-Car Video

The Clinton Police Department requires all officers to activate their Body Worn Cameras (BWC) when responding to a call or simply having contact with the public. This increases officer accountability as well as increasing officer safety. The use

of body worn cameras and in-car cameras has significantly changed the way the public views law enforcement.

Tablets and laptops

Back in the day, officers patrolling the streets of Clinton were notified of a call by a single light being lit in town, letting the officer know to call in to the radio room to get a call for service. The officer would respond and then jot down what he did during the night in a ledger book. Today officers are primarily dispatched through a laptop or tablet in their squads, which are linked to Dispatch. Clinton County Communications receives a call and inputs the call directly to the officer. Officers are alerted of an incoming call and can read the screen, which tells them

everything the Communications Operator has received from the initial caller. The officer responds to the call and can input notes to the call for service screen and generate an incident report if need be. He/she can do so right then and there. If the incident needs to be investigated, the officer or his/her supervisor can transfer the entire call to our Criminal Investigations Division (CID) prior to the end of shift. These mobile devices for police allow officers to work nearly anywhere and advance case investigations and other police work without the extra time required to return to the station and manually enter case notes. Today’s law enforcement changes daily and the new technology enables officers to respond to the needs of their communities very quickly.

Towed Vehicle Reclaim Procedure

Pursuant to resolution adopted by the Clinton City Council, there is a \$50.00 administrative fee that must be paid prior to the release of an impounded vehicle

In Order for an Impounded Vehicle to be Released

1. You must present a physical copy of a valid insurance card for the impounded vehicle.

2. You must appear at the Clinton Police Department between 9:00 a.m. and 4:00 p.m. (M-F), with valid insurance, valid driver’s license or identification, and \$50.00 (cash or debit/credit).

3. You must have paid the citation (ticket) at the Clerk of Courts Office, if the vehicle was impounded for failing to have insurance.

4. Vehicles may only be released to the registered owner.

5. Upon completion of above items, you will be provided with a release from the Clinton Police Department that you will take to the towing company. You will still be responsible to pay any towing or storage fees charged by the wrecker service.

CLINTON FIRE DEPARTMENT

Do you have smoke detectors?

This is question that should echo throughout the City of Clinton. Everyone whether a homeowner, contract buyer, or rental occupant should be asking this question. January 25, 2020 will be the 10-year anniversary of a Structure fire that took the life of 4 of our fellow citizens. This fire broke the hearts of our community and kicked off a campaign to place smoke detectors in every household in Clinton. The Clinton Fire Department, in conjunction with the Clinton Community School District, spearheaded by the Bluff Elementary School PTA, campaigned to raise funds to provide smoke detector coverage. This undertaking saw the installation of over 7,000 smoke detectors throughout the City of Clinton. This program is still in place today, and on average, the Fire Department installs several smoke detectors per week into area residences. One would think that in light of this tragic event and the huge install campaign, that every household surely has working detectors. This assumption is simply untrue. The Clinton Fire Department tracks smoke detector activations on all structure fires, and the Department does a fairly good job of checking all houses that it enters, to ensure that detectors are present and in working order. The Fire Department is finding that just 10 years after the tragedy, houses are once again insufficient with smoke detector coverage. This finding is disheartening, as it is the smoke detector that gives early warning of a fire, and provides us the crucial time needed to escape a structure that is burning. The Clinton Fire Department is preparing for a media blitz to re-educate our public on the importance of properly placed smoke detectors, and to once again provide them as part of our public safety awareness campaign. The Fire Department implores you to check your detectors regularly, replace the batteries during the spring and fall daylight savings, and to call your Fire Department for assistance if you are deficient. Smoke detector installation is required in all residential occupancies. All new construction, and/or new rental units must have hard wired interconnected detectors as follows:



1. Dual sensor (smoke/carbon monoxide) detector in the basement where fuel fired utilities are located.
2. In every sleeping room.
3. In the hallway outside (vicinity) of sleeping rooms. Dual Sensor (Smoke/Carbon Monoxide)
4. On every occupied floor.

All other existing residential occupancies and rental units prior to July 1, 2008 are as follows:

1. One smoke detector on each occupied level including the basement, with a detector located in the vicinity of the sleeping rooms.

It is a reminder that as of July 1, 2018 the State Fire Marshal has made it mandatory that every residential occupancy with gas fired appliances be required to have carbon monoxide detection installed as follows:

- a. In the immediate vicinity of every room used for sleeping purposes in each dwelling unit.
- b. In each bedroom where a fuel burning heater or furnace, fuel burning appliance, or fireplace is located within the bedroom or its attached bathroom.

c. In each sleeping unit, if the sleeping unit or its attached bathroom contains a fuel-burning appliance, fuel-burning heater or furnace, or fi replace.

d. In the immediate vicinity of each sleeping unit where the sleeping unit or its attached bathroom does not contain a fuel-burning appliance, fuel-burning heater, or fi replace and is not served by a forced-air furnace.

Code does provide some location exceptions:

a. There are no communicating openings between the fuel burning heater or furnace, fuel burning appliance, fireplace, or attached garage and a dwelling unit or sleeping unit.

b. There are no communicating openings between the fuel burning heater or furnace, fuel burning appliance or fireplace and a dwelling unit or sleeping unit and when a dwelling unit or sleeping unit is located more than one story above or below an attached garage

c. There are no communicating openings between the fuel burning heater or furnace, fuel burning appliance, or fireplace and a sleeping unit or dwelling unit and the attached garage connects to the building through an open-ended corridor.

d. A carbon monoxide alarm is located on the ceiling of the room containing the fuel burning heater, fuel burning appliance or fireplace, or in the first room or area between the fuel burning heater, fuel burning appliance or fireplace and the dwelling unit or sleeping unit.

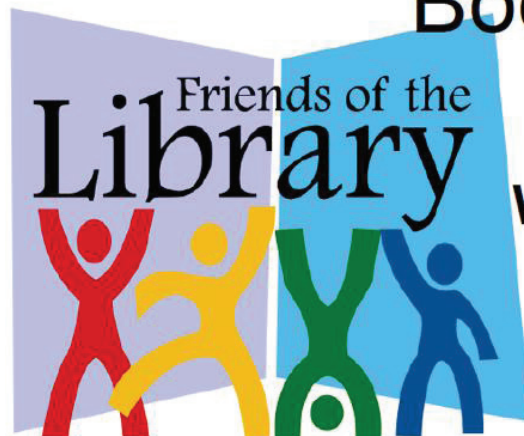

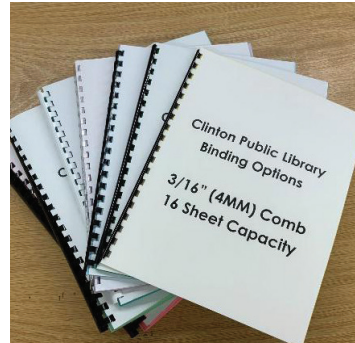

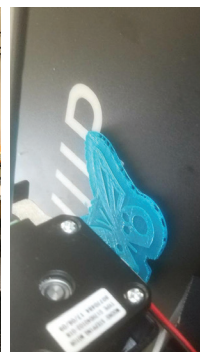

Wide Access Aisles Versus Narrow Access Aisles

The photo above shows a van-accessible space, which is next to a wide (eight foot) access aisle. The wheelchair user needs this much space, at a minimum, to safely lower the ramp and exit or enter the van.

In the photo below, the van is parked in a standard accessible spot next to a narrow (five foot) aisle. This does not allow enough space for the wheelchair user to safely exit and enter without possible damage to her wheelchair – or to the car parked nearby.



Access Aisles: Why They Exist

For many people with disabilities, access aisles serve a critical purpose. These yellow or blue striped aisles next to accessible (or handicapped) parking spaces provide extra room so wheelchair users or other people with disabilities can exit or enter their vehicles.

The access aisle provides room for people to:

- Lower their van's ramp or lift
- Navigate with wheelchairs, scooters, walkers, canes or unsteady gait

If this area is blocked even a small amount, a person with a disability who requires the extra space may not be able to get out of or into his/her vehicle.

Or, if a person with a disability returns to the vehicle and finds a car parked over the access aisle, the person may have to wait hours until the violator moves the illegally parked vehicle.



Access aisles are not intended for emergency parking, as shown in the violation above.

You can help by keeping the access aisles completely open.

Even if you only parked over the aisle a small amount, you could restrict a wheelchair user's ability to enter and exit a ramp- or lift-equipped vehicle.

It might seem like access aisles cover a large area, but people with disabilities need *all* of the space to deploy their ramps or lifts. The wide aisle provides room to safely maneuver on and off the ramp or lift.

So please stay within the lines and honor the aisles!

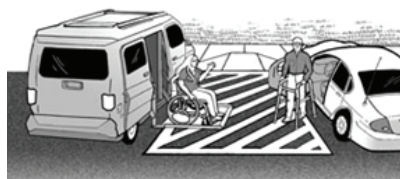

Accessible Parking Etiquette Honor the Aisles!

Accessible Parking Etiquette: Dos and Don'ts

Do display your accessible parking permit.

It is required by law that you display your accessible parking permit, including accessible parking placards or license plates, when you park. You may have a permit that legally entitles you to use the space, but if you don't display it, you could receive a ticket.

Do leave van accessible parking spaces open for ramp- or lift-equipped vehicles.

Van-accessible parking spaces have a wider access aisle than standard accessible spots. The **eight-foot wide aisle** provides enough space for a wheelchair user who has a ramp- or lift-equipped vehicle to lower the ramp or lift, and have room between vehicles to exit/enter the van.

A sign with the words "Van Accessible" and the international symbol of accessibility means the parking space is designed for ramp- or lift-equipped vehicles (RLEVs).

In contrast, access aisles next to regular accessible parking spaces are only **five feet wide**, which is not enough room for wheelchair users to safely exit or re-enter a van that has a lift or ramp. In addition, there are fewer van accessible parking spaces than regular accessible parking spaces in most parking lots.

Although you may park in van-accessible spaces with an accessible parking permit, you are encouraged to reserve van-accessible spaces for RLEV users unless there are no regular accessible parking spaces. Otherwise, RLEV users might not be able to find a parking space at all.

Do not use an accessible parking permit once it's expired.

Accessible parking permits have expiration dates. Please be mindful of the expiration date of your placard or license plate, and do not use it after it's expired. It's against the law.

If you still need to use it after expiration, apply for a new one or renew your permit.

Do not let others use your accessible parking permit when you are not present.

The owner of an accessible parking permit must be present when using the permit. Do not lend your permit to your family members or friends so that they can use the accessible parking spaces.

There can be legal consequences both to you and to the person who borrowed your permit, including a fine and your permit being revoked.

RLEV = Ramp- or lift-equipped vehicle

Parking here for "Just a Minute..." ...is 60 seconds too long!

NEVER park in a space reserved for people with disabilities **UNLESS** you have a permit, placard or handicapped parking plates. It's the courteous thing to do—and it's the law.

REMEMBER: Do not park in the striped access aisles next to spaces reserved for people with disabilities, even if you have a permit or plates. Access aisles provide room for wheelchair users to transfer safely to and from their vehicles.

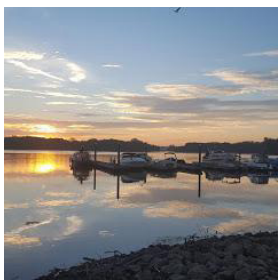

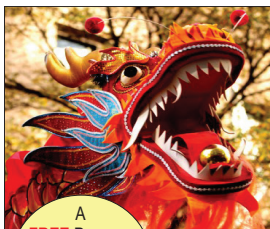

PERMITS & INSPECTIONS

Talk to the Permit Office / Building and Neighborhood Services

Some people fear that the moment you call the local building inspectors and permit office, you immediately are flagged. This simply isn't true. The permit office exists to ensure that home

and commercial improvements are done safely and pose no risk to occupants, and BNS inspectors and administrative support are happy to answer questions.

Do I need a Permit?

Generally speaking, you are allowed to replace most existing elements of your home without a permit, while anything that changes the structure of your home or represents a real estate improvement, will require a permit. You can replace a broken wall switch or worn-out faucet, for example, but adding a deck or room addition calls for a permit.

Roofs, siding, water heaters and furnaces all require permits and inspections. If you are in doubt, or have any questions, call BNS and ask. Many times if a permit and inspections aren't needed, BNS will issue a "No Fee" permit, which indicates you have spoken to us about your work scope, and it doesn't require permitting.

Property Owner & Building Permits... Not a Problem

Some property owners worry that BNS will not allow them to do their own work, and will only issue permits to professional contractors. This is not true since inspection offices routinely issue permits to property owners to do all kinds of work themselves—up to and including serving as a GC (general contractor) when building an entire house. As an owner/builder, you can act as your own general contractor instead of hiring one. This does allow you to save on construction costs, but you also carry the burden of potential liabilities, many of which can be serious. Hiring a licensed, insured, bonded contractor better insulates you from

these liabilities. Property owners are allowed to do minor work for commercial construction projects, but do require licensed contractors for specialized work. Homesteaded home owners are allowed to do most projects themselves, but are required to hire a licensed electrical contractor for any work associated with electric service / electric panel. Check with Building and Neighborhood Services to see what is required for your project.

Whether a licensed contractor, commercial property owner, or home owner, all projects are still required to meet building codes. Clinton currently works off the 2018 IRC, 2018 IRC and 2017 NEC.

Inspections Are Mandatory

The inspection is an integral part of the overall permit process, and under no circumstance should you or your contractor ignore this step. Most minor permits, like roofs, water heaters, furnaces, only require one inspection. With some projects, several inspections will be required. This is not something to fear since the inspector is there just to make sure the work has been done correctly. It is often a very brief, perfunctory visit. Inspectors may be a little more diligent about the inspection if the work has been done by a homeowner, as they are less familiar with current building codes, but it is still a very routine process.

Failing an inspection is not as big of a deal as you would think. Most inspectors will give you every opportunity to correct any problems that have flagged. Though inspectors don't prefer re-inspects, they will return as many times as needed to pass the work and close out the permit. The most important thing is that the project outcome is a safe structure.

If you have had a water heater or furnace installed on your property, and there is not an "APPROVED" sticker from our office on the appliance, call to set up an inspection. 563.244.3360. The cost of the inspection is included in the permit fee.

Not Getting a Building Permit Can Be Costly

It can be very tempting to ignore the permit process and to hide the work you are doing, especially if it is inside the home where you can work without anyone seeing it. If it comes to light that you have done work without a required permit, you could be forced to apply for a permit after the fact, at a greatly increased cost. And you might even have to tear out walls or ceilings in order for the work to be inspected.

If you made any mistakes, though unlikely, you could be forced to demolish the entire job and start over. Your homeowner's insurance coverage can also be affected. For example, should you have a flood or fire due to poor plumbing or electrical work, your insurance policy has a case for denying coverage if the work was done off-permit.

ZONING

Property Setbacks. Every property has them.

Setbacks are mandated buffers between property borders and permanent structures that help maintain a feeling of openness in communities, as well as providing for safety margins in the event of fires. For example, if you are extending the side of your home, you will need to be aware of your local building code's required setback distances. There will likely be setback rules for extending a property to the front and back of a house, as well.

Usually, this involves maintaining a minimum distance between the edge of structures and the surveyed property boundaries. Setbacks provide continuity to a neighborhood, and also helps with fire distance buffer. Structural home additions, garages, sheds, fences, and decks can all be subject to these setback rules. Again, Building and Neighborhood Service office can let you know what setback regulations are in effect.

Variances Are Possible

While easements are rarely waived, exception to setback and some other zoning requirements are sometimes allowed through the legal process of applying for and receiving a variance. A variance is an officially-approved exception to zoning ordinances. Most commonly, variances are requested when a homeowner wishes to build a larger house on his or her lot than is allowed by zoning ordinances. By requesting a variance, the homeowner may

be allowed to build that larger home, or to complete a room addition that violates setback regulations. Property owners must show a hardship that the ordinance puts on them and why they should be allowed to have an exception. They are required to notify all neighbors of the public hearing date and time, when a variance is requested, and their approval may be key to obtaining the variance. Clinton Urban Revitalization Program

Do you plan to make improvements to your home, build an addition, or build a new home? Did you know the City of Clinton's Urban Revitalization Program ("CURP") offers tax incentives for doing so?

The City of Clinton has a City-wide residential CURP incentive. 100% of the first \$75,000 of qualified increased value can be abated for a period of five years. For example, if a new residential single-family home was constructed on a bare lot and \$100,000 of qualifying value was added, \$75,000 of the added value would not be subject to taxation for five years.

For residential homes in blighted areas of the City, 100% of all qualifying value added can be abated for a period of five years. Multi-residential properties similarly can have 100% of all qualifying value added abated for a period of five years.

Qualified Improvements mean the improvements must increase the actual (assessed) value of the property by at least 10% if the property is assessed as commercial, multi-residential, or industrial; or by at least 5% if the property is assessed as residential.

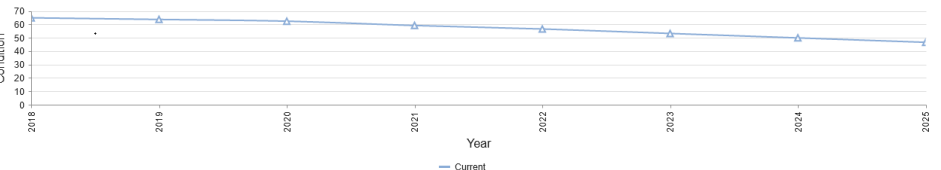
Pavement Management Program Update 2020-2021

The City of Clinton is responsible for the maintenance of 145 miles of streets. Of these streets, 14 are aggregate roadways maintained by the County under the authority of a 28E agreement. The rest of these streets are a broad range of 126 miles of concrete, asphalt, chip seal, and 5 miles of aggregate roadways some of which have never been improved. This leaves approximately 126 miles of streets for the City to maintain as part of the pavement management program.

Over the past several years, the City of Clinton Engineering Department has been using DTIMS asset management software to track citywide pavement condition index (City PCI). This information has been used to prioritize the street rehabilitation schedule and budget for street construction from 2013 to 2022. The plan includes budgetary cost estimates based on expected quantities, known ADA accessibility issues, and contingency factors. To the right is a chart of actual changes in the Citywide Pavement Condition Index from 2007 to 2017.

We can use DTIMS to predict future road network deterioration based on pavement condition history and construction records. We are slowly making progress towards our goal PCI of 65, and hope to get there within the next few years.

The engineering department's recommendation is to allocate \$3.3 million of funding for 2020, in order to reconstruct or resurface the worst remaining streets in town, most of these being asphalt streets with a PCI of less than 30.



In 2021, we plan to focus on the remainder of asphalt streets that have not been rehabbed over the last 20 years, along with collector street resurfacing, and concrete patching on the very worst of the concrete streets in town. We currently project this expenditure at or near \$2.6 million.

Beginning in 2022, the City we would then be able to focus on a yearly resurfacing, patching, and maintenance plan, with the goal of maintaining streets rather than repairing them. The recommendation is likely to land somewhere between \$2.5 and \$2.7 million in order to maintain a City PCI of 65 into the future.

The need for consistent funding from 2022 on is evident. The next chart displays what would be the result of a "Do Nothing" approach to street paving beginning this year. Obviously, our PCI would deteriorate, and in 5-6 years we would be back to pre-2007 levels. Once we receive the 2019 pavement condition data in March, we will project our budget scenarios into the five-year plan and come up with exact recommendations for 2022-2026.

Note 1: The data points for 2018 and 2019 are "projected only". We will obtain the 2019 PCI data from Iowa DOT in March of 2020.

Note 2: Manufacturing Drive & Bluff Blvd have been

removed from the network listing, as those streets are scheduled for complete reconstruction beginning in 2022, which will be funded outside of the Pavement Management Program budget.

2020 Engineering Projects

In addition to the Pavement Management Program projects, the following projects will be under construction in early spring.

North 12th Street & North 13th Street Resurfacing – This project includes resurfacing of 12th Street from 4th Ave N to 13th Ave N and N 13th Street from 4th Ave N to N 12th Street. Most of the preparation work was completed last year, but unfortunately the asphalt was delayed until 2020. This will be the first project tackled by Determann Asphalt, with a revised completion date of May 15, 2020. This project is long overdue.

10th Avenue Pumping Station Replacement – This project includes full replacement of a sanitary lift station at 10th Ave N & Galbraith Drive. The existing station was undersized and obsolete, which resulted in basement backups during heavy rains. This project will double the size of the lift station and include all new pumps, which will add resiliency to the system. The one block section of 10th Avenue North, between North 12th Street & Galbraith Drive, will also be reconstructed as part of this project. Legacy Construction of East Moline will likely begin this project over the winter.

27th Avenue North sewer Separation – This project includes full reconstruction of 27th Avenue North between 3rd Street and 4th Street, along with all new storm sewers replacing the old com-

bined sewers. This project is the last remaining separation project north of the courthouse. This project has been awarded to BWC Excavating, who will begin early spring.

Breezy Point Reconstruction – This long overdue project includes the total reconstruction of Breezy Point Drive between North 4th Street & Oakhurst Drive. This project has been awarded to Eastern Iowa Excavating, who plans to be onsite early spring.

Cleveland Street – This includes reconstruction of Cleveland Street from 29th Ave N to 31st Ave N, and this project is a hold-over from 2019 as well. This project will occur in early May.

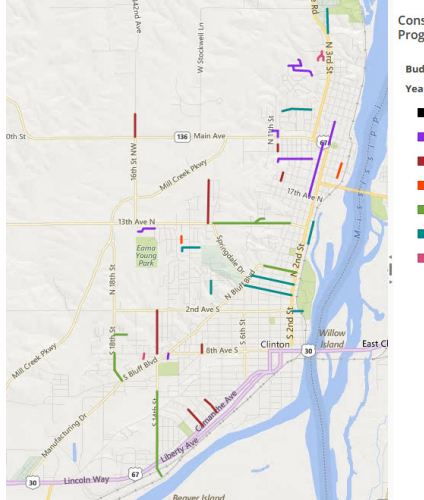
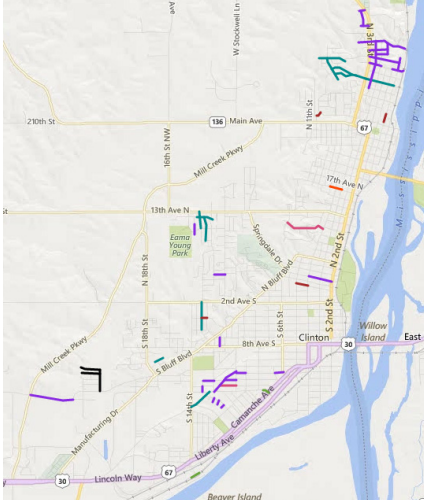
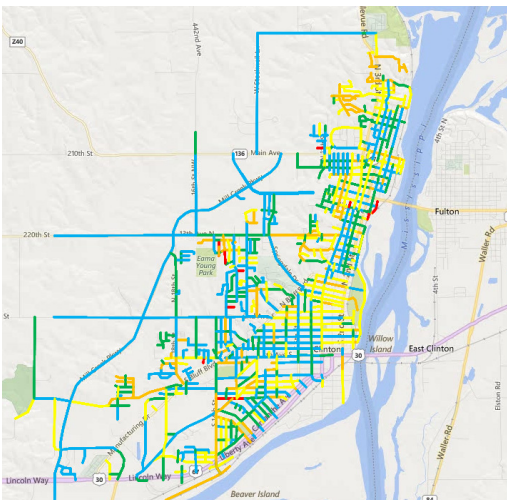
North Discovery Trail Resurfacing – This project will be out for bid very shortly after the new year. The project design is complete for the project, which includes resurfacing of the entire trail from the 30th Ave N boat ramp to Eagle Point Park. Also included as part of this project is the reconstruction and realignment of the intersection of McKinley Street & 36th Avenue North.

South 7th Street sewer Separation – This project includes all new storm sewer on South 7th Street and nearby alleys between 3rd Avenue South and 8th Avenue South. The new storm sewer will provide relief for basement backups in the area. Once pipe work is done, streets in the neighborhood will be patched and

resurfaced as necessary.

Lumberkings & Riverview Pool Parking Lots – This project involves reconstruction of both parking lots using permeable pavers and infiltration ditches with tree plantings to control storm water runoff and flooding at each location. The remainder of the parking lots will be reconstructed with new asphalt at the same time. The majority of this project is funded through an Iowa DNR grant of \$800,000.

North 3rd Street Traffic Safety Improvements Project – This project involves conversion of North 3rd Street from a four-lane roadway to a three-lane roadway from 17th Avenue North to 25th Avenue North. The project also includes reconstruction of the intersection of Main Avenue & North 3rd Street, which involves new concrete street pavement with widened radii and smoother travel lanes, reconstructed sidewalks, ADA accessibility, and all new traffic signalization equipment. The intersection of 17th Avenue North & North 3rd Street will also be fully reconstructed as part of this project. Other project items include storm sewer construction, construction of ADA curb ramps, micro-surfacing of the entire length of North 3rd Street, and application of pavement markings throughout. The goal of this project is to reduce traffic accidents by up to 40% along the corridor.

Don't forget to register your pets for calendar year 2020!!

The City's fee for pet registrations has not changed. It is still \$10 per animal and is good for the calendar year running January 2020 – December 2020. The license form can be found on the City's website at www.cityofclintoniowa.us under the Finance Department > Forms.

5 Reasons to Get Your Animal Licensed

Being a pet owner requires all sorts of responsibility. One that is often overlooked is registering your pet with your city government and getting him licensed. The American Humane Association indicates that 62% U.S. households own a pet. Another national average indicates that only 16% of pets are estimated to be licensed in the United States. Failing to license your pet can hinder your chances of getting him back if picked up by the pound, and can get you in trouble with the law.

If the above isn't reason enough for you to properly register your pets, here are a few more reasons why you should:

1. It is the law. In most states, it's mandatory that pet owners have their animals licensed. If you get caught without a license, which can and does happen, you will be hit with a hefty fine.

2. If your pet goes missing, having him licensed drastically improves your chances of getting him back. A license tag helps animal control and shelters quickly identify your pet and get him back to you safely. If your pet is found wandering the streets, a rescue organization can easily look up your pet via its license identifying number. Animals that

are licensed tend to be kept at the shelter longer than unlicensed animals.

3. The cost of the license is far less than the penalty for being caught without one. If a city official finds your pet without a license, you shall be guilty of a simple misdemeanor and, upon conviction, be subject to a fine of not more than \$500 or imprisonment not to exceed 30 days.

4. Licensing lets people know that your pet is up to date on its rabies vaccinations. An animal cannot be licensed unless it is properly vaccinated. Animal control or a Good Samaritan will be much more likely to want to handle and care for your missing pup if they know that it is healthy and sans rabies.

5. License fees support the efforts of many local animal shelters. If you purchase your pet license at the Humane Society, half of the annual fee that you pay to license your pet goes to the shelter to help keep the shelter running.

Where to get your pet licensed

You may visit City Hall; you may purchase at the Humane Society; you may purchase from Midwest Pets for Life at their portable spay/neuter clinics; or you may apply for a license by mail.

What is required to get a license?

- In order to apply for an animal license, you must provide a certificate showing that your pet is up to date with its rabies vaccinations.
- Animals over four months and older must be licensed.

Restaurant Reminder

Early last spring the City passed an ordinance requiring restaurants to install grease interceptors no later than June 30, 2020. At that time letters were sent out to all known Food Service Establishments to notify them of the change. The City also offered an incentive at the time to pay 50% of the installation cost up to \$1500. Ten Food Service Establishments took advantage of the program.

Some restaurants have already been inspected this year and notified in person of the upcoming change. The intent of this ordinance is to keep as much oil & grease out of the sewers to avoid sewer blockages and to reduce the maintenance costs which will help in keeping the sewer rates down.

A lot of restaurants believe if they do not use a deep fryer that they do not have a grease issue. The truth of the matter is most of the Fats, Oil, and Grease come from doing dishes. There are "Best Management Practices" that can be implemented to reduce the amount of FOG going into your interceptor that will reduce the amount of times it will need to be emptied.

§ 52.038 INSTALLATION AND MAINTENANCE REQUIREMENTS.

(A) Installations.

(1) All establishments subject to this chapter shall have a grease interceptor installed and in fully operational condition no later than June 30, 2020. Any establishment that demonstrates timely compliance with this section shall be entitled to a one-time rebate of 50% of the total cost of installation of the grease interceptor, with the maximum rebate payment not to exceed \$1,500. This rebate would only be available to businesses that have installed a compliant grease interceptor between July 1, 2018 and June 30, 2019. No rebates issued pursuant to this section shall be approved or issued for grease interceptors installed after June 30, 2019. However, if an establishment begins installation of a compliant interceptor before June 30, 2019, a rebate shall be approved if the installation of such interceptor is completed within 30 days of commencement of installation, even if such installation is not complete until after June 30, 2019.

(2) New facilities. Food processing or food service facilities which are newly proposed or constructed, or existing facilities which will be expanded or renovated to include a food service facility, where such facility did not previously exist, shall be required to design, install, operate and maintain a grease interceptor in accordance with locally adopted plumbing codes or other applicable ordinances. Grease interceptors

shall be installed and inspected prior to issuance of a certificate of occupancy.

(3) Existing facilities. Existing grease interceptors must be operated and maintained in accordance with the manufacturer's recommendations and in accordance with these Model Standards, unless specified in writing and approved by the POTW.

(4) All grease interceptor waste shall be properly disposed of at a facility in accordance with federal, state, or local regulation.

(B) Cleaning and maintenance.

(1) Grease interceptors shall be maintained in an efficient operating condition at all times.

(2) Each grease interceptor when cleaned shall be fully evacuated.

(b) Name, signature, address, and phone number of the person who generated the waste and the date collected;

(c) Type and amount(s) of waste collected or transported;

(d) Name and signature(s) of responsible person(s) collecting, transporting, and depositing the waste;

(e) Date and place where the waste was deposited;

(f) Identification (permit or site registration number, location, and operator) of the facility where the waste was deposited;

(g) Name and signature of facility on-site representative acknowledging receipt of the waste and the amount of waste received.

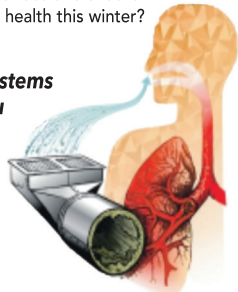

STREETS AND SOLID WASTE DEPARTMENT

Street And Solid Waste Department

The City of Clinton Streets Department has several responsibilities within the city's right-of-ways. Some of these responsibilities include: pothole repairs; putting up and replacing street signage; street sweeping; snow & ice removal on city streets; alley grading; right-of-way mowing and weed spraying; and removing fallen trees, branches, and debris within the roadway.

The City of Clinton Solid Waste Department is responsible for the collection of the city-owned garbage, yard waste

and recycling carts. The Solid Waste Department is also responsible for taking the orders for delivery and cancellation of the city-owned carts.

The Streets and Solid Waste Department strive to maintain the safety and health of our community in all our endeavors.

As a reminder when driving around town, we ask that you please use caution and slow down when approaching street crews in the roadway! Thank you!

Dumping of Snow

§ 97.010 DUMPING OF SNOW ORDINANCE

It is unlawful for any person to throw, push or place or cause to be thrown, pushed or placed, any ice or snow from private property, sidewalks or driveways onto the traveled way of a street or alley so as to obstruct gutters, or impede the passage of vehicles upon the street or alley or to create a hazardous condition therein; except where, in the cleaning of large commercial drives in the business district it is absolutely necessary to move the snow onto the street or alley temporarily, the accumulation shall be removed promptly by the property owner or agent. Arrangements for the prompt removal of the accumulations shall be made prior to moving the snow.

Iowa Code § 364.12(2) (1999 Code, § 135.10) Penalty, see § 10.99

Calendar Parking

§ 79.10 CALENDAR PARKING ORDINANCE

(A) *General provisions.* Calendar parking shall be activated with the occurrence of a snow event, which is defined as the accumulation of one inch (1") or more of snow upon the public right-of-way.

(B) (1) During the period from November 15 through March 15, when a snow event has occurred, parking is restricted in the public right-of-way to alternate sides of the roadway in the following manner:

(a) On odd-numbered days, vehicles shall only be parked, stopped or left standing on that side of the roadway having odd-numbered addresses.

(b) On even-numbered days, vehicles shall only be parked, stopped or left standing on that side of the roadway having even-numbered addresses.

(2) A snow event will remain in effect

for 24 hours after the snow has stopped.

(3) The hours for calendar parking will be from 9:00 a.m. to 6:00 a.m. Vehicles will have three hours to be moved to the correct side of the roadway.

(4) The date at 6:00 a.m. shall determine if the day is odd or even.

(5) During a snow emergency, calendar parking shall be in effect except on designated snow routes where no parking will be permitted until the snow emergency has been cancelled.

(6) This section shall not apply to commercial districts where parking is designated on both sides of the street. (1999 Code, § 69.10) (Ord. 2233, passed 3-27-2001; Ord. 2259, passed 9-24-2002; Ord. 2468, passed 1-10-2012; Ord. 2510, passed 8-12-2014; Ord. 2527, passed 10-13-2015) Penalty, see § 79.99

Snow Emergencies

When weather predictions call for a snowfall of 4 inches or more, or a comparable weather event, the City will declare a Snow Emergency. The City shall notify news and media outlets of the declared Snow Emergency along with the rules for parking and its duration. Parking rules during a Snow Emergency are usually as follows:

*"On posted Emergency Snow Routes, **please** remove all vehicles, if possible, by (a notified*

time). *The Clinton Police Department will enforce the ticket and/or towing process. If vehicles are not removed, crews may only be able to clear a single path and possibly not be able to return to clear any more snow.*

Please be aware that all Emergency Snow routes will be cleared first before crews begin to clear residential areas. Calendar Parking will be in effect."

Placing Debris on Street or Alley

§ 97.003 Placing Debris on Street or Alley It is unlawful for any person to throw or deposit on any street or alley any glass, glass bottle, nails, tacks, wire, cans, trash, garbage, rubbish, litter, offal, leaves, grass or any other debris likely to be washed into

the storm sewer and clog the storm sewer, or any substance likely to injure any person, animal or vehicle.

(Iowa Code § 321.369) (1999 Code, § 135.03) Penalty, see § 10.99

City Ordinance Regarding Tree Responsibility

§ 98.06 DUTY TO TRIM TREES

The owner or agent of the abutting property shall keep the trees in or overhanging the street trimmed so that all branches will be at least 13 feet above the surface of the street and nine feet above the sidewalks. If the abutting property owner fails to trim the trees, the city may serve notice on the abutting property owner requiring that such action be taken within five days. If such action is not taken within that time, the city may perform the required action and assess

the costs against the abutting property for collection in the same manner as a property tax. Except as allowed in this section, it is unlawful for any person to trim or cut any tree in a street or public place without first obtaining authorization from the city. The Building and Neighborhood Services Official or his or her designee shall have the power to enforce this section.

Residential Street Light Outages

Many people are not aware the majority of the street light outages in residential neighborhoods are **not** the responsibility of the City of Clinton. The City of Clinton is only responsible for the lighting and poles in the business corridors throughout town as well as the traffic signals. Street lights located in the residential areas of town are the responsibility of Alliant Energy. For any problems concerning residential street lights Alliant Energy prefers to be contacted by the homeowners directly.

Yard Waste Collections Resume On Monday, April 6, 2020

Solid Waste Department Policy on Yard Collection

The Solid Waste Department has set the following start and end times for yard waste collections for each upcoming calendar year as:

Start: 1st week of April*
End: Last week of November* or with the first significant snowfall or prolonged temperatures below freezing
*As always, these dates are subject to the weather.

Tarping Loads to the Landfill

Please be aware that tarps and/or covers are required by City Ordinance on any and all waste being transported to the Clinton County Solid Waste Agency (aka the Landfill).

§ 50.27 LOADING ORDINANCE

Vehicles or containers used for the collection and transportation of any solid waste shall be **loaded** and moved in a manner that the contents will not fall, leak or spill therefrom, and shall be covered to prevent blowing or loss of material. Where spillage does occur, the material shall be picked up immediately by the collector or transporter and returned to the vehicle or container and the area properly cleaned.

(1999 Code, § 106.03) (Iowa Code §§ 321.460 and 805.8A(13)(c))

Upcoming Garbage, Yard Waste and Recycling Delays:

PRESIDENT'S DAY – MONDAY, FEBRUARY 17TH

There will be NO collection delays this week. Routes will be collected as normal.

EASTER – SUNDAY, APRIL 12TH (including Good Friday, Friday, April 10th)

There will be NO collection delays the week before or the week after Easter. Routes will be collected as normal.

MEMORIAL DAY – MONDAY, MAY 25TH

Monday, May 25th – NO garbage/yard waste/recycling collections. Collections will be delayed by one day for the rest of the week.

Monday's Routes – Will be collected on Tuesday, May 26th.
Tuesday's Routes – Will be collected on Wednesday, May 27th.
Wednesday's Routes – Will be collected on Thursday, May 28th.
Thursday's Routes – Will be collected on Friday, May 29th.
Friday's Routes – Will be collected on Saturday, May 30th.

Solid Waste Collection Program

CART INFORMATION

- All City of Clinton collection carts are the property of the City.
- The City has 3 types of collection carts: Grey – garbage, Green – yard waste, and Blue – recycling.
- Collection carts are assigned to an address, not an individual (family). When ownership of a residence changes, each cart must stay at the address it is assigned to. Residents may cancel services at any time and all appropriate carts will be removed.
- Each resident is responsible for the proper care and security of the collection carts. The resident will be charged for replacing a cart should it become damaged or stolen as the result of improper care and/or not keeping the cart secured on the property.

COLLECTION INFORMATION

- All carts must be out by 7:00 am the day of collection.
- Garbage should be bagged in the grey cart.
- Yard waste should be placed loose in the green cart (no bags).
- Recycling should be placed loose in the blue cart (no bags).
- Carts will not be emptied if there is improper or incorrect material in the cart (such as garbage in a yard waste or recycling cart).
- Hot ashes should never be placed in the carts.
- Construction debris is not allowed in any of the carts.
- Toxic or hazardous waste is not allowed in any of the carts. This includes: electronics, pesticides, paint cans with paint, motor oils, sharps containers, flammable material, etc. (Contact the Clinton County Landfill at 563-243-4749 for any questions about acceptable material.)
- The maximum weight limit of the 95-gallon carts is 200 lbs.
- To avoid exceeding the weight limitation of the cart or causing possible damage to the cart or collection vehicle, do not place rocks, concrete, bricks or dirt inside carts. Any items placed within the cart must fall out easily when the cart is being serviced. Please do not overfill or tightly pack items into the cart.
- Lids must be closed.
- Give adequate space between carts for collection by the automated trucks – 3 feet apart is optimal.
- Carts must be placed for collection away from homes, garages, fences, parked vehicles, utility poles, mailboxes, etc.
- Carts should not be placed higher than 1 foot above the surface that the collection truck is on.
- Carts should not be left at their collection spots past the collection day. Carts should be removed from the street or alley right-of-way and placed in a designated storage area on the resident's property. (This will prevent a possible road hazard, damage to the cart, or theft of the cart.

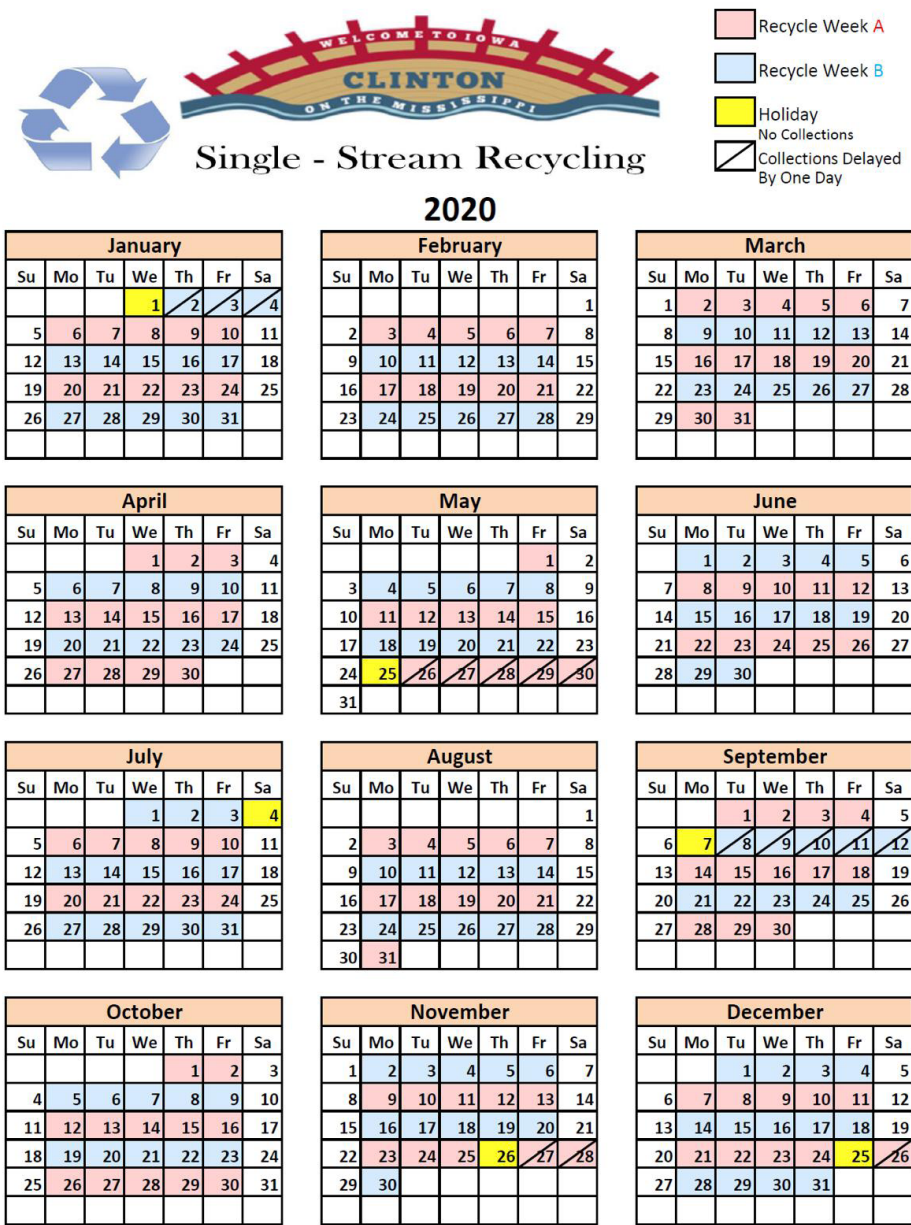
