PROPOSED RECONSTRUCTION OF MANUFACTURING DRIVE & BLUFF BOULEVARD IN CLINTON, IOWA

The City of Clinton will hold a public hearing for the Environmental Assessment (EA) document, which has been prepared by the City of Clinton in accordance with the National Environmental Policy Act (NEPA). The purpose of the EA is to analyze the potential environmental impacts associated with construction of the Drive to Prosperity: Manufacturing Drive and Bluff Boulevard Reconstruction Project, from US Route 30 to 7th Avenue North & North 4th Street, Clinton County, Iowa, Project # HDP-1415(634)-71-23. The EA analyzes the proposed project's potential to affect the following resource areas: Air Quality, Noise Environment, Cultural Resources, Natural Resources, Water Resources, Hazardous Materials and Waste, Land Use, Infrastructure/Utilities, Earth Resources, Socioeconomics, Environmental Justice, Safety and Occupational Health, and other resource areas as appropriate.

The City of Clinton is seeking public comment on the proposed project in the NEPA process to identify any concerns regarding the project's potential impacts. The City of Clinton has coordinated with the Iowa Department of Transportation, the Federal Highway Administration, the United States Corps of Engineers, the Iowa Department of Natural Resources, the Iowa State Historic Preservation Office, and other governmental agencies for their input on the Proposed Action. The EA has been made available for public review and comment. The EA will be available for public review and comment from January 18th to February 16th at the following locations:


